On Tuesday May 09, 2023, at approximately 8:23pm Squad 4440, (P.O BAUMANN and I while in full duty uniform and equipped with AXON body worn cameras,) was dispatched to 5909 W Good Hope Dr. for an Abandoned/Stolen-property complaint.

Prior to arriving on scene, officers contacted the caller, later identified, as Thelia STATON (B/F 08-10-1973.) STATON stated that her son, at approximately 4:30pm, lost his wallet at the gas station before heading to work. STATON stated that her son returned to the business, upon realizing he did not have the wallet and spoke to the gas station attendant later identified as Gagan SING (UN/M 06/08/2023) to see if his wallet had been turned in. SING stated he had not observed the wallet and told STATON's son to look near the candy. STATON stated that her son wanted to see the camera footage to see who might have taken the wallet. SING stated that he could not let STATON's son view the camera footage unless the police were involved. STATON then contacted the non-emergency line to request the aid of police and to send officers to the scene.

Officers while on scene spoke with STATON and then entered the gas station to review the camera footage. While on scene officers spoke with SING and asked to review the camera footage from the time provided by STATON. SING initially stated to officers that he could not review the camera footage and that he needed permission to allow officers to review the camera footage. SING contacted the owner later identified as Qasim F, AJANI (NA/ M 03-18-1965,) via phone to get permission to review the camera footage. Officers while talking on the phone with AJANI were able to get into the booth and try to review the camera footage for the gas station. Officers were unable to review the footage due to the cameras playback feature not operating properly. Both AJANI and SING cooperated fully with the police.

Officer confirmed that the business license is active with a license date of 4-09-2024. There are four licenses for: Cigarette and Tobacco, Filling station, Food dealer retail, and Weight and measures.

On Friday, December 29th, 2023 at 4:00 PM., I received a walk-in, lost property reported by Jovonte M. Chamberlain (M/B 03-06-96) that occurred at Clark's gas station located at 5909 W. Good Hope Rd in the City and County of Milwaukee.

It should be noted that I, Officer REED was in full duty Milwaukee Police Department-issued uniform equipped with an AXON bodyworn camera ACTIVATED during my investigation.

Interview with the victim

Station and purchased a Black and Mild. Chamberlain stated that he placed his Black, iPhone 12 valued at \$500 USD on the counter when he took his wallet out of his pocket. Chamberlain stated that when he exited the store and went into his car, he realized he had left his phone on the counter. Chamberlain searched his vehicle, the parking lot, and the aisles of the gas station and was unable to locate his phone. Chamberlain stated that when he went back inside to speak to the clerks, they were unhelpful and unwilling to look at possible camera footage.

Chamberlain then went into District 4 to report the incident. Chamberlain stated that he did not observe any suspicious person(s) in Clark's, nor did he suspect anyone in particular of depriving him of his cell phone.

Squad 4240, PO SAROSH, and PO BURRIS were dispatched to the listed location. Officers observed the video surveillance which did not capture the alleged event.

NATURE OF CALL/JUSTIFICATION

On Saturday, February 17, 2024 at approximately 9:43 pm, I was dispatched to 5909 W Good Hope Rd for a Trouble with Subject complaint. This address is to the Clark gas station and is in both the city and county of Milwaukee, WI. The caller of this complaint stated that he wanted a subject escorted off the property who was at the business for over an hour and refused to leave on his own. The caller gave a description of the subject as a black male wearing a black jacket with black pants.

INVESTIGATION

Upon my arrival in my fully marked MPD squad car, I observed a black male subject matching the description given in the complaint in the parking lot near a gas pump. As I turned into the gas station lot the subject immediately left the premises and ran southbound on N 60th St. By the time I was able to turn my squad car around the subject was unable to be located. I then spoke to the caller inside of the business who stated that the subject entered the gas station and purchased a bottle of water. The subject then asked to use the restroom in which he remained inside of it for a hour despite being asked numerous times to leave the store. The subject finally exited the restroom and stood outside the main entrance door bothering patrons as they entered and exited the business. The caller stated that the subject did not make any threats nor caused any damages while inside the business. I informed the caller that the subject left on his own when he saw the police on scene and for the caller to contact police if the subject returned causing issues.

Please make such requests no later than one business day prior to the start of the meeting. You are not required to attend the hearing, but please see the information below if you would like to provide testimony. Once the Licenses Committee makes its recommendation, this recommendation is forwarded to the full Common Council for approval at its next regularly scheduled hearing.

Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:

- 1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.
- 2. You must appear in person and testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)
- 3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are present at the committee hearing and willing to testify).
- 4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
- 5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)

- 6. You may then provide testimony.
- a. Include only information relating to the above license application.
- b. Include only information you have personally witnessed or seen.
- c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
- d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
- 7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
- 8. Business Competition is not a valid basis for denial or non-renewal of a license.

Please Note: If you have submitted an objection to the above application your objection cannot be considered by the committee unless you personally testify at the hearing.
