This is to notify you that on Tuesday, March 26, 2024, the City's Licenses Committee voted to recommend to the City's Common Council to deny the Class B Tavern and Food Dealer License Applications for the premises located at 4323 N 60th St., based upon the preponderance of the evidence on the police report, neighborhood testimony and fitness of the location.

On Tuesday, April 9, 2024, the Common Council considered the Committee's recommendation regarding your application. On that date, the Common Council adopted the Committee's recommendation and denied the Class B Tavern and Food Dealer licenses for the premises located at 4323 N 60th St., based upon the preponderance of the evidence on the police report, neighborhood testimony and fitness of the location.

This is to notify you that on Tuesday, April 9, 2024, the City's Licenses Committee voted to recommend to the City's Common Council to revoke the Disabled Loading Zone permit upon the preponderance of the evidence of the licensee and neighborhood testimony that demonstrates that the licensee does not reside at the premises where the permit was granted (3536 N 93rd St.).

On March 29, 2024, you were mailed a true and correct copy of the findings of fact, conclusions of law, and recommendations of the Licenses Committee with respect to the Disabled Loading Zone permit in which the Committee recommended the revocation of the Disabled Loading Zone permit upon the preponderance of the evidence of the licensee and neighborhood testimony that demonstrates that the licensee does not reside at the premises where the permit was granted. You were further notified that the Milwaukee Common Council would consider the matter at its meeting of Tuesday, April 9, 2024 commencing at 9:00 a.m. in the Common Council Chambers on the third floor of City Hall, 200 East Wells Street, Milwaukee, Wisconsin. You were advised of the right to file written objections and to appear personally or by counsel to address the Common Council. At that date, time, and place, you did not file written objections to the report of the Licenses Committee, you did not appear in person and you were not represented by a counsel.

Following consideration of the report of the Licenses Committee, the Common Council voted revocation of the Disabled Loading Zone permit upon the preponderance of the evidence of the licensee and neighborhood testimony that demonstrates that the licensee does not reside at the premises where the permit was granted.

Said revocation is in effect April 9, 2024.
