## Narrative (1)

### LICENSED PREMISE REPORT

This report was written by P.O. Mario DANTZLER, assigned to District 7, Early Power Shift, Squad 7243.

On Sunday, February 26, 2023, at 12:46 p.m. (while in full duty uniform equipped with axon body worn camera and in a marked squad car), my partner, P.O. Jazmine WILLIAMS and I, were dispatched to 5507 W. Hampton Ave. (Divine Hands Auto Sales) for a Subject with Weapon complaint. This address is located in the City and County of Milwaukee, WI.

Upon arrival, I spoke to one of the callers identified as Cleophus ANDERSON (B/M, 8/4/68, 414-233-7549, 3536 N. 16th Street). ANDERSON informed me that he is the owner of Divine Hands Auto Sales. ANDERSON informed squad that on today's date, his firearm (9mm Beretta, 92FS-Cal, Serial# BER191267) was taken from his left pants pocket during an incident involving Titiana RICHMOND (B/F, 4/4/96, 414-914-1645, 2463 N. 50th Street). ANDERSON informed me that the firearm belonged to his daughter, identified as Kenbri COX (B/F, 1/16/92, 414-651-5783, 3536 N. 16th Street). The firearm was returned while squads were on scene, however ANDERSON did inform squad that he is a Felon, after informing squad that the firearm was taken out of his left pants pocket. After entering subject's information in Etime, record request results confirmed that subject, identified as Cleophus ANDERSON is a Felon (Case#2001CF003420).

### Interview of ANDERSON

I interviewed ANDERSON. ANDERSON informed squad that on today's date he received a phone call from a female caller inquiring about a vehicle (Gray, 2012 Dodge Journey, VIN 3C4PDCBGXCT368627). ANDERSON informed the caller that she could come by his car lot to take a look at the vehicle (prior to him going to church, which is located across the street from the car lot). ANDERSON informed squad that when female subject arrived, he recognized her as the female that accused him of selling her a bad car two days ago. The female subject was Titiana S. RICHMOND (B/F, 4/4/96, 414-914-1645, 2463 N. 50th Street). ANDERSON informed squad that he sold RICHMOND the Dodge Journey two days ago, and that she put \$3000 down on the vehicle. She still owed ANDERSON \$2000 on the vehicle, but returned the vehicle to the car lot yesterday because she believed something was wrong with it. ANDERSON then posted that the vehicle was for sale after RICHMOND returned the vehicle, which is what prompted RICHMOND to return to the car lot today around 11:00 a.m. When she returned to the car lot, she was upset and had multiple subjects with her. According to ANDERSON, the subjects tried to enter his building on the car lot. He informed squad that he then took the firearm out of the gun case and put it in his left pant pocket. ANDERSON informed squad that subjects came into his building and one of the subjects snatched the firearm out of his left pocket and ran.

I interviewed RICHMOND's mother (Latoya M. RICHMOND, (B/F, 7/10/81). L. RICHMOND informed me that her son (Femaj YARBER, B/M, 6/12/07) snatched the firearm out of ANDERSON's pocket and ran, due to him believing that ANDERSON was going to try to shoot her with it. It was later discovered that he had given the firearm to his friend, identified as Emmanuel ARMSTRONG (B/M, 1/1/08, 414-803-6035, 2836 N. Wells) The subject later returned to the scene and returned the firearm while squad was on scene. The firearm was recovered by Squad 7253 (P.O. OSSANNA and P.O. RODENKIRCH). The firearm Inventory number is 23006647. A gun report and a receipt for the firearm was created.

## Video Footage

Squad observed surveillance camera footage. The footage portrays multiple subjects surrounding ANDERSON at approximately 12:53 p.m. The footage shows a hooded subject walk behind ANDERSON and snatch, what appears to be a black firearm from ANDERSON's left pants pocket. The subject then passes the firearm to another individual. The video footage was downloaded onto the axon system.

P.O. Samphanh LUANGPHAXAYACHACK performed CST duties.

ANDERSON was transported to District 7 for booking and processing.

During the booking process, P.O. DANTZLER performed a Buccal Swab on ANDERSON. ANDERSON provided his consent.

2. You must appear in person and testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)
3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are present at the committee hearing and willing to testify).
4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)
6. You may then provide testimony.
  - a. Include only information relating to the above license application.
  - b. Include only information you have personally witnessed or seen.
  - c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
  - d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
8. Business Competition is not a valid basis for denial or non-renewal of a license.
