This report is written by Police Officer Xavier Benitez, assigned to the License Investigation Unit, Days.

The Milwaukee Police Department's investigation regarding this application revealed the following:

1. On 04/05/23 at 8:47pm, Milwaukee Police were dispatched to 3381 N. 35<sup>th</sup> St, for a welfare check. Officers arrived and observed a subject who appeared to be intoxicated and refused to identify them self. The agent spoke with officer and stated that the subject knocked over items and he wanted her removed from the location. Officers conveyed the subject off the property.
2. On 04/24/23 at 4:58pm, Milwaukee Police were dispatched to 3381 N. 35<sup>th</sup> St, for a threat complaint. Officers spoke with the employee who stated that a customer threatened to harm him. The employee was cooperative with police and provided video.
3. On 04/26/23 at 11:49am, Milwaukee Police were dispatched to 3381 N. 35<sup>th</sup>, for a theft complaint. Officers spoke with the employee who stated that a subject took items without paying for them. The employee was cooperative with the investigation and showed officers video of the incident.
4. On 04/29/23 at 2:03am, Milwaukee Police were dispatched to District 7, for a shooting complaint. The victim sustained one gunshot wound to the leg. The victim spoke with officers stating the incident occurred at 3381 N. 35<sup>th</sup> St. At the location officers located the shooting scene, with multiple casings recovered outside the business location. The business was

cooperative providing video of the incident. The video footage showed the incident in its entirety as well as suspect and vehicle descriptions.

5. On 05/25/23 at 10:54pm, Milwaukee Police were dispatched to 3381 N. 35<sup>th</sup> St, for an armed robbery complaint. Officers spoke with the caller, who stated that he was robbed at gun point, and his back pack with items was taken. The caller stated that an unknown suspect asked if he wanted a ride to the gas station, the caller accepted. The suspect took the caller to the gas station, and gave him money to purchase items from the gas station, leaving his back pack in the vehicle. The caller was refused service returned to the vehicle where the suspect pointed his gun to his chest demanding his property. The investigating officer found the caller's story to be inconsistent and spoke with the employee of the gas station. The employee provided video and video confirmed the suspect did not point a hand gun and left when the caller exited the vehicle with the back pack. The officers filed a report for the back pack taken.
6. On 06/05/23 Milwaukee Police were dispatched to 3381 N. 35<sup>th</sup> St, for a battery complaint. The caller stated that she was at the location and saw a group kids and wanted to prayer for them. The security guard came over and told the caller to leave the kids alone. The security guard then push the caller on the ground and told her to leave. Officers arrived at the location and reviewed video regarding the complaint. Officers observed the caller continuing to exit her vehicle and yell at security refusing to leave. Also observed was the security guard pushing the caller back in her vehicle telling her to leave. The video did not corroborate the caller's allegations.
7. On 06/14/23 at 6:40am, Milwaukee Police were dispatched to 3381 N. 35<sup>th</sup> St, for shooting complaint. Officers arrived and located the victim in the business who had a gunshot wound, and was unconscious. Milwaukee Fire Department arrived and conveyed the victim to Froedtert Hospital for treatment. One casing was recovered outside the location. The business was cooperative and provided video of the incident in its entirety. The video footage showed the victim approached by two suspects and one of the suspect's takes the victim's phone from the victim. The victim struggled with the suspect over the phone and the other suspect discharged a gunshot striking the victim.
8. On 06/19/23 Milwaukee Police respond to Froedtert Hospital for a battery cutting complaint. Officers spoke with the victim who stated that he fought with a known subject outside the location of 3381 N. 35<sup>th</sup> St. during the fight he got stabbed by some scissors. Officers responded to the address of 3381 N. 35<sup>th</sup> St, and spoke with the employee who was unaware of the incident. The employee was cooperative with the investigation providing officers access to the video surveillance. Officers could not locate a scene or evidence of the battery cutting at the location.
9. On 06/22/23 at 12:02 am, Milwaukee Police were dispatched to 3381 N. 35<sup>th</sup> St, for a shot spotter complaint. Officers arrived and were notified that the person who shot gun fire fled already. Officers did not observe any victims of gun fire and located numerous casings on the parking lot of the business. Officers spoke with business who provided video of the incident in its entirety. The video provided the suspect, and suspect description wanted for the shots fired in the area.
10. On 08/19/23 at 4:43am, Milwaukee Police were dispatched to 3381 N. 35<sup>th</sup> St for a shots fired complaint. Officers arrived and spoke with the employee who stated that a ground of younger subjects were outside the location and an altercation occurred. On the subjects then fired on gun shot during the altercation. The business was cooperative with the investigation and provide video of the incident. The video shows a subject purchasing an items armed with a

hand gun at his side. Then 3 younger suspects approached behind the subject and attempted to get the handgun. All parties spilled outside the location and the handgun was discharged by the subject. The 3 suspects fled on foot from the location and the subject left the location on a bicycle. No calls were made to police from the subject who discharged the handgun.

11. On 09/08/23 at 12:50pm, Milwaukee Police were dispatched to 3381 N. 35<sup>th</sup> St for a trouble with subject. Officers spoke with the employee who stated that a subject was outside the location pan handling. The subject left prior to police arrival.
12. On 12/18/23 at 7:47am, Milwaukee Police were dispatched to 3381 N. 35<sup>th</sup> St for a trouble with subject. Officers arrived to the location and spoke with the employee who wanted a subject to leave the location but she refused. Officers spoke with the subject who refused to leave, and was uncooperative. The subject was taken into custody, cited and released form District 7.
13. On 01/0/324, at 5:35am, Milwaukee Police were dispatched to 3381 N. 35<sup>th</sup> St for a fight complaint. Officers arrived and spoke with a subject standing outside who appeared to be intoxicated. The subject stated that a subject tried stealing from him, inside the store. Officers then spoke with the employee who stated that the subject outside and another subject no longer on scene fought in the store. Officers reviewed video provide by the employee. Officers then further attempted to speak with the subject outside, who did not want any police services.
14. On 01/29/24 at 5:44am, Milwaukee Police were dispatched to 3381 N. 35<sup>th</sup> St for a violation of restraining order. Officers spoke with the employee who stated that a known subject he has restarting order against struck in him in the face. The subject fled the area, and officers observed the subject but were unable to apprehend the subject. Officers reviewed the video of the incident and filed reports regarding the violation.

On Thursday, May 25th, 2023, at approximately 10:54 PM I (SQUAD 7250) was dispatched to 3381 N 35th St, regarding an armed robbery complaint.

Upon arrival I made contact with the possible victim and caller, **Antonio D. WALKER (B/M 11-08-2005)**, who stated he got off of the city bus, which stopped at W Burleigh St and W Fond Du Lac Av, then walked to the gas station, 3381 N 35th St. WALKER stated while he was walking a gray old Buick sedan pulled up next to him, driven by Subject 1 (S1), and offered him a ride to the gas station across the street.

WALKER stated he got into the front passenger seat and put his black Adidas backpack with red lettering on the floor in front of the front passenger seat. WALKER stated S1 drove him across the street and asked him to go into the gas station to buy him some blunts. WALKER stated S1 gave him a few dollars. WALKER stated he forgot his backpack in the car and went into the gas station to get the blunts but was refused service because he was underage. WALKER stated he then came back out to WALKER, who pointed a gun at his chest and told him to give him everything. I asked WALKER why S1 said that when all of his stuff was in his backpack and still in the car. WALKER stated S1 must have been confused. WALKER stated he then went back into the store and asked the clerk what he should do while S1 drove away.

We made contact with the owner of the Kool Petroleum Citgo gas station, **Kulwant DHILLON (W/M 10-06-1961)**, who allowed us to view surveillance footage. Footage showed S1 drove off after WALKER got out of the vehicle the first time. The windows to S1's vehicle were clear and did not show S1 pointing a gun at WALKER.

WALKER stated he is missing his backpack which contained his government-issued smartphone as well as \$100 in US currency (1 \$10, 4 \$20, 1 \$5, and 5 \$1 bills). I advised WALKER that his story was inconsistent with the video surveillance footage and while I would write him a lost property report I would not be writing an armed robbery report. WALKER stated this was ok.

I provided WALKER with this case number and my community contact card.

The owner of the gas station, DHILLON, was cooperative and greatly aided my investigation.

Subject had a GSW to the left side of his torso upper back area. The subject was unconscious with a very weak pulse. CPR was performed on scene by officers until MFD took over.

Upon arrival on scene, we were immediately notified that we had gotten there too late and that the person who had shot fled. I did not notice anyone in the area to be injured by gunfire or anything to be struck by gunfire.

I then went to view the cameras in the gas station when I observed numerous spent casings approximately 15-20 feet south of the front business door in the parking lot. PO MOORE then stood by with these casings while I viewed the video surveillance.

## Video observations:

The time on the video was approximately one minute faster than the real time. I later downloaded video from cameras 1, 9, and 10 from approximately 00:00:00-00:05:00.

00:00:08- suspect vehicle arrives

00:01:57- suspect exits out of the front passenger seat

00:02:01- suspect shoots a firearm into the air

00:02:32- suspect vehicle flees southbound on N. 35th St

## Suspect vehicle:

The suspect vehicle was a black or gray 2007 Volkswagen Passat station wagon bearing WI auto ATU-7048 VIN WVWVU73C77E002317 that lists to Daron L. MAY (M/B, 11-20-1989). The license plate of this vehicle is clearly depicted on the video from the gas station.

## Suspect description:

The shooter was observed to be male, black, 25-35 years of age, medium complexion, approximately 6'00"-6'02", thin build, long dreadlock hair with the side of his head shaved, small chin beard, black t-shirt with a red and green design, black Milwaukee Bucks athletic shorts, black shoes, white socks, and armed with a semi-automatic handgun with what appeared to be an extended magazine.

Store worker was able to show me surveillance footage of the incident and I observed the following,

On 08/19/2023, at approximately 4:40 AM while at 3381 N. 35th St. footage shows an unknown B/M 20-30 YOA, wearing a black shirt, black hat w/ yellow logo, black pants and gray shoes trying to buy something from the gas station. Unknown subject then approached the security guard working at the gas station and it seems as if he asks for cash in exchange for a cash app transaction. Unknown subject proceeds to receive the cash from the security guard and goes back into the gas station. Unknown subject is then seen trying to buy something at the front counter. As the subject is trying to purchase items from gas station 4-5 younger B/M's enter the gas station and stand behind the unknown subject, but three of the younger subjects actually are involved in the incident.

The younger subjects are described as follows,

S#1 - 13 - 18 years old, B/M green army bape zip up hoodie, dreads, blue jeans, blue nike shoes

S#2 - 13 - 18 years old, B/M beige hoodie, black jeans, gray yeezy 350 shoes with black stripe, armed with a black semi auto firearm.

S#3 - 13 - 18 years old, B/M Black hoodie, dark gray sweatpants, black shoes.

S#3 while standing behind the unknown subject attempts to grab something from the right side of his hip which was later determined to be a pink firearm. As S#3 tries to grab the unknown subject's firearm, S#1 helps S#3, and they corner him in the middle of the store. S#2 is then seen displaying a black firearm and walks up to S#1 and S#3 to try and help, but the unknown subject is able to get his firearm out. S#1 is then seen backing up towards the entrance and S#3 also retreats and exits the gas station. Unknown subject in in the gas station with only S#1 and pushes S#1 on the ground and points his firearm at him. Unknown subject then walks outside looking for the other two subjects and sees S#2 running westbound on W. Townsend St. Unknown subject discharges his firearm once towards the S#2 and then got on a bicycle and left southbound on N. 35th St. All of the younger subjects are seen on video fleeing westbound on W. Townsend St. together.

Jacob HENSLEY and I, were dispatched to the address of 3381 N 35th St, regarding a violation of restraining order, which is located in the City and County of Milwaukee, WI.

The CAD (Computer Aided Dispatch) indicated the caller stated the subject, who he has a restraining order against just struck him in the face. The caller then stated the suspect was described as a B/M, known the caller as "Deante," last seen wearing a brown suit. The caller then stated the subject is still outside of the location. A CAD number was auto generated (CAD#24-029-0241).

### Initial Observations and Scene Description:

Upon our arrival, I saw a subject matching the description the caller indicated in the CAD. In addition, I had previous dealings with the subject and confirmed the subject to be **Dante D THOMAS (B/M, 04-22-90)**, after seeing THOMAS the caller, who was identified as **LAKHWINDER P SINGH (W/M, 07-30-94)**, then exited the business and stated "thats him." I attempted to speak with THOMAS, but he fled on foot Westbound on W Townsend Av, I was unable to locate THOMAS in the near vicinity.

SINGH was cooperative and allowed us to view footage and take pictures of the business up to date license. See initial report for interview of SINGH.

### Camera Surveillance:

After viewing the cameras it showed THOMAS entered the gas station at approximately 5:33 AM, and then attempt to enter the business at approximately 5:40 AM. You then see SINGH talk to THOMAS through the glass, which SINGH stated was him telling THOMAS to leave the location "a lot of times." The cameras then showed SINGH leave from behind the counter, enter the front of the store with a crowbar in his hand, and threaten THOMAS to leave. It should be noted that SINGH stated he grabbed the weapon because he has had bad interactions with THOMAS in the past. The cameras then captured SINGH and THOMAS argue for a few minutes before THOMAS exiting the gas station. THOMAS then continued to stand outside of the business until our arrival.
