Proper review by the public directly affected is not only necessary for prevention of displacement in

marginalized communities, but legally, and historically these processes must not be allowed to continue under the guise of equity. Every neighborhood in Milwaukee County with Black residents was given the worst rating in the 1930's and crucial decisions were made based on the gathering this data, without the implementing of solutions or relief for the betterment of the homeowners, imagine the impact on unhoused individuals today if those with most say, have none. The 1968 Fair Housing Act outlawed racially motivated redlining and tasked federal financial regulators, including the Federal Reserve, with enforcement.

Processes that require the enforcement or the development or redevelopment of a plan utilizing public funds, must definitely abide by equitable practices from the start, moving forward without approval from dedicated stakeholders such as organizations and residents would be unethical and defeat the purpose of the plan proposed unless the plan is meant to mainly benefit developers interested in the land and homes we already lack as they capitalize on properties with multiple units.
