Partnership applicants must appear by a partner listed on the application or by an attorney. If you wish to do so and at your own expense, you may be accompanied by an attorney of your choosing to represent you at this hearing.

You will be given an opportunity to speak on behalf of the application and to respond and challenge any charges or reasons given for the denial. No petitions can be accepted by the committee, unless the people who signed the petition are present at the committee hearing and willing to testify. You may present witnesses under oath and you may also confront and cross-examine opposing witnesses under oath. If you have difficulty with the English language, you should bring an interpreter with you, at your expense, so that you can answer questions and participate in your hearing.

This report is written by Police Officer Carlos Felix, assigned to the License Investigation Unit, Days.

The Milwaukee Police Department's investigation regarding this application revealed the following:

1. On 09/16/19 the applicant was charged with 3 counts of Possess with Intent THC (>10,000g) (Felonies); 2 counts of Maintain Drug Trafficking (Felony); Misappropriate ID (Felony) Info in Kenosha County.

Charge 1-3: Possess with Intent THC

4&29: Maintain Drug Trafficking Place

5: Misappropriate ID

2. Item number 1 was updated with Finding, Sentence, and Date.

3. On 10/31/2022, at 12:08pm, officers conducted follow-up at 140 S. 1st Street, Prestige Collective regarding a shooting investigation. The business was identified as a property where a music video was filmed at after hours. Officers reported the city licenses were not posted nor did the employee on scene have any knowledge of them. Security footage for the time frame of the shooting could not be

checked, due to the employee not having knowledge of where the surveillance system was housed. Officers were informed the only means of contact the employee had with management was through Snapchat. While at the property officers observed the smell of burnt marijuana. Behind a counter 5-6 bottles of Tequila were stored with 3 prior opened bottles. Officers asked about parties hosted at the business, and the employee stated it was not done during store hours. The applicant called officers at a later time. It was confirmed a rapper from Detroit and crew were in the business 10 hours earlier around 2:45A.M., filming a video. The applicant also confirmed the bottles of alcohol observed by officers, were for him and others that stay at the property after business hours to drink (Case 223040074).

- 4. On 12/14/2022, at 12:56pm, officers conducted follow-up at 140 S. 1st Street, Prestige Collective regarding a double shooting investigation. Upon arrival the business doors were locked, and an employee observed sleeping on a couch allowed officers entry. The applicant was not on scene and the employee refused to check or allow officers to check for a surveillance system. It was reported the two shooting victims met with the applicant at the business before the incident occurred, at a stop light a few blocks away (Case 223470127).
- 5. On 12/19/ 2022, at 1:22pm, officers and conducted follow-up at 140 S. 1st Street, Prestige Collective regarding the previously reported double shooting investigation. The employee on scene was not cooperative with officers. That employee was in contact with the applicant by text. An officer observed a message from the applicant advising the employee to stop speaking to police. Officers were not able to confirm or obtain any video from the property due to the applicant delaying the investigation. A computer and tablet were recovered as possible evidence (Case 223530090).
- 6. On 10/08/2024, an email was sent to the Department of Correction requesting the applicant's probation status, start and end date be sent to the Milwaukee License Division.

INITIAL INVESTIGATION

Emmons, Jordan 018992

This report was typed by P.O. Jordan EMMONS, assigned to District One, Day Shift.

On Monday, October 31st, 2022, at 12:08PM, while assigned to squad 1164, I responded to 140 S. 1st St. (Prestige Collective) for a License/Premise check. I was accompanied by squad 1168 PO James FILSINGER. I was equipped with a body worn camera and it was activated at the time of this investigation.

This visit was prompted after a Shooting had occurred on Monday, October 31st, 2022, at 556 N. Plankinton Ave (on street), at approximately 1:45AM. The victim of this Shooting, identified as ROGERS, London M. (B/M 03/02/1999) told investigators he was in the area of N. 76th St. and W. Florist at a Lounge called LUSH for a Halloween Party and Music Video shoot for an artist named "G" or "Gio". Once the director was finished filming a portion of the music video at LUSH, the next scene was at Prestige Collective (140 S. 1st St.). ROGERS stated the person who believed was the owner of Prestige Collective identified as "Bo" handed him a stack of money for the music video. ROGERS stated the money was to be used as a prop while he was an extra in the music video. ROGERS had \$7,988.50 total US Currency on his person during the Shooting investigation and stated he did not know how much money "Bo" gave him. (SEE IR#22-304-0011).

We met with the only employee on site, identified as RUIZ, Jamie M. (Hispanic W/M 12/11/2003). RUIZ's demeanor while speaking with him was nervous. RUIZ stated he has been an employee at the location for 2-3 months. I advised RUIZ we were there for a License/Premise check. I asked RUIZ to please see their City of Milwaukee issued Second Hand Dealer license and Weights & Measure license, as I did not see them anywhere displayed. RUIZ advised he did not know what we were talking about, or where these could be. I located at least two surveillance cameras inside the business, and asked if we could review the footage around the time of a Shooting downtown, 1:45AM. RUIZ stated he knew nothing about how this worked or where it was stored. RUIZ did not attempt to locate a Digital Video Recorder or their licenses for us to review.

RUIZ was asked if something were to happen at this location where he needed to get in contact with the owner of manager, how would he get in contact. RUIZ stated he was instructed to use the social media platform Snapchat (an application used to send and receive communication via video, photo, or text that is immediately deleted and unable to retrieve using any form of Legal Process) to contact Tyler, the License Agent. RUIZ denied having any other way to get a hold of anyone. RUIZ was asked to contact Tyler regarding our presence, and that we had some questions regarding our License/Premise check.

There was no answer while we were there. I reviewed my body cam regarding this incident, and noticed while we were speaking with RUIZ, I noticed RUIZ concealing Ozium air freshener spray bottles on the front counter, into a hooded sweatshirt also on the front counter.

Immediately walking into the business, we were both met with a strong smell of unburnt marijuana, although did not observe any in plain view. I asked if "Bo" was working, and RUIZ stated, "Bo is barely here.". While looking for where licenses may be displayed for the business, PO FILSINGER and I located approximately 5-6 large bottles of tequila behind the counter. 3 appeared to be opened and some of the liquid missing. There also was a cardboard box with Tito's alcoholic beverage advertising propped against the back wall. I asked if RUIZ knew of any parties occurring at this location, and he replied he did not, and he usually leaves a 7:00pm. I then brought up the tequila bottles behind the counter, and if they have any parties here. RUIZ stated they do not do anything during store hours.

Before leaving, we asked RUIZ if he could at least look around for where the Licenses may be stored. RUIZ replied that is something we will have to discuss with the License Agent Tyler about.

I left my business card with RUIZ.

On October 31st, 2022, at approximately 3:40PM, Tyler T HUFFHINES contacted me via phone, stating he received the business card I had left. HUFFHINES advised me that his best friend "Bo" found a post on Instagram from a Rap artist based in Detroit, MI. HUFFHINES stated the rap artist was named GMO Stax, and posted they were in the Milwaukee area looking to shoot a music video. HUFFHINES stated on 10/31/2022 at exactly 2:04AM, GMO Stax and his crew were inside the business shooting the music video. HUFFHINES stated they smelled like Marijuana, and that, he said explains the odor we smelled when we visited 10 hours later at 12:08PM when they opened. HUFFHINES stated they do used Ozium air freshener spray to try and get rid of the smell as customers normally come into the store smelling like marijuana as well. HUFFHINES stated he gave GMO Stax three pairs of shoes for shooting the music video at his store. HUFFHINES was asked to provide "Bo's" identity twice within our conversation, and only offered to share his name and phone number to my government email as he stated he was about to eat. I never received an email from HUFFHINES regarding.

I asked him about the alcohol bottles we located behind the front counter. HUFFHINES stated that him and others do drink after business hours at the location. HUFFHINES stated RUIZ did have HUFFHINES cell phone number but was probably scared at the time of us asking. HUFFHINES stated he did re-display the licenses inside the businesses, and they were currently down because the frames broke.

You are not required to attend the hearing, but please see the information below if you would like to provide testimony. Once the Licenses Committee makes its recommendation, this recommendation is forwarded to the full Common Council for approval at its next regularly scheduled hearing.

Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:

- 1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.
- 2. You must appear in person and testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)
- 3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are present at the committee hearing and willing to testify).
- 4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
- 5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)

- 6. You may then provide testimony.
- a. Include only information relating to the above license application.
- b. Include only information you have personally witnessed or seen.
- c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
- d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
- 7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
- 8. Business Competition is not a valid basis for denial or non-renewal of a license.
