Regarding: Your Class B Tavern and Public Entertainment Premises Licenses Renewal Application for "STEWART'S REST SPOT" at 1422 W ATKINSON Av. 

There is a possibility that your application may be denied for one or more of the following reasons: The recommendation of the committee regarding the application shall be based on evidence presented at the hearing. Per MCO 85-4-4, unless otherwise specified in the code, probative evidence concerning non-renewal, suspension or revocation may include evidence of the following: failure of the applicant to meet municipal qualifications, pending charges against or the conviction of any felony, misdemeanor, municipal offense or other offense, the circumstances of which substantially relate to the circumstances of the particular licensed or permitted activity, by the applicant or by any employee or other agent of the applicant. If the activities of the applicant involve a licensed premises, whether the premises tends to facilitate a public or private nuisance or has been the source of congregations of persons which have resulted in any of the following: disturbance of the peace; illegal drug activity; public drunkenness; drinking in public; harassment of passers-by; gambling; prostitution; sale of stolen goods; public urination; theft; assaults; battery; acts of vandalism including graffiti, excessive littering, loitering, illegal parking, loud noise at times when the licensed premise is open for business; traffic violations; curfew violations; lewd conduct; display of materials harmful to minors, pursuant to s. 106-9.6; or any other factor which reasonably relates to the public health, safety and welfare, or failure to comply with the approved plan of operation. It is the intention of the Common Council to suspend or non-renew the licenses if objectors provide testimony related to the factors enumerated in MCO 85-4-4 that the Common Council finds to be true by a preponderance of the evidence and/or police reports are found to be true by a preponderance of the evidence. The police reports and other attached documents relating to objections to the license are a part of this notice and expressly incorporated in this notice. The licensee should be prepared to address these matters at the hearing.

Notice for applicants with warrants or unpaid fines:

Proof of warrant satisfaction or payment of fines must be submitted at the hearing on the above date and time. Failure to comply with this requirement may result in a delay of the granting/denial of your application.

Failure to appear at this meeting may result in the denial of your license. Individual applicants must appear only in person or by an attorney. Corporate or Limited Liability applicants must appear only by the agent designated on the application or by an attorney. Partnership applicants must appear by a partner listed on the application or by an attorney. If you wish to do so and at your own expense, you may be accompanied by an attorney of your choosing to represent you at this hearing.

You will be given an opportunity to speak on behalf of the application and to respond and challenge any charges or reasons given for the denial. No petitions can be accepted by the committee, unless the people who signed the petition are present at the committee hearing and willing to testify. You may present witnesses under oath and you may also confront and cross-examine opposing witnesses under oath. If you have difficulty with the English language, you should bring an interpreter with you, at your expense, so that you can answer questions and participate in your hearing.

You may examine the application file at this office during regular business hours prior to the hearing date. Inquiries regarding this matter may be directed to the person whose signature appears below.

Limited parking for persons attending meetings during normal business hours is available at reduced rates (5 hour limit) at the Milwaukee Center on the southwest corner of Kilbourn Avenue and Water Street. You must present a copy of the meeting notice to the parking cashier.

This report is written by Police Officer Monreal, assigned to the License Investigation Unit, Days.

The Milwaukee Police Department's investigation regarding this application revealed the following:

1. On 2-23-2005 at 7:12pm Milwaukee police conduct a license premise check at 1422 W Atkinson Ave, Stewart's Rest Stop. On the premise were amusement machines, but the license on the premise for the machines was expired. Jessica P Stewart was issued a citation for the following:

The following incidents has been added as a supplement to this attachment on 8-30-2205.:

2. On 7-16-2005 at 1:45am a shooting occurred at the Stewart's Rest Stop tavern, 1422 W Atkinson Ave. One witness in the tavern stated she heard 3 or 4 gunshots while she was seated at the bar. Thought the shots came from outside of the tavern. Another witness stated that he heard at least 4 shots. After the shooting he noticed Thelma Stewart, who was seated at the bar, bleeding from her head. A third witness stated he observed 2 males standing outside of the bar with shotguns. He noticed a male from inside the tavern, walk to the front door of the tavern with a .357 handgun. Once that male was in the doorway, the witness heard about 8 to 10 shots. No further information.

3. On 8-11-2005 at 10:57PM, an armed robbery occurred at Stewart's Rest Stop tavern, 1422 W Atkinson Ave., The robber fired one shot into the ceiling of the tavern.

4. On 04/05/07 at 12:01 am, Milwaukee Police conducted a license premise check at 1422 W Atkinson. Upon arrival, officers were unable to enter because the front door was locked. Officers could hear music coming from the tavern and began knocking loudly. A subject, identified as Bobby Allen, opened the door and advised police he was the bartender on duty. Officers asked to see the licenses for the tavern and Allen provided them. The taverns four licenses were all expired and the licensee was not on scene. Allen was asked for his bartending license in which he could not provide one to officers. Officers advised Allen to close down the tavern.

1. On 04/05/08 at 1:58 am, Milwaukee police were dispatched to 1422 W Atkinson for a Property Damage complaint. Officers spoke to the bartender Stephen Veener who stated he had been working all night and that an unknown patron paid for drinks with an altered ten-dollar bill. The bill was confiscated and placed on inventory.

2. On 03/06/10 at 12:45 am, Milwaukee police conducted a License Premise Check at 1422 W Atkinson and spoke to the manager Demetrius Meeks Sr who was on scene. As officers were about to exit the tavern, the observed patrons get up and start to dance among the tables and chairs. The tavern did not possess a dance tavern and Meeks was advised that the patrons could not dance and that the area they were dancing in was not a specific area for dancing. Police later made contact with the owner Jessica Stewart and advised her of the violation and stated a citation would be issued next time if the violation was found.

3. On 08/14/10 at 2:00 am, Milwaukee police were dispatched to 1422 W Atkinson for a Shooting complaint. Investigation revealed there was no shooting but that shots had been fired outside of the tavern. Officers spoke to the bartender Demetrius Meeks who stated at approximately 1:55 am, he was closing the tavern when patrons began coming back into tavern stating somebody was getting robbed outside. Meeks further stated that he then heard 4-5 shots, which sounded like they were outside the front door. Meeks further stated he believed it was related to the bar since everyone left peacefully. Police also spoke to the owner Jessica Stewart who stated she also heard 4-5 shots fired. A report was filed.

5. On 01/26/19 at 2:32am, Milwaukee Police conducted a license premise check at 1400 W. Atkinson Avenue. Before entering the establishment, officers observed 4 patrons leave the tavern and walk to their vehicles. Once inside the establishment, officers observed 10 total people inside the tavern after the hours of licensed operation. During the investigation, it was learned that one of the bartenders did not have a valid class D operator's license and the on duty security officer stated that the number of the patrons inside the establishment at one time is usually around 45-50 people (the DNS maximum capacity is 25 persons). The applicant was contacted about the investigation and a citation was issued to her.

6. On 03/31/19 at 10:24pm, Milwaukee Police conducted a license premise check at the address at 1422 W. Atkinson Avenue. Upon entering the establishment, officers informed security that they were there to perform a capacity check and security told them that DNS had upgraded there capacity to 49 persons since 03/18/19. A body count was performed and there were 34 persons inside the tavern.

7. On 03/17/2020 at 9:24pm officers conducted a license premise check at Stewart's Rest Stop, 1422 W. Atkinson Av. The officer was checking to see if the bar was complying with the Governor's emergency order. The officer entered the business and observed three people sitting at the bar, one with alcohol. The bartender stated, she thought it was okay to be open as long as there were less that ten people inside. The officer advised her to close the bar. The bartender stated she would comply.

8. On 03/19/2020 at 12:51am officers were dispatched to a Tavern violation at 1422 W. Atkinson Av. The officers did not see an open sign but did observe a neon bar sign turned on. The door was locked but a subject did answer when the officers knocked. The subject stated he was a bartender for the bar but the bar was closed. The officers observed three subjects inside drinking beer. The bartender stated they were his friends that he invited over to get out of the house. The officers advised him to close the bar and provided him with a copy of the Governor's order.

9. On 03/21/2020 officers conducted a license premise check at Stewart's rest Stop, 1422 W. Atkinson Av. The business was closed with an iron gate locked across the main entrance.

10. On 11/26/20 at 8:42pm, officers conducted a license premise check at 1422 W. Atkinson (Stewart's Rest Stop). No violations were observed and the employee was cooperative, alerting officers to entry to autos occurring frequently across from the location.

11. On 12/19/20 at 11:45pm, officers conducted a license premise check at 1422 W. Atkinson (Stewart's Rest Stop) regarding a complaint the tavern was selling cases of beer after 9:00p. On arrival officers found the entrance door locked, however, gained entry upon knocking on the door. Officers observed approximately 40 people including staff in the bar, as well as a table with an electric skillet and air fryer. An employee was identified near the table and stated he was making hamburgers. The bartender advised officers at times they give food away as well as gift baskets. The agent was contacted via telephone and advised of the anonymous complaint and to obtain a Food License if she wanted to continue to serve food.
12. On 01/01/21 officers conducted a license premise check at 1422 W. Atkinson Av. (Stewart's Rest Stop). No violations were found
13. On 02/18/21 at 7:46pm, officers were on patrol and observed a van double parked in front of 1422 W. Atkinson Av. (Stewart's Rest Stop) unloading a box with multiple bottles of liquor, along with cases of beer. Officers believed this may not have been obtained by a distributor and conducted a license premise check regarding. The bartender could not produce receipts for the liquor and stated a State of Wisconsin agent told her if she was short on liquor, she could purchase liquor from a liquor store. The bartender was advised this was incorrect and they could only purchase from a distributor. While on scene officers also observed patrons eating at the bar. The bartender stated it was a sub purchased from the grocery store, which she was sharing. The bartender was advised she needs to obtain a Food License in order to have food at the bar. The bartender was further advised to obtain a Manager License since it appeared she was conducting the day to day operations. The agent was contacted via telephone and advised of the violations.
14. On 03/04/21 at 7:00pm, officers conducted an Alcohol/Tax Compliance check at 1422 W. Atkinson (Stewart's Rest Stop) with State of Wisconsin Department of Revenue Agents. Officers interviewed the bartender and requested to speak to the agent. The agent was contacted via telephone and advised officers due to health reasons, she could not come in person and has an employee taking care of the day to day operations including purchasing alcohol. The employee stated she had applied for a Manager License, however, a check with LIRA did not show an application. The employee in charge was advised of an outstanding tax bill. A Wisconsin Seller's Permit could not be produced and multiple liquor bottles were found to be contaminated.

15. On 10/11/21 at 1:02am, officers responded to a Spotshotter at 1426 W. Atkinson av., which is next door to 1422 W. Atkinson. On arrival officers observed multiple people fighting in the street and many vehicles parked in the City owned lot next to the bar. Officers observed a firearm in plain view in one of the vehicles and another firearm near the rear tire of the same vehicle. The owner of the vehicle was upset officers were looking at this vehicle and stated he and his intoxicated girlfriend were trying to enter the bar but were denied, therefore, an argument ensued. Officers interviewed the bartender who stated a drunk female carrying a bottle of liquor, was denied entry, which resulted in the fight. Officers advised the bartender their patrons can not continue to park in the City owned lot.

16. On 08/11/22 at 1:50a.m., Milwaukee Police conducted a License Premise Check at 1422 W. Atkinson Av. On arrival officers observed traffic and parking violations in front of and around the location. On prior occasions officers observed loitering and gambling also near the location. The officers interviewed the bartender on duty as well as the agent and advised them of the violations and offered suggestions on how to make improvements. The agent was cooperative with the investigation.
17. 07/05/23 at 12:58am, Milwaukee Police were dispatched to a shooting complaint at 1412 W. Atkinson Av. Officers spoke with witnesses on scene who stated that an argument occurred outside the business of Stewart's Rest Stop, located at 1422 W. Atkinson Av. The suspect shot the victim and fled the area in a vehicle east from the location. The witness stated that two gun shots were heard. The witness observed the suspect holding a handgun while fleeing the area. Officers spoke to the agent who stated that she was inside the premise at the time of the incident. The agent was cooperative with police and attempted to show video from her surveillance cameras. The agent eventually provided a phone to police of a person who could properly operate the surveillance cameras. During the course of the investigation officers observed patrons in vehicles parked in a lot near the business. The patrons were playing loud music, drinking, gambling and igniting fireworks. The patrons were creating a disturbance which could be heard more than 50 ft. away.
18. On 07/17/23 at 2:00a.m to a Battery at a local hospital. Investigation revealed the victim was involved in a physical altercation at 1422 W. Atkinson Av., and was struck in the head with a firearm. The victim was uncooperative, refusing police services. The hospital staff advised the officer the victim received multiple stitches for lacerations to the head.
19. On 08/07/23 at 2:00am, Milwaukee Police were dispatched to 1422 W. Atkinson Av, for a subject with gun complaint. Investigation revealed the assignment to be a battery complaint. The caller had left and officers met her at her residence. The caller stated that she left her purse containing her hand gun at the bar, earlier in the night. Once the caller realized she was missing her purse, she returned to the bar. The caller stated that she asked some patrons, about her purse. Per the caller a fight ensued with other patrons, and an employee eventually returned her purse and all her items. Follow up was conducted on 08/14/23 at 1:04am. The manager was cooperative and stated that a purse was found with a hand gun by security in the women's bathroom. The manager stated the owner received her purse but she tried to fight with patrons and security while retrieving her items. The manager was not able to provide video at the time of the follow up due to the business being closed.
20. On 08/20/23 Milwaukee Police were dispatched to the area of N. 15th and W. Atkinson Av, for a shooting complaint. The victim was shot in the knee area while standing outside the bar, and the assignment was related to a shot spotter of 12 guns shots being fired in the area. Investigating officers had a difficult time managing the shooting scene, due to the close proximity of the business and actions of some patrons. Over 50 subjects were standing outside or near the bar. Some subjects were being disorderly, outside the business. Actions observed by officers were of loud music, revving vehicle engines, squealing tires and belligerent individuals. Based on these actions the supervisor on scene had the business close down. The manager and DJ of the location were cooperative with police in closing the business and the investigation. The location was not involved in the shooting.

21. On 09/06/23 at 11:48p.m., Milwaukee Police were dispatched to a Shooting at 1438 W. Atkinson Ave. The victim was located with a gunshot wound to the lower left leg. Officers conducted a canvass of the area and located 4 shell casings outside of 1422 W. Atkinson Ave.

Employees and patrons were interviewed regarding the shots fired and a few patrons stated they did hear gunfire. The business was cooperative with police.

22. On 09/15/23 at 1:20a.m., Milwaukee Police conducted a License Premise Check at 1422 W. Atkinson Ave. No violations were found; however, officers did speak to the agent regarding some issues the establishment has had. The agent stated they are aware of loitering issues and they attempt to keep subjects away from the door that appear to be coming from the apartment next door.
23. On 12/16/23 at 12:38a.m., Milwaukee Police were dispatched to a Subject with a Gun at 1422 W. Atkinson Ave. The caller was anonymous and refused to provide their information. On arrival the officers observed citizens outside who did not appear to fear for their safety. The citizens were interviewed and all subjects denied seeing anyone with a gun.
24. On 02/07/24 at 10:20p.m., Milwaukee Police conducted a License Premise Check at 1422 W. Atkinson Ave. No violations were found and officers spoke to the owner who expressed concerns regarding vehicles parking in an empty lot next to their business.
25. On 03/10/24 at 1:24a.m., Milwaukee Police were dispatched to a Shot Spotter at 1422 W. Atkinson Ave. On arrival officers located 22 casings in front of the business. The officers attempted to interview patrons, however, they all denied seeing anything. The owner stated they do have video surveillance but they did not have access to the system at the time. In total 3 two-man squads and 1 supervisor responded to this incident.
26. On 06/19/24 at 10:17p.m., Milwaukee Police were dispatched to a Noise Nuisance at 1422 W. Atkinson Ave. On arrival officers found the door to the business open and music was excessive. Officers interviewed the owner and advised the door has to be closed after 10p.m. The owner complied and no other violations were found.
27. 06/23/24 at 2:05a.m., Milwaukee Police were dispatched to a Shooting at 1422 W. Atkinson Ave. On arrival officers observed the victim laying on the ground, who later succumbed to their injuries, as well as multiple spent casings in front of and to the west of the bar. All employees on scene were interviewed and cooperative, however, it could not be positively determined if the victim was ever inside the establishment. Officers were able to view video surveillance from both inside and outside, however, it only depicts people scattering outside and the victim lying on the ground. All employees interviewed were cooperative with police and it was determined the business did not have security.
28. On 06/23/24 at 8:501p.m., Milwaukee Police conducted follow up regarding a Recklessly Endangering Safety incident at 3500 W. Atkinson Ave. The victim stated prior to the incident they were at 1422 W. Atkinson Ave. The officer interviewed an employee who stated the video surveillance only goes back to 06/17/24 and they did not recall seeing the suspect vehicle.

LICENSED PREMISE REPORT

This report is written by Officer BUKOVSKY assigned to District 5 Late Power Shift.

On 09/06/2023 at 2348hrs, my partner Officer LOPEZ and I (Squad 5436) were dispatched to the address of 1438 W. Atkinson Ave for a shooting. We arrived at 2351hrs in full duty uniform wearing activated body-worn cameras.

We located the victim along with Officers MOODY-PETZ and Officer WELCH (Squad 5426) in the stairwell of the listed address. The victim appeared to have one gunshot wound to the lower left leg and currently had a make-shift tourniquet (belt) already in place above the left knee. The belt was left in place, and I applied an additional tourniquet at 2356hrs directly above the belt since the belt was against his knee joint.

MFD arrived and took over medical for the victim.

My partner and I set up crime scene tape.

My partner and I conducted a residential and vehicle canvass which were ran in CAD #232491873. Which included checking businesses for cameras.

My partner and I continued to locate and mark shell casings at the scene. While locating numerous shell casings on W. Atkinson Ave, we located approximately 4 shell casings outside of 1422 W. Atkinson Ave (Stewarts Rest Spot) front door.

*2 SHOTSPOTTER ACTIVATIONS DURING THE SHOOTING AT 1426 AND 1444 W ATKINSON ALONG SEVERAL CALLERS FOR THE SHOTS FIRED INCIDENT BUT NO ONE FROM TAVERN.

I spoke with the bartender inside of Stewarts Rest Spot, Gloria R. RAGSDALE (BF 09/06/1963) who stated she did not witness or hear any gunfire outside of the bar entrance and there were no cameras. A couple of patrons stated they heard gunfire outside. RAGSDALE was cooperative with police.

Upon attempting to interview approximately (15) patrons, every single one stated that they did not see anything and could not provide an account for what had taken place. While inside of the bar, we spoke to the owner, Gloria RAGSDALE (F/B, 09/06/1967), who stated that the bar does have cameras, but stated that she did not have access to the video at this time, and follow up will need to be conducted during daytime hours. RAGSDALE was not asked why no one had called regarding this incident. The bar did not have any staffed security at the time of this incident.

While on scene, PO SANDOVAL spoke to the bartender and alleged owner, Gloria R RAGSDALE (F/B, 06/09/1963), who stated that she did not witness the incident, but stated that the bar does have surveillance cameras that may have captured this incident. Upon *our arrival*, we observed the establishment to have an open door with loud music playing from within the bar. The volume of he music could be heard very clearly from across the street and around the corner of the establishment. We also observed street food vendors selling food in front of the location and at and both ends of the block. The food vendor in front escorted us inside to meet the Manager, Gloria R RAGSDALE (B/F 9-6-63)

PO WILSON and I advised RAGSDALE that after 10PM, she needs to have the front door of her establishment closed to keep the noise from leaking into the neighborhood. We then walked outside establishment to advise her that she needs to have the volume of speakers turned down due to the audible noise from within the location. RAGSDALE was cooperative with our requests and allowed us to talk to the DJ, who turned the speaker volume down. once the door was closed, and the speakers were turned down, the noise coming from the building was reasonable in accordance to city ordinance.

We did not speak to the caller due to our initial observations upon-entering the area. We did follow up about an hour later to see if any changes. we were pleased to see that the establishment was still complying with our earlier requests.

RAGSDALE voiced her concerns about being blamed for the noise of the local residents. She stated she has no control over the people who live close by and congregate in front of her establishment. I advised her to think about hiring a form of security to move the crowd or purchasing a queue rope that so Law Enforcement can identify whos a patron and whos not.

While on scene, I observed the licenses posted and they were up to date. During my investigation for the noise complaint, we informed RAGSDAE that she would not be cited for todays interaction, but warned her that if this continues, further actions will be taken. We also notified RAGSDALE that we had to file the report, but will add how cooperative her and her staff were in todays interaction.

On Sunday, June 23rd, 2024, at approximately 2:05 AM, my partner PO Delia CARRILLO and I, responded to 1422 W. Atkinson Avenue., located in the City and County of Milwaukee (WI), for a ShotSpotter Activation, that was shortly upgraded to a Shooting, resulting as a Homicide.

Upon our arrival, I observed multiple subjects outside of 1422 W. Atkinson Avenue., standing in front of Stewarts Rest Stop, which is a bar. I observed a male subject, who was the victim in this shooting, laying on the ground with police officers surrounding him. I noticed multiple spent casings as well, starting at the beginning of the bar entrance, and leading to the west of the location.

I entered Stewarts Rest Stop and spoke with two employees, who identified themselves as the Bar Managers. I spoke with Gloria R RAGSDALE (B/F 09-06-63) and Earnest L MORGAN (B/M 06-21-79).

I asked MORGAN and RAGSDALE if Stewarts Rest Stop is equipped with surveillance cameras on the interior and exterior of the bar. RAGSDALE informed me that there is a surveillance camera located on the exterior of the establishment right above the bar.

I asked RAGSDALE if I could view the video footage and RAGSDALE contacted Donnell MCCARTY (B/M 11-16-67), who has access to the surveillance cameras. I was later met by MCCARTY, and I escorted MCCARTY into the bar.

I spoke with MORGAN and asked if he heard or saw anything regarding the shooting. MORGAN stated that he was escorting a group of female subjects to their vehicle, when he heard approximately 4 gunshots. MORGAN stated that he observed multiple subjects scatter from in front of the bar on foot and in vehicles. MORGAN stated that when the last gunshot was fired, police arrived on scene. MORGAN stated that he did not hear or observe any altercation or commotion outside of the bar prior to the gunshots. MORGAN stated after the gunshots, he observed the victim fall to the ground. I asked MORGAN if he knew if the victim was conscious after he had fallen to the ground, and MORGAN stated that he was unsure. I asked MORGAN if the victim was inside of the bar prior to the shooting and MORGAN stated that he was unsure.

PO CARRILLO spoke with RAGSDALE, who stated the following:

RAGSDALE stated that she began to shut the bar down at approximately 1:45 AM and began to clean the bar. RAGSDALE stated that she heard approximately 4 gunshots.

There was nothing further provided by RAGSDALE.

I asked MORGAN if the bar had security and MORGAN stated that the bar does not have

security. I asked the time of operation for the bar, and I was informed of the hours of operation:

- Monday: 6:00 PM-2:00 AM
- Tuesday: 6:00 PM-2:00 AM
- Wednesday: 6:00 PM-2:00 AM
- Thursday: 6:00 PM-2:00 AM
- Friday: 6:00 PM-2:00 AM
- Saturday: 6:00 PM-2:00 AM
- Sunday: 6:00 PM-2:00 AM

I did observe the hours of operation posted as well, with a few minor changes from the above hours I was informed of:

- Friday: 5:00 PM-2:30 AM
- Saturday: 12:00 PM-2:30 AM

It is also posted that this bar only accepts individuals who are 25 and older, which is also posted on the outside of the bar.

RAGSDALE informed me that she closes the bar early, at approximately 1:45 AM, so that everyone is out by 2:00 AM. RAGSDALE stated that she works every night that the bar is open, and normally arrives for her shift at approximately 8:00 PM. RAGSDALE informed me that MORGAN works at the bar on Thursdays, Saturdays, Sundays, and Mondays.

When MCCARTY arrived on scene, he pulled up video footage from the exterior surveillance camera as well as one of the interior surveillance cameras. I was advised that the bar has 3 surveillance cameras inside of the bar. I first viewed the video footage from the exterior surveillance camera, which unfortunately did not capture the shooting. Prior to the shooting, the video footage shows multiple subjects outside of the bar. The video footage jumps around and when I tried to view the video footage of when the ShotSpotter activation comes over, it states that there was no video footage. The video footage afterwards shows when the police first arrived on scene. MCCARTY stated that he was unsure which interior surveillance camera footage I wanted to view, and I told MCCARTY to pull up video footage from the surveillance camera that captures most of the inside of the bar, which also points outside of the main entrance. The video footage showed multiple subjects outside of the bar. The timing on the surveillance cameras is not accurate, but the time stamps are:

- 1459 hours - Shows multiple subjects scatter and the main entrance to the bar immediately closes.
- 1501 hours - The main entrance to the bar opens up and the victim is observed laying on the ground.

MCCARTY asked me if the victim was wearing white and red clothing, and I stated yes. MCCARTY did state that the victim was inside of the bar earlier in the evening and was informed that he had to leave because he had brought his own liquor into the bar. MCCARTY stated that the male subject apologized and stated that it was a onetime occurrence and if he could come back inside of the bar. MCCARTY stated that the male subject was informed he could not come inside of the bar anymore. It is not 100% sure if this was the actual victim, or someone that was

I did ask MCCARTY if he was the only one who had access to the surveillance cameras and MCCARTY stated that he was the only one who knew how to operate the surveillance cameras.

While on scene, I did observe the following licenses posted:

At this time, there was no police action taken. While speaking with all parties listed in this report under the "License Persons Involved" tab, everyone was very cooperative with the investigation and did not cause any issues once so ever.

I provided RAGSDALE with a PV-17 form (Victims Rights) and a Community Contact Card. I advised RAGSDALE that there would be a report filed regarding the license premises portion. I advised RAGSDALE that STEWART could contact me regarding any questions regarding this report.

This location does have nuisance related issues, but only on the outside of the bar. There have been prior ShotSpotter activations near this bar, as well as other complaints placed by citizens. In the past, police have advised citizens standing outside of the bar, of calls placed for service. Also, there have been multiple parking citations issued for vehicles that are in violation of parking.

As I was leaving from the scene, I briefly spoke to Detectives that investigated this homicide. I asked the Detectives if they were able to obtain any video footage regarding the incident, and the Detectives stated yes.


