There is a possibility that your application may be denied for one or more of the following reasons: The recommendation of the committee regarding the application shall be based on evidence presented at the hearing. Per MCO 85-4-4, unless otherwise specified in the code, probative evidence concerning non-renewal, suspension or revocation may include evidence of the following: failure of the applicant to meet municipal qualifications, pending charges against or the conviction of any felony, misdemeanor, municipal offense or other offense, the circumstances of which substantially relate to the circumstances of the particular licensed or permitted activity, by the applicant or by any employee or other agent of the applicant. If the activities of the applicant involve a licensed premises, whether the premises tends to facilitate a public or private nuisance or has been the source of congregations of persons which have resulted in any of the following: disturbance of the peace; illegal drug activity; public drunkenness; drinking in public; harassment of passers-by; gambling; prostitution; sale of stolen goods; public urination; theft; assaults; battery; acts of vandalism including graffiti, excessive littering, loitering, illegal parking, loud noise at times when the licensed premise is open for business; traffic violations; curfew violations; lewd conduct; display of materials harmful to minors, pursuant to s. 106-9.6; or any other factor which reasonably relates to the public health, safety and welfare, or failure to comply with the approved plan of operation. It is the intention of the Common Council to suspend or non-renew the licenses if objectors provide testimony related to the factors enumerated in MCO 85-4-4 that the Common Council finds to be true by a preponderance of the evidence and/or police reports are found to be true by a preponderance of the evidence. The police reports and other attached documents relating to objections to the license are a part of this notice and expressly incorporated in this notice. The licensee should be prepared to address these matters at the hearing.

**Notice for applicants with
warrants or unpaid fines:**

Proof of warrant satisfaction or payment of fines must be submitted at the hearing on the above date and time. Failure to comply with this requirement may result in a delay of the granting/denial of your application.

Failure to appear at this meeting may result in the denial of your license. Individual applicants must appear only in person or by an attorney. Corporate or Limited Liability applicants must appear only by the agent designated on the application or by an attorney. Partnership applicants must appear by a partner listed on the application or by an attorney. If you wish to do so and at your own expense, you may be accompanied by an attorney of your choosing to represent you at this hearing.

You will be given an opportunity to speak on behalf of the application and to respond and challenge any charges or reasons given for the denial. No petitions can be accepted by the committee, unless the people who signed the petition are present at the committee hearing and willing to testify. You may present witnesses under oath and you may also confront and cross-examine opposing witnesses under oath. If you have difficulty with the English language, you should bring an interpreter with you, at your expense, so that you can answer questions and participate in your hearing.

You may examine the application file at this office during regular business hours prior to the hearing date. Inquiries regarding this matter may be directed to the person whose signature appears below.

The Milwaukee Police Department's investigation regarding this application revealed the following:

1. On 06/28/2012 the applicant was cited for Operating While Intoxicated. He was convicted on 07/18/2012 and his license was revoked for 6 months.
2. On 01/27/2018 the applicant was cited in the City of Milwaukee at 1226 W. National Av for

Item #2 updated with disposition on 06/20/2019

3. On 03/11/2019 at 2:11am officers investigated a subject with gun complaint at 1226 W. National Av. The officers spoke with security, who stated there had been a fight between two males. They escorted the subjects out and one of them punched security and broke a window. Security stated they did not want to prosecute for the incident.

4. On 04/01/2019 at 2:01am Officers were dispatched to a battery at 1226 W. National Av. The investigation revealed two patrons of the bar where fighting outside because of an incident that had occurred inside the bar prior to closing. The applicant was on scene but stated he was upstairs when the fight occurred. No tavern violations were observed.
5. On 06/08/2019 at 12:04am officers were dispatched to 1226 W. National Av to investigate a battery complaint. The investigation revealed a patron punched the security guard in the face and fled the scene. The subject was located and identified as being 19 years old. He stated he entered the bar without being asked for ID and consumed alcohol while on scene. The officers were unable to speak with the applicant because it was after bar closing time when the subject was located.

6. On 07/21/20 at 11:39am, the Milwaukee Police Tactical Enforcement Unit conducted a search warrant at 1226-1228 W. National Avenue. The applicant was located in the upstairs living area along with cocaine, marijuana, and items used to package and sell these products. The applicant was arrested and the actual tavern was searched but did not contain anything of evidentiary value.
7. On 08/17/20 the applicant was cited in the City of Milwaukee at 1226 W. National Avenue for Build Code Violations.

8. On 11/18/20 at 10:57pm, Milwaukee Police were dispatched to 1226 W. National Avenue for a subject with weapon complaint. Officer's interviewed the applicant who stated that there was a fight between three brothers, who are regular customers, and one of them threatened to break his window with a rock. The applicant was cooperative with the investigation and told to call back if the brothers returned.
9. On 12/28/20 the applicant was cited in the City of Milwaukee at 1339 S. 9th Street for Building Code Violations.

10. On 02/14/21 at 1:23am, Milwaukee Police, along with the Milwaukee Health Department, conducted a license premise check at 1226 W. National Avenue. The Environmental Heath Specialist observed several individuals standing in close proximity of one another and nobody had face masks on. The Environmental Health Specialist told the applicant he was going to issue citations for not wearing face masks and standing. (As of 06/23/21, no citations were found for violations regarding this incident.)

11. On 03/02/21 at 1:21am, Milwaukee Police were dispatched to 1226 W. National Avenue for a sexual assault complaint. Investigation revealed that a patron had her breast grabbed by another patron inside the establishment. The victim's boyfriend punched the actor and the applicant broke up the altercation. The victim called police and the applicant (who did not call police) was cooperative with police. No tavern violations were observed.

12. On 07/09/23 at 2:25a.m., Milwaukee Police were dispatched to a Subject with Weapon at 1226 W. National Ave. Investigation revealed a physical altercation took place inside the establishment between patrons. The agent was notified and came downstairs and sprayed pepper spray in an attempt to disperse the crowd. The business was cooperative with the investigation and allowed officers to view video surveillance of the incident.
13. On 09/24/23 at 1:26a.m., Milwaukee Police were dispatched to a Subject with a Gun at 1226 W. National Ave. Investigation revealed a subject was removed from the tavern due to causing a disturbance. The subject then fired multiple shots into the establishment, causing damage to the exterior. The subject fled the scene and officers. The subject crashed a short time later. Officers recovered spent casings and magazines in the unoccupied vehicle. The business was cooperative with the investigation and allowed officers to view video surveillance of the incident.
14. On 12/14/23 at 12:40a.m., Milwaukee Police were dispatched to a Fight at 1226 W. National Ave. Officers interviewed the agent who stated he observed two subjects from opposing gangs making threats to shoot one another, however, did not observe any weapons. The agent did not want the subjects removed, as they did not want involvement in any potential conflicts. The agent requested increased police presence.
15. On 04/29/24 at 1:36a.m., Milwaukee Police were dispatched to a Property Damage at 1226 W. National Ave. Officers observed a subject who stated they were in pain due to being pepper sprayed at the location. Officers interviewed the agent as well as several witnesses who stated they patron was causing a disturbance in the bar and engaged in a physical altercation, at which time the agent pepper sprayed the subject and called for police. The agent stated officers could come back to view video surveillance once they retrieved the password.
16. On 07/30/24 at 8:30p.m., Milwaukee Police conducted a License Premise Check at 1226 W. National Ave., regarding a complaint of underage bartenders. Assisting in this assignment were Agents from Wisconsin Department of Revenue Alcohol and Tobacco Division. On arrival officers found the business open and one employee inside (33yo), who initially stated they were the bartender, however, then recanted and stated they were just opening up for the owner who lives upstairs. The DOR Agent found the following violations:
- No Licensed Operator on Premise
 - Seller's Permit was not posted
 - Beer Purchased from Unlicensed Distributors

- Defaced Labels
- Contaminated Liquor
- Missing Invoices

The Agent confiscated a total of 139 Liquor bottles, both open and unopened. The Agent advised the business agent this would be an educational visit and made suggestions to correct the violations.

17. Milwaukee Police were dispatched to 1226 W. National Ave., for Noise Complaints on the following dates:

- 07/21/23 at 9:46pm Music could be heard on officer's body cam from two properties away. Officers advised the business to close the door and lower the music
- 07/23/23 at 12:51am No loud music could be heard from the premise
- 09/09/23 at 10:29pm The officer determined the loud music was not coming from the premise
- 02/10/24 at 9:52pm Caller cancelled the squad because music was turned down
- 02/13/24 at 12:30am Body cam showed music could not be heard until the door was open. The employee agreed to lower the music.

18. On October 18, 2024, at approximately 12:21 pm, Milwaukee Police Officers executed a search warrant in the tavern and residential units of 1226 W National Av. The warrant was requested because officers were investigating a shots fired incident from the residential unit and the applicant was the suspect. Officers recovered cocaine, drug paraphernalia, a suspected drug sales ledger, and 9mm cartridges. Chickens were also located in the basement of the tavern. The applicant was arrested, charges have been referred to the District Attorney's Office.

unknown females in a physical altercation with the victim, later identified as Jhonny SANTIAGO-PEREZ (W/M, 6-25-00). ALBANIL-COYOLT stated that he then peppered sprayed the crowd of people in order to break up the fight. ALBANIL-COYOLT stated that this occurred at approximately 2:10 am.

I spoke with SANTIAGO-PEREZ who stated that he was at the bar dancing when one of unknown females started to mock him and call him a "joto", which is a derogatory Spanish slang word for a homosexual. SANTIAGO-PEREZ stated that he was offended at the comments made by the unknown female. SANTIAGO-PEREZ stated that the bartender, later identified as Emileydi S. CANTARERO-VALDIVIA (W/F, 3-7-99), tried to defend him and asked the unknown female to leave. SANTIAGO-PEREZ stated that when CANTARERO-VALDIVIA intervened, the unknown female became angry and things turned physical, further stating that he was struck and bit multiple times by the unknown female.

CANTARERO-VALDIVIA stated that she was tending to the bar (El Cielo) on July 9th, 2023, at approximately 2:00 am, when she noticed that two unknown females were making fun of SANTIAGO-PEREZ. CANTARERO-VALDIVIA stated that the unknown females were calling SANTIAGO-PEREZ a "joto" and when she noticed this, she asked them to leave. CANTARERO-VALDIVIA stated that when she stepped in, things escalated and one of the unknown females attacked SANTIAGO-PEREZ. CANTARERO-VALDIVIA stated that she then contacted ALBANIL-COYOLT to come downstairs. CANTARERO-VALDIVIA stated that ALBANIL-COYOLT then pepper sprayed the unknown females.

The owner was cooperative during the course of our investigation. ALBANIL-COYOLT let us view video which matched the stories told by CANTARERO-VALDIVIA and SANTIAGO-PEREZ. I reviewed the business permits which revealed that the Tax Certification has been expired since 2019, however his Class B Tavern License was up to date. The lead bartender did not have a license to bartend, and the bar was open past 2:30 am.

EMS services were dispatched to our location. Bell 4555 arrived on scene at approximately 3:12 am. EMS was provided to SANTIAGO-PEREZ. EMS stated that the injuries were minor, no broken skin or bruising. SANTIAGO-PEREZ stated that he did not need to go to the hospital.

A PV-17 was issued to SANTIAGO-PEREZ. Restraining order information and a contact card was also provided.

This case is still pending.

PO SANTIAGO and I (PO LOMELI) arrived at 1226 W National Ave in front of the location and heard multiple gunshots and we observed a gray Nissan Armada Silver bearing WI plate #LZ2764. Suspect vehicle then fled Westbound on W National Ave and turned Southbound on S 14th St, which it then struck another vehicle (occupied and no injuries) going Eastbound on W National Ave from S 14th St. Officers approached the suspect vehicle and did not locate the suspect but did locate inside the vehicle one unspent casing 9mm cartridge on the driver floorboard and one 9mm spent brass casing in the rear driver floorboard. I (PO LOMELI) also observed two black firearm magazines one was empty, and the other magazine had multiple unspent 9mm Luger cartridges in the center console.

PO MARTIN from Squad 2321 interviewed the bartender Ruben Albanil COYOLT (W/M 06/08/85) who stated he observed the suspect argue with another citizen inside the tavern over a female, which he then told the bartender Karina E SEBALLOS (W/F 02/18/90) to remove the suspect from the bar. SEBALLOS stated she told the suspect to leave the bar and once she closed the door she heard multiple gunshots. PO MARTIN stated he observed four spent casings outside in the sidewalk and the tavern was struck multiple times in the front brick wall.

PO MARTIN stated an unoccupied vehicle was also struck 2005 Nissan pathfinder white in color bearing WI Plate ANM8242 parked in front of the tavern as well. I (PO LOMELI) viewed the video from PO GNAS where it shows the gray Nissan Armada drive in front of the tavern and discharged a firearm towards the bar. I (PO LOMELI) observed muzzle flash coming from the gray Nissan Armada and as soon as the driver observed Police behind

On Sunday, April 29th, 2024, at approximately 1:36 AM, my partner Police Officer Jack Carloni and I were dispatched to a Property Damage Complaint at the address of 1226 W National Ave which is located inside the City and County of Milwaukee.

It should be noted every interview I conducted was in the Spanish language and I am translating this report to English in the best of my ability. To get a better understanding of the incident you can refer to my bodycam for all interviews.

Upon our arrival, I observed person who was called upon outside of his vehicle who later identified himself as Heriberto Santiago Canseco (H/M, 12/18/1995). Santiago Canseco was outside of his vehicle and what appeared to be in an erratic manner. We approached Santiago Canseco and asked what was wrong. Santiago Canseco then stated he was in excruciating pain due to being pepper sprayed. I asked Santiago Canseco where he was pepper sprayed and he pointed west, indicating at the bar closest to which was later determined to be 1226 W National Av. Santiago Canseco continued to scream in agony and then asked for water for his eyes.

I then continued to walk to the bar where I was later met with the owner of the bar who was also our caller. I spoke to the caller, who identified himself with a valid Illinois stated ID card as Ruben Albanil Coyolt (H/M, 06/08/1985). Albanil Coyolt stated he observed Santiago Canseco enter the establishment approximately 45 minutes prior to making the call for service. Albanil Coyolt stated Santiago Canseco continued to order drinks, but he noticed Santiago Coyolt to slowly become an issue as he would finish the drinks. Albanil Coyolt stated Santiago Canseco was repeatedly bothering other customers/patrons inside the establishment at the front bar. Albanil Coyolt stated he would continuously warn Santiago Canseco to put an end to his actions or he would be kicked out. Albanil Coyolt stated he then observed Santiago Canseco enter the men's restroom after another patron. Albanil Coyolt stated he heard what sounded like a scuffle and quickly entered. Albanil Coyolt stated he attempted to break up what was going to be a fight but was unsuccessful. Albanil Coyolt stated he then chose to pepper spray Santiago Canseco as he was the main person causing an issue. Albanil Coyolt stated Santiago Canseco then exited the restroom, approached the window near the main entrance and began to either push or slam his hands against it. Santiago Canseco was then escorted out of the business and Albanil Coyolt called for police.

I spoke to witness 1 who did not wish to identify himself. The patron stated he observed Santiago Canseco acting in an unruly manner the entire time he was inside the establishment. The patron also stated his actions were entirely unprovoked and uncalled for due to not being bothered. The patron stated he observed Santiago Canseco enter the restroom, shortly after exit and begin to violently slam his hands on the sole window just next to the main entrance. It should be noted that no damage was caused to the window. The patron did not wish to add any other info.

I spoke to second witness and sole bartender on scene who identified herself as Patricia Lopez (W/F, 03/19/1991). Lopez stated she was the bartender the entire time Santiago Canseco was inside the business and served him. Lopez stated Santiago Canseco was also harassing other patrons and causing an overall disturbance. Lopez stated there was a specific gentleman who Santiago Canseco "kept getting into it with". Lopez then physically pointed out the gentleman Santiago Canseco had an issue with, and I then interviewed him.

I then interviewed the subject who Santiago Canseco had the altercation with. He identified himself as Noe Clavel (H/M, 01/21/1989). Clavel stated he entered the restroom and was followed by Santiago Canseco inside. Clavel stated Santiago Canseco then got in his face attempting to possibly cause a scene. Clavel stated he then attempted to ignore him but Santiago Canseco refused. Clavel stated they both then engaged in a scuffle where Clavel felt the need to strike him due to the aggressive manner Santiago Canseco was acting. Clavel stated shortly after was when the owner entered the restroom, attempted to separate the two but then resulted in Santiago Canseco being pepper sprayed.

I was not able to review video surveillance footage. Albanil Coyolt stated he would have to acquire the passwords to the cameras as he has nothing to hide and asked if we could return another day so he could retrieve the password.

Santiago Canseco was cited for his actions inside the establishment.

It should also be noted that every person I interviewed to be mildly intoxicated at the time of my investigation.

While on scene, I did not observe the licenses posted and it is unclear if they were up to date. During my investigation for Property Damage, I did not observe any violations in the licensed premise, nor did I observe any property to be damaged which was our initial call for service.

Upon a records search, there is a Class B Tavern License and Public Entertainment Premises License. Both active and expire on 08/02/2024.

This report is being typed by PO Dellian Mendez-Santiago, assigned to District Two, Late Power, in full duty uniform, operating marked MPD Squad 234, and equipped with my department issued body worn camera, which captured this incident.

On Tuesday, July 30, 2024, at approximately 8:30 PM, Squad 2445 (PO Justin Merritt, PO Jesus RODRIGUEZ and I) along with Special Agents Ashley Schnering and Erin Dorn) regarding an investigation with underage bartender at 1226 W National Ave (Exclusive Night Lounge/El Cielo), in the City and County of Milwaukee.

Debrief:

We were informed by Special Agent Schnering there have been multiple complaints received that bartender at the listed location, are alleged under the age of 18, serving alcohol to customers, and inappropriately dancing on bar tops. Special Agent Schnering stated these events are happening during the busier days and we will be assisting them with this investigation.

On Scene:

Upon arrival, we observed the business was open. We entered and did not see anyone at the bar. A female subject was observed sitting down playing on her phone. This female identified herself verbally as Diana P. Lopez-Medina (w/f, 3/17/91). Lopez-Medina originally stated she was the bartender and was opening up for the owner. Lopez-Medina recanted her statement and stated she is just helping the owner open, as the bartenders who were originally set to open the bar did not arrive. Lopez-Medina stated the owner lives upstairs and could be coming down shortly.

Special Agent Schnering explained to Lopez-Medina officers are currently there to double check their license and permits, along with invoices. A short time later, the owner who was identified as Ruben Albanil-Coyolt (w/m, 06/8/85) walked downstairs from his residence and was explained why we were there.

While there, Special Agent found the establishment in violation of the following:

1. Did not have a licensed operator on premises
2. Post Seller's Permit
3. Beer was not purchased by License Distributors
4. Defaced labels

5. Contaminated Liquor
6. Missing Invoices

Special Agents confiscated 38 sealed liquor bottles and 101 open liquor bottles.

Special Agent Schnering informed Albanil-Coyolt he would not be facing criminal chargers or would be referred to the District Attorney's office.

This simply will be an educational visit and suggested the following:

1. Must have a License Operator on premise at all times.

Albanil-Coyolt stated he is upstairs and his workers can open the bar without him being there. He was informed by Special Agent Schnering that is not possible and would need to be present at all times if he does not have a proper License Operator on the premise. Albanil-Coyolt became irritated and stated he will just contact his lawyer and get a license for his employees.

1. Post Seller Permit

Albanil-Coyolt stated his permit was posted however upon our arrival, Special Agent asked Lopez-Medina for the seller's permit which was never provided. Once provided, it was observed the seller's permit was expired. Special Agent Schnering explained it would need to get renewed with angered Albanil-Coyolt who stated he was told by the state he did not need it. It was explained to Albanil-Coyolt he could go online and retrieve an updated version.

1. All liquor and beer must be purchased through a License Distributor not retail.

Albanil-Coyolt stated he buys his liquor from a retail shop located on W. Oklahoma Ave. Albanil-Coyolt stated it is not his fault when the retail store knows he is a licensed bar and would sell to him regardless. It was explained to Albanil-Coyolt, he needs to buy through a License Distributor only not a retail service as they did invoices to keep track of all the purchases.

1. Defaced Liquor Labels
2. Dispose of Contaminated Liquor
3. Invoices must be on premises for 2 year sequence.

Albanil-Coyolt informed officers and agents on scene he kept his invoices in his residence or with his accountant. Albanil-Coyolt was informed he cannot do that and needs to keep them in the bar or in a folder inside the bar.

Albanil-Coyolt was displeased with officers and agents and informed us multiple times he would contact his lawyer who can contact Special Agent Schnering.

Albanil-Coyolt signed the following forms:

2. Property Receipt.

Officers were also given a copy for record purposes.

Scott SUVAKA (squad 2150) were dispatched to a shots fired complaint at the address of 1241 W National Ave. During the course of the investigation officers recovered video footage which showed a Hispanic male who officers suspected to be Ruben ALBANIL-COYOLT (H/M 6/8/1985) stick his head out of the upper window of 1226 W National Ave and extend his arm and fire several shots into the air. This footage was uploaded to Axon Digital evidence system by P.O. TRACY under CAD # P2410140657.

Also, during the course of the investigation officers located 4 spent casings directly in front of the address of 1226 W National which officers knew to be from the upper unit, likely from the tenant and bar owner Ruben ALBANIL-COYOLT. These spent casings were placed on MPD inventory. This report was field under MPD case number C2410140085. I then drafted a search warrant for the entire address bar and residence located at 1226 W National Ave. This search warrant was executed on 10/18/24.

On 10/18/24 at 11:45am I briefed Milwaukee Police Officer Jason STACHOWIAK and Colin ULATOWSKI (squad 2165) who were in an unmarked Milwaukee Police Department Squad car watching the address before the execution of the search warrant that Ruben ALBANIL-COYOLT (H/M 8/6/85) was wanted for firing a handgun from his residence MPD IR C2410140085, and if they see him to stop and arrest him. P.O. STACHOWIAK and ULATOWSKI observed ALBANIL-COYOLT exit the residence where Officers arrested him. ALBANIL-COYOLT was then transported to district two for processing where he requested a lawyer.

AT 12:21 Officers from the Milwaukee Police Department tactical enforcement unit executed the search warrant and cleared the residence and turned it over to investigation officers to search. I along with P.O. Brian HEDER searched the bedroom and located top dresser drawer in the master bedroom a blue bowl which contained a powdery white substance which I suspected to be powder cocaine. I also observed in this bowl a plastic progressive insurance card with the name "Ruben" in the bowl. Also in this drawer was a set of measuring spoons with white powdery residue on it which I suspected to be used to measure out smaller quantities of cocaine for sales and distribution. Also in this drawer were multiple identifying documents belonging to Ruben ALBANIL-COYOLT. Located in a nightstand next to the main dresser were three boxes of Blazer 9mm brass in color Blazer unfired cartridges. I know this caliber to be consistent with the caliber casings located from the shots fired incident directly in front of the address of 1226 W National Ave.

I along with Officer HEDER located a suspected drug ledger on top of the main dresser, also located on top of the main dresser was a small bag of a white powdery substance which I suspected to be cocaine. This evidence and cocaine were transported to District Two for processing by P.O. HEDER and tested with the NARC II 07 field test kit which yielded a positive result for cocaine with a total weight of 7 grams (6.33 bowl and .77 small bag) This amount of cocaine, the presence of tools to measure out smaller amounts for sales, is consistent with an individual distributing cocaine. Additionally, during the search of the basement officers located chickens. Notification will be made to DNS.


