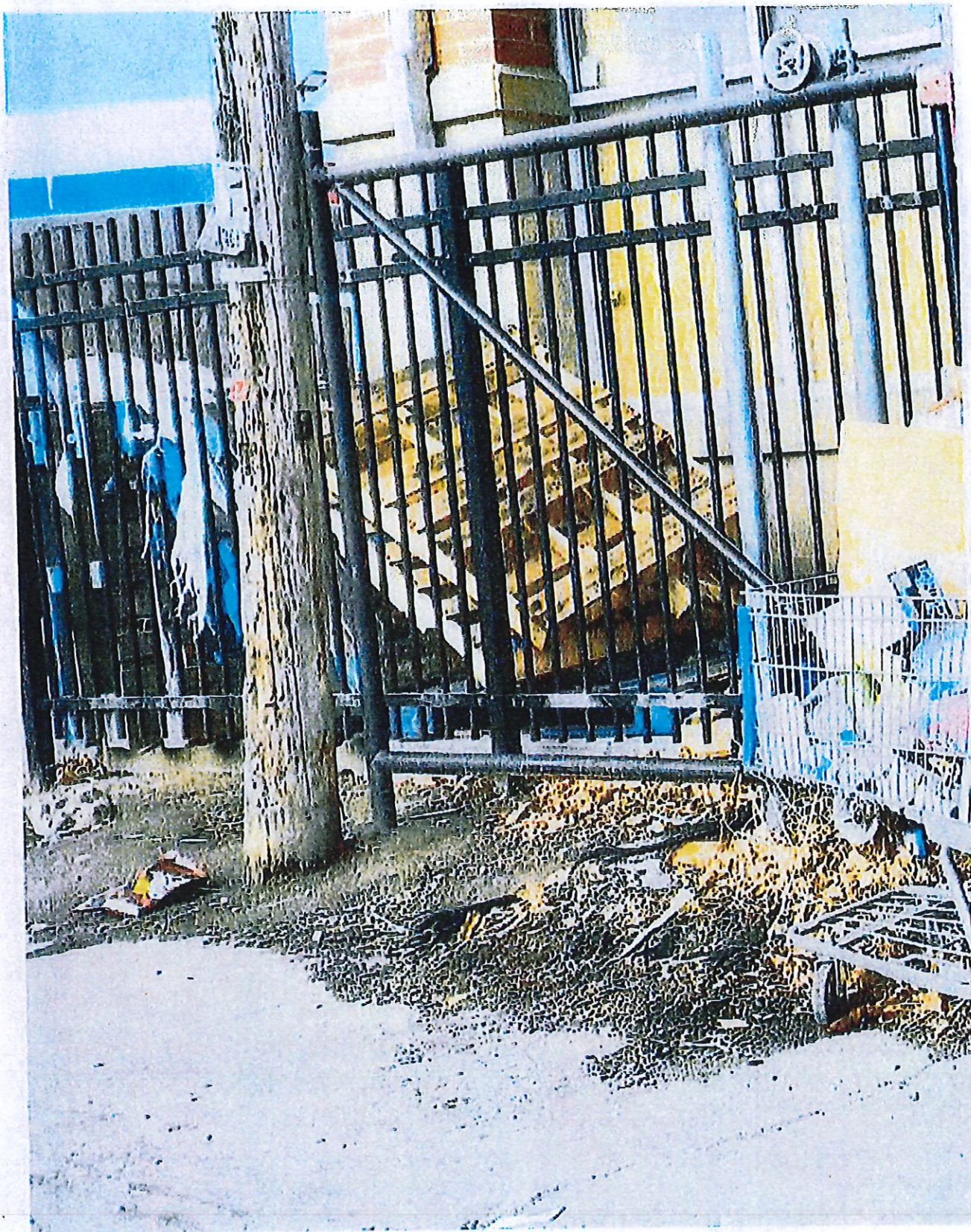

This report is being written by PO Ray PEARSON, assigned to District 5, Late Shift

On Tuesday, May 21st, 2024, my partner PO Hector SOSA and I were conducting a Business Check at the Hometown gas station, located at the address of 3476 N Holton St, which is located in the city and county of Milwaukee.

Upon arrival, I observed a black male who appeared to be in his 30s sitting awkwardly along the side of an ice machine outside the business. I observed him to be breathing and presumed him to be asleep or intoxicated. I decided I was going to conduct a welfare check on him after I had made a purchase at the business.

Upon leaving the business, I called out to the man, later identified as Joshua E. PERRY (B/M 01-06-88), who was not responsive to the sound of my voice, nor the flashes from my flashlight. I knocked on the ice machine in an attempt to wake PERRY with no success. I activated my body camera and alongside with PO SOSA, began to place perry into the rescue position, and to check for a pulse. PERRY had a pulse and was breathing but was not conscious. After several attempts to wake PERRY, we called for a Squad to provide us with a dose of Narcan, and Medical.

I spoke with the Hometown employee, later identified as Gurpreet SINGH (A/M 6-4-97), who stated PERRY came to the store at approximately 3am but was unaware of his condition. SINGH was helpful with the investigation, and showed empathy when he discovered what happened to PERRY. SINGH did not have footage of PERRY smoking the cigarette, or him in his found position. While on scene, I observed the licenses posted and they were up to date.

Squad 1320 (PO Elliott BARTA SANDERS) responded and provided Narcan Lot# 221322, which I administered.

Medical arrived (Med 5, Engine 1, Blue Shift, LT John SERGUS) and they administered a second dose of Narcan. PERRY eventually awoke and was advised to seek medical attention for his overdose. PERRY requested to be taken to the Milwaukee VA Hospital, located at 5000 W National Ave. PERRY was admitted at 5:11 Am and was seen by Dr. DILLIE.

I met with PERRY at the VA and inquired about what happened prior to his overdose. PERRY stated he was walking down Holton St at approximately 3am when he stopped at the gas station. PERRY stated he asked a man whom he did not know, if he could take a "hit of his cigarette". PERRY stated upon leaving the gas station, he "got dizzy" and stooped down on the icebox to rest. PERRY stated the next thing he remember was being woken up by medical. I asked PERRY to further describe the cigarette he smoked, and he described it to be "a rolled joint that tasted like a cigarette". PERRY was left with a community contact regarding todays incident.

The victim was identified as John POLLEY (W/M 11091958) who stated he two black males had taken his firearm was his waistband. POLLEY did not stay on scene because he had to go to work.

I spoke to licensed premise I spoke to the licensing agent of the business who was identified as Dhillon B BALJONDER-SINGH (W/M, 4/15/1977). The business was *cooperative*. The business does not have security officers.

I reviewed video surveillance footage, which depicted the following:

VICTIM PARKED IN THE PARKING LOT IN A BLUE TOYOTA PICKUP TRUCK, ENTERED THE GAS STATION TO PURCHASE CIGARETTES. THE VICTIM WAS AT THE EAST REGISTER, WHEN THE SUBJECT 1 COMES UP FROM BEHIND THE VICTIM AND TAKES THE VICTIM'S FIREARM FROM THE LEFT HIP. SUBJECT 1 POINTED HIS FIREARM AT THE VICTIM AND GRABBED THE VICTIM'S FIREARM AND POINTED IT AT THE VICTIM AS WELL.

THE FIREARM IS DESCRIBED AS A BLACK GLOCK 19, WITH A MAGAZINE. THE VICTIM STATED THERE WAS NO ROUND IN THE CHAMBER AND 14 ROUNDS IN TOTAL IN THE MAGAZINE.

VICTIM CHASED SUSPECT 1 TO THE BACK OF THE STORE, TACKLES THE SUSPECT. THE SUSPECT 1 THROWS THE VICTIM'S FIREARM TO SUSPECT 2. SUSPECT THEN GETS AWAY FROM VICTIM AND EXITS THE BUSINESS WITH THE OTHER 2 SUBJECTS AND THEY ENTER A SILVER CHEVERLOT SUV.

Follow-up will be conducted to attempt to recover the video footage.

While on scene, I observed the licenses posted and they were up to date.

## **Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:**

1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.
2. You must appear in person and testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)
3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are present at the committee hearing and willing to testify).
4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)
6. You may then provide testimony.
  - a. Include only information relating to the above license application.
  - b. Include only information you have personally witnessed or seen.
  - c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
  - d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
8. Business Competition is not a valid basis for denial or non-renewal of a license.


