FROM A POINT 50 FEET NORTH OF WEST WILLOW WAY
TO A POINT 130 FEET SOUTH THEREOF

Dear Alderman Burgelis:

This is in response to your request on behalf of a local resident to install the above-captioned parking restrictions in an effort to facilitate the movement of traffic on West Willow Way east of South 43rd Street and improve cross traffic visibility at the intersection of West Willow Way and South 43rd Street.

Our Traffic Engineering staff has investigated this request and found that restricting parking on West Willow Way would improve the flow of traffic on the roadway and restricting parking on the east side of South 43rd Street north and south of the intersection would increase visibility of vehicles on South 43rd Street for motorists exiting West Willow Way and therefore recommend their installation.

We will prepare the necessary legislation that will be heard at the next Public Safety and Health Committee meeting, so that you may support it to final passage.

This is in response to your request on behalf of a local resident to install the above-captioned parking restriction.

Our traffic engineering staff has investigated this request and found that east bound motorists on West Vienna Avenue at North 84th Street have a difficult time seeing traffic traveling southbound on North 84th Street when vehicles park close to the intersection. Therefore, in the interest of public safety, we recommend installing the above-captioned parking restriction to increase cross traffic visibility at the intersection.

We will prepare the necessary legislation for the next Public Safety and Health Committee meeting, so that you may support it to final passage.

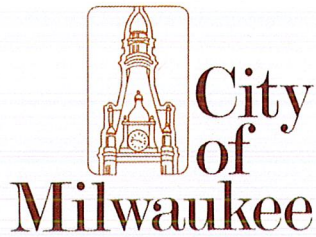
