- TSU issued 60% of speeding warnings in 2021, 67% in 2022, 70% in 2023, and 58% in 2024.

Data Methods: Citation and warning data was obtained from the Traffic and Criminal Software (TraCS) 10 for the time period of 2/24/2021—12/31/2024 and counts distinct citations and warnings for the requested statutes.
