Notice is hereby given that an ordinance that was introduced at the April 12, 2011 meeting of the Milwaukee Common Council, the essence of which is as follows:

A substitute ordinance relating to the change in zoning from Industrial-Heavy and Industrial-Light to Industrial-Office, for consistency with the Port of Milwaukee Redevelopment Plan's recommendations, for land generally bounded by railroad right-of-way to the north and east, East Bay Street to the south and South Allis Street to the west, in the 14th Aldermanic District.

Resolved, That the Mayor and Common Council of the City of Milwaukee, do ordain as follows:

Part I. There is added to the Milwaukee Code of Ordinances a new section to read as follows:

Section 295-801.10004. The zoning map is amended to change the zoning for 427 East Stewart Street, Tax Key No. 466-0201-100; 2100 South Bay Street, Tax Key No. 465-0109-112; 2039 South Lenox Street, Tax Key No. 465-0041-112; 822 East Bay Street, Tax Key No. 465-0034-000; 516 East Bay Street, Tax Key No. 466-9993-000; 356 East Stewart Street, Tax Key No. 466-0101-120; 432 East Bay Street, Tax Key No. 466-0202-111; and 2074 South Lenox Street, Tax Key No. 465-0108-100, from Industrial-Heavy (IH) and Industrial-Light (IL2) to Industrial-Office (IO2).

Notice is hereby further given that the foregoing matter will be given a public hearing by the Committee on Zoning, Neighborhoods and Development in Room 301-B, City Hall, 200 East Wells Street, Milwaukee, Wisconsin, on Tuesday, June 28, 2011 at 9:00 A.M., pursuant to the provision of Sub-Section (7)(d) of Section 62.23 of the Revised Statutes of the State of Wisconsin.

Therefore, notice is given that this meeting may constitute a meeting of the Common Council or any of its Standing Committees, and must be noticed as such, although they will not take any formal action at this meeting.
