Re: Pop Promotions, LLC d/b/a Texture – 606 S. 5th Street, Milwaukee, WI Objections

Dear City Clerk Leonhardt,

Our office is Counsel to Pop Promotions, LLC d/b/a Texture ("Texture"). On June 21, 2011, the Licenses Committee ("Committee") met to consider the renewal of Texture's Class B Tavern and Tavern Amusement license ("License"). The Committee voted to recommend that Texture's License be non-renewed based upon Items 21-25 of the Synopsis, the objection of one neighbor, and police department testimony.

This letter serves as my client's written objection to the "Findings of Fact and Conclusions of Law" and recommendation of the Committee. The specific objections are as follows:

- 1. Paragraph 4 of the Findings of Fact states that the hearing before the Committee was for the consideration of several items, including "neighborhood objections." The notice submitted to Texture contained no reference to neighborhood objections, but did include hearsay emails from a neighbor.
- 2. Paragraphs 5A through 5E contain a recitation of the Milwaukee Police Department's Criminal Record / Ordinance Violation / Incidents Synopsis ("Synopsis"). This recitation of the Synopsis fails to note that the Milwaukee Police Department, on virtually every night that taverns and clubs are open on 5th Street, has squads and officers present all throughout the area.

Paragraph 5A recites an incident which occurred on September 6, 2010. As testified to at the Committee hearing, the "large crowd" was actually Texture's security. Additionally, as testified to at the Committee hearing, the PA-33 for this incident states that a search of the disorderly subjects' vehicle was conducted, with consent, and no gun was found in the vehicle.

Paragraph 5B recites an incident that occurred on March 14, 2011. This incident

involved a woman who was pulled over blocks from the establishment because of a loud car stereo. The woman claimed to have been coming from Texture that night. Texture provided documentation and testified at the hearing that despite reports that the woman claimed that she was coming from the club, that Texture's ID system revealed that the woman had not been a patron of the club on that night. Because she was not a patron of the club, despite reports to the contrary, this incident should not have been included on Texture's Synopsis and it should have been struck.

Paragraph 5C recites an incident that occurred on March 6, 2011. The Synopsis (and paragraph 5C of the Findings) incorrectly states that MPD officers were monitoring closing at Texture that night. This is incorrect. As testified to at the hearing and as the PA-33 provides, MPD officers were monitoring bar closing on 5th Street, not specifically monitoring Texture. Additionally, and as testified to at the Committee hearing, many of the people in the crowd were Texture security who were attempting to gain control of the scene. In truth, there were approximately 10-15 people who were fighting and the fight was brought under control within a matter of minutes.

Paragraph 5D recites an incident that occurred on March 28, 2011. As testified to at the Committee hearing, Texture flagged down police (who were already patrolling the 5th Street area) and regardless of the fact that it resulted in a PA-33, Texture testified that it would not hesitate to again contact police in a similar instance. Upon information and belief, this type of use of the police department is encouraged by the Committee and Common Council.

Paragraph 5E recites an incident that occurred on April 2, 2011. The Findings fail to recite the fact that Texture played video of this incident for the Committee and the video conclusively proved that the female "victim's" alleged version of events were not the truth. In fact, the video proved that it was the female who twice attacked the male driver and the male driver was only trying to defend himself from the female's attacks. Additionally, as testified to at Committee and as the documentation from Texture conclusively proved, Texture's ID system revealed that neither the female driver nor her cousin had been a patron of the club on the night that this incident occurred, despite their reported claims to the contrary. The male driver of the other vehicle never claimed to be at the establishment. Because no person who was involved in this incident had been a patron of the club on the evening that it occurred, this incident should have been struck.

3. Paragraph 5F recites testimony provided by the only objecting neighbor. Texture objected to this testimony at the Committee hearing and does not believe that most, if any, of the complained of behavior is emanating from Texture nightclub. Texture illustrated to the Committee that there are numerous other establishments that are significantly closer in distance to the neighbor's property than Texture and that it is likely that the source of any disturbances the neighbor is complaining of are coming from those establishments.

- 4. Paragraph 5G describes the testimony of Lieutenant James MacGillis of the Milwaukee Police Department. The Findings fail to include Lt. MacGillis's testimony that neither he nor the Milwaukee Police Department were objecting to renewal of Texture's License.
- 5. Paragraph 5I describes the fact that Texture informed the Committee that it would not be seeking renewal of its License past the 2011-2012 license year as the lease at its 5th Street location was set to expire in 2012. Despite a Committee member's concern about lack of accountability, should Texture's License be renewed, it intends to operate in a very responsible and accountable manner. Texture has nothing to gain by operating the club poorly. This will only result in patrons who do not feel safe and do not want to attend the club. Further, as most if not all members of the Common Council are aware, Texture's owners are involved in other business ventures throughout the City of Milwaukee and they are from the area. Texture's owners have no desire other than to operate a well-respected, well-run business as they know that their failure to do so will only negatively affect their ability to continue being successful in all of their ventures. Further, Texture has proven that it can and will continue to improve its operations every The Committee complemented Texture at its 2010 hearing for the improvements that it had made from the prior year. Despite comments to the contrary at the 2011 hearing, the record shows that Texture operated with significantly less problems in 2010-2011 than it had the prior year. At its 2010 hearing, the Committee considered 13 items on Texture's Synopsis, while at its 2011 hearing the Synopsis was composed of only 5 items, 2 of which should have been struck as they had nothing to do with patrons of the establishment.
- 6. The Licenses Committee has failed to forward *its own* report and recommendation, including Findings of Fact, Conclusions of Law, and a recommendation to the Common Council as required by § 90-11-2-c-2, Milwaukee Code of Ordinances.
 - Paragraph 5 of the Findings states that "Based upon the testimony heard and evidence received, the <u>Committee makes the following findings of fact</u>" [emphasis added]. Texture objects to this statement, as the Committee has never adopted these findings. Because the Findings of Fact and Conclusions of Law were never adopted by the Committee, it would be more properly characterized as the City Attorney's proposed Findings of Fact and Conclusions of Law.
- 7. The City of Milwaukee's treatment of numerous other establishments, including its treatment of Pizza Shuttle at its license renewal hearing held on January 27, 2009, demonstrates that Texture's Equal Protection rights as guaranteed under the United States Constitution were violated.
 - Attached hereto and incorporated herein are police reports for establishments known as Quarters (hearing on 6/2/10), Discount Cigarettes & Beer (hearing on

5/10/10), and Bosses Lounge (hearing on 4/20/10).

Quarters is a tavern located on Center Street. It had three new items on its police report (a fourth item was included but this item consisted of a summary of a meeting between MPD, the tavern owner, and the tavern's attorney). These incidents included a citation for patrons dancing when there was no tavern dance license, a shots fired complaint, and *a murder*. The murder occurred in front of the tavern with the victim having received multiple wounds to the head and back. MPD determined through the tavern's surveillance cameras that the victim and suspect were both at the tavern and left shortly before the murder occurred. This video also showed that the suspect had been armed while inside the tavern. Quarters' license was recommended for renewal by the Committee with a 30-day suspension.

Discount Cigarettes & Beer is located on 27th Street. It had four new items on its police report. These incidents included a citation for sale to underaged, an allegation of sale to underaged, a second citation for sale to underaged, and a third citation for sale to underaged. Discount Cigarettes & Beer's license was recommended for renewal by the Committee with a 30-day suspension.

Bosses Lounge is located on North Avenue. It had six new items on its police report. These items included a battery complaint, an incident in which an individual drove by the tavern and waived a gun out the vehicle window, two false hold up alarms, a fight that occurred between patrons after leaving the bar, a citation for presence of underaged, and a shooting incident in which <u>five people</u> were wounded. Bosses Lounge's license was recommended for renewal by the Committee with a 20-day suspension.

On January 27, 2009, the Licenses Committee held a hearing to consider the renewal of Pizza Shuttle, 1827 N. Farwell Avenue. Pizza Shuttle had an extensive police report. Attached to this letter is a copy of Pizza Shuttle's police report. Pizza Shuttle's report contained a total of 26 items, including 25 from 2008. In addition, Pizza Shuttle's CADS reports, obtained through the MPD, show that there were approximately 100 police calls related to the establishment between November 2007 and January 2009. There are numerous incidents in the Pizza Shuttle report that presented valid cause for concern. For example, the report recounts numerous fight complaints, numerous issues with guns, complaints of loud music from cars, cars being used to block traffic, disorderly patrons, and drugs. In fact, incident No. 24 on Pizza Shuttle's police report required the MPD to be on scene for almost two hours, involved multiple fights and also involved hundreds of patrons who were spectators and encouraged the Incident No. 24 states at its conclusion, "Police did speak with management regarding the volume of calls received by the restaurant and that no other businesses in the area have needed this type of police response."

In spite of this extensive police report, the MPD did not object to renewal of the

license and the City Attorney's office made no appearance at the hearing to oppose the license renewal or assist the MPD. It is also remarkable that despite the high volume of police calls to Pizza Shuttle, the property received no nuisance letters from the City of Milwaukee.

As stated *supra*, Pizza Shuttle had 25 items on its police report that were considered at the 2009 hearing. In reviewing this police report (which is also attached), 24 of the incidents occurred between February and July. The 25th and final incident occurred on October 18th, and was a situation in which juveniles were "trashing" the dining room and yelling obscenities. Pizza Shuttle's license was renewed with a warning letter.

- 8. Texture objects to the 30-minute time limit enforced by Chairman Bohl pursuant to § 90-11-2-b-2-g, Milwaukee Code of Ordinances. This time limit is not enforced equally to all parties during contested hearings and the enforcement scheme also changes from hearing to hearing. This time limit is inappropriate and a violation of Texture's rights as it does not allow licensees with sufficient time to adequately address all allegations made against its License, an item in which Texture has a recognized, protected property interest. The 30-minute time constraint and its inconsistent enforcement violate Texture's right to both due process and equal protection.
- 9. On November 23, 2011, the Common Council considered the renewal application of Scooters Pub & Dukes On Water ("Dukes") located at 150-58 E. Juneau Avenue in the 3rd Aldermanic District. Dukes had four items on its Synopsis, three of which were used as a basis for the Committee's recommendation for renewal of Dukes' license with a 10-day suspension. Enclosed is a copy of Dukes' Synopsis. Ultimately, the Council renewed Dukes' license with only a warning letter. The three items relied upon for the recommendation were three fights, two of which resulted in injuries (a broken nose and a head wound).

As described above, while Texture had five items on its Synopsis, two of those items have been conclusively proven to not be connected to patrons of the establishment, leaving Texture with what should have been three incidents on its Synopsis. The three remaining incidents on Texture's Synopsis were an incident in which security had to remove two patrons who refused to leave the premises after closing, a fight for which video shown at Committee proved was quickly under control, and a situation in which a group of patrons waiting in line after the club was at capacity were disbursed by police. Unlike Dukes, none of Texture's three remaining incidents involved injuries, and only one was a fight.

Based upon the past practice and conduct of the Common Council in the Dukes matter and based upon the precedent set in the Pizza Shuttle matter referenced above (wherein Pizza Shuttle had 25 items on its Synopsis and received a warning letter), Texture's right to equal protection requires that its License be renewed without suspension, and only a warning letter.

10. That prior to the June 21, 2011 Committee hearing, Texture submitted several public records requests to the Milwaukee Police Department. Attached hereto and incorporated herein are these public records requests.

On June 2, 2011, Salvatore Safina, a member of Pop Promotions, LLC d/b/a Texture, submitted a public records request in which he requested any and all tavern reports and/or PA-33s as well as all CADS reports relating to Texture. The time frame for Mr. Safina's request was July 26, 2010 through June 2, 2011. In response to his request, Mr. Safina received all documents except for CADS #10-249-0191 which is the CADS report that is referenced in the PA-33 for the September 6, 2010 incident which was included on the Synopsis and used as a basis for the Committee's recommendation of non-renewal. Based upon Mr. Safina's public records request, CADS #10-249-0191 was a responsive record that the Milwaukee Police Department had a duty to produce. The Milwaukee Police Department's failure to produce this record resulted in Texture not being able to fully prepare its case before the Committee.

On June 16, 2011, Texture's legal counsel submitted a public records request which requested copies of any and all Incident Reports that were related to the PA-33s which were related to the new items on Texture's Synopsis. In response to this request, the Milwaukee Police Department only produced one Incident Report and this lone report was related to the incident that occurred on March 6, 2011. All PA-33s are written based upon actual Incident Reports and therefore an Incident Report exists for each and every one of the five PA-33s and Synopsis Items. The Incident Reports provide significantly more detail than the PA-33s and allow for licensees such as Texture to better and more fully prepare to defend the protected property interest they have in renewal of their licenses. Milwaukee Police Department represented to Texture that except for the March 6, 2011 Incident Report that there were allegedly no other Incident Reports that related to the four other PA-33s. There are four other Incident Reports relating to the 9/6/10, 3/14/11, 3/28/11, and 4/2/11 incidents and the Milwaukee Police Department has failed to provide those reports to Texture as required by law. The Milwaukee Police Department's failure to produce these records resulted in Texture not being able to fully prepare its case before the Committee.

Because of the Milwaukee Police Department's failure to comply with the public records law and the ensuing damages caused to Texture as a result, equity requires that the matter of Texture's License be remanded back to the Committee for a new hearing which can commence at such time that all public records have been provided to Texture as requested.

Texture's rights to Due Process and Equal Protection have been violated by the actions of the City of Milwaukee. As explained above, Texture's business operations in 2010-2011 require that the City of Milwaukee renew its License with the issuance of only a warning letter.

3. On 02//17/10 at 1:30 am, Milwaukee police conducted a License Premise Check at 900 E Center Street. Officers observed approximately twelve patrons dancing on the dance floor and found the tavern not to have a tavern dance license. Police spoke to the bartender Cherissa Fischer who stated she was also co-owner of the tavern. - 4. On 03/20/10 at 1:21 am, Milwaukee police were dispatched to 900 E Center for a Shots Fired complaint. An anonymous caller stated shots had been fired inside the Quarters tavern. Police spoke to the bartender Cherissa Fischer who stated there were no shots fired but that two patrons were arguing with one another and were escorted out of the bar. Police did not find any evidence supporting shots being fired. Call was advised.
- 5. On 03/28/10 at 1:50 am, Milwaukee police were dispatched to Bremen and Center for a Shooting complaint. Arriving officers observed a male lying on the ground in front of Quarters tavern with multiple gun shot wounds to the head and back. The victim later died from his wounds. Officers questioned the bartender Cherissa Fischer if the victim had been in the tavern prior to the shooting and Fischer stated no. Fischer further stated that she heard shots phone. Upon viewing the bar's surveillance video, police determined that the victim and suspect were both patrons in the bar and were observed leaving the tavern shortly before the armed while inside the bar. Five casings were recovered at the scene and place on inventory.
- 6. On 03/29/10 at 2:15 pm, the owner of Quarter's Night Club, Daniel Fischer, and his attorney Andy Arenas, met with District Five personnel regarding the homicide that occurred outside of his business. The meeting took place at District Five and in attendance was Assistant City Attorney Adam Stevens, Assistant City Attorney Ben Wesson, Lieutenant Michael Brunson as Well as a few police officers. Mr. Fischer relayed that his business is open on Wednesdays, Fischer stated he tries to shut down the tavem approximately one hour prior to closing time. Fischer further stated that he has 4 to 5 employees and that two of his children help manage three to fives dollars for a cover charge and that he has two interior cameras, one of which is that he monitors the tavern from his residence, which is the upper portion of the tavern. Fischer stated that up to a month ago, his crowd was generally neighborhood individuals, however due faces.

***************************** 2. On 07/30/09 at 11:17 am, Milwaukee police were dispatched to 2725 W Auer Street for a Battery complaint. Officers spoke to the victim who stated he and friend were at Bosses Lounge when the victim noticed a known patron "mean mugging" him. This patron then came up to the victim and started punching him in the face and head area. The victim stated the suspect was demanding his wallet but that he (the victim) refused to give it up. The victim stated he then heard the suspect tell another guy to get the victims wallet and felt someone going through his pockets. The victim then fell to the ground and where he was kicked several more times. The suspects obtained the victim's wallet and cell phone and fled the bar. Officers on a later date contacted and spoke to Tommy Harris regarding the incident. Harris stated he was working the night of the incident and wasn't aware of any problems. Officers also spoke to the bartender Rebecca Moses, who is no longer employed at Bosses. Moses stated she couldn't recall the incident and that there have been so many fights inside the bar, she can't remember one incident from the other. The suspect was ordered into the DA's office regarding possible charges. As of 01/28/10, a check of CCAP revealed no charges were issued.

- 3. On 10/30/09 at 1:29 am, Milwaukee police were dispatched to 408 E North Avenue for a Man With Gun complaint. Officers spoke to Michael Williams who stated he works security for Bosses Lounge and that he observed a late model black Infiniti pull up in front of the tavern as a subject waved a gun from the passenger side window. Squads that were in area found a car matching the description and conducted a traffic stop with no gun being found. A wanted to the district.
- 4. On 11/05/09 at 1:25 am, Milwaukee police were dispatched to 408 E North Avenue for a Hold Up Alarm. Officers spoke to Tommy Harris who stated there were several females fighting across the street from the bar and that one of his employees might have pushed the hold up alarm. Harris stated the females left before police arrived.
- On 12/26/09 at 2:31 am, Milwaukee police were dispatched to 408 E North Avenue for a Hold Up Alarm. Officers spoke to the bartender Kamona Dixion who stated there were no problems.
- 6. On 01/14/10 at 12:41 am, Milwaukee police were dispatched to 2244 N Buffum Street for a Fight complaint. Upon police arrival, officers observed a large fight/argument in the vicinity of North and Buffum. Officers stopped one of the actors and conducted a field interview. Police found this subject to be in possession of .38 special Smith & Wesson and placed the actor under arrest. The suspect stated to police that there was no fight going on just a verbal argument with a couple of people after leaving the tavern located at 407 E North.
- 7. On 01/21/10 at 1:27 am, Milwaukee police were dispatched to 400 E North Avenue for a Shooting comptaint. Upon arrival, officers found a victim who was shot to the back. The victim, who is under the age of 21, stated he was at Bosses when he got into a fight. The victim further stated as he was leaving the tavern, he heard gunshots and then felt pain to his lower back. Officers were able to confirm the victims' presence in the tavern by viewing video that was recorded by the tavern. A house located at 2244 N Buffum was also struck by gunfire as four occupants were sleeping inside. Officers interviewed a resident resident further stated that there are problems at Bosses Lounge every Wednesday night. The licensee Tommy Harris was cited for Presence of Underage.

Police spoke with a patron who stated his sister was punched by a security guard while inside the tavern. Officers spoke to the security guard who was identified as Gilbert Abdullah. Abdullah stated that a female patron was arguing with another patron when Abdullah asked this patron to leave.
