- 1. Gurjapbir S. Kahlon Donald R. Jackson (hereinafter the "Licensee") is the holder of a Public Passenger Vehicle Driver license in the City and County of Milwaukee, Wisconsin. Said license expires at midnight, October 31, 2011.
- 2. An application to renew said license was filed with the Office of the City Clerk on July 28, 2011.
- 3. Pursuant to Chapter 100 of the Milwaukee Code of Ordinances and § 349.24 of the Wisconsin Statutes, the matter was referred to the Milwaukee Police Department for investigation. The Milwaukee Police Department filed a police report dated July 29, 2011. That report could form the basis of non-renewal or suspension of this license.
- 4. On August 18, 2011, the City Clerk's Office provided timely notice to the Licensee, pursuant to Chapter 100 of the Milwaukee Code of Ordinances and § 349.24 of the Wisconsin Statutes of a police report that could form the basis for suspension or non-renewal of the license of the licensee and included therewith a copy of the Milwaukee Police Department report. The matter was scheduled for a hearing on the police report on September 14, 2011 at 9:00 a.m. in Room 301B of City Hall. At said date, time and place, the licensee did appear and was not represented by counsel.
- 5. Based upon the sworn testimony heard and the evidence received at the hearing, the Committee finds the following:
  - A. On October 7, 2009 the License Investigation Unit received an e-mailed complaint forwarded from the License Division. The complaint was in letter form from Joseph Sanfelippo of Joe Sanfelippo Cabs, Inc.

The letter related that the applicant leased a taxicab from Joe Sanfelippo Cabs, Inc. and that he is the only person authorized to operate that taxicab. On October 3, 2009 Michael Sanfelippo observed Jasdeep Nat drop off a passenger at a grocery store in Milwaukee in the taxicab leased by the applicant.

On October 28, 2009 an officer of the Milwaukee Police Department interviewed the applicant regarding the allegation. The applicant denied allowing Jasdeep Nat use of the taxicab, stating he must have taken it while he was sleeping. The applicant was cited for subleasing taxicab prohibited. On June 24, 2010, the case was set for trial in Milwaukee Municipal Court, Branch 2. The case was dismissed without prejudice as witnesses Michael and Joseph Sanfelippo did not appear.

- B. On March 16, 2010, an officer of the Milwaukee Police Department observed the applicant operating a taxicab not licensed in the Cit of Milwaukee, picking up a passenger at 2450 West Galena. The applicant stated he owns this taxicab and works for American Logistics. He picked up a transit plus passenger to take her to the bank. The applicant was issued a citation for public passenger vehicle permit required and found guilty on this citation on May 4, 2010 and fined \$374.00.
- C. On August 22, 2010, an officer of the Milwaukee Police Department observed the applicant operating a taxicab at 1721 West Canal Street. The applicant did not have a daily safety checklist filled out for that day or any customer complaint forms in the vehicle. The applicant was issued a citation for daily safety checklist required and was found guilty on October 12, 2010 and fined \$125.00. The applicant was issued a citation for complaint forms required but there is no record at Municipal Court of this citation.
- D. On February 18, 2011, an officer of the Milwaukee Police Department observed the applicant operating a taxicab at East Wisconsin Avenue and North Broadway. The officer observed that the applicant did not stop for a yellow traffic light when he had time to do so. The applicant was issued a citation for violating yellow traffic signal and was found guilty on April 29, 2011 and fined \$108.00.

## CONCLUSIONS OF LAW

1. The Committee has jurisdiction to hold hearings and provide Findings of Fact and Conclusions of Law and a Recommendation to the full Common Council pursuant to Chapter 100 of the Milwaukee Code of Ordinances and § 349.24, Wisconsin Statutes.

- 2. Based upon the above facts found, the Committee concludes that the licensee, Gurjapbir S. Kahlon, has not met the criteria of Chapter 100 of the Milwaukee Code of Ordinances or § 349.24 of the Wisconsin Statutes to allow renewal of his Public Passenger Vehicle Driver license without undergoing a ten (10) day suspension based upon the police report and driving record.
- 3. In order to protect the health, safety and welfare of the citizens of the City of Milwaukee, it is the recommendation of the Public Safety Committee that the full Common Council of the City of Milwaukee should exercise its judgment to renew the Public Passenger Vehicle Driver license held by Gurjapbir S. Kahlon with a ten (10) day suspension based upon the police report.

## RECOMMENDATION

Based upon the Findings of Fact and Conclusions of Law stated above, the Committee by vote of three (3) ayes and two (2) noes recommends that the Public Passenger Vehicle Driver license of Gurjapbir S. Kahlon be renewed with a ten (10) day suspension based upon the police report.

Said suspension is to be in effect from the date of the Common Council hearing of October 11, 2011 and for ten days thereafter.


