You are hereby notified that the Milwaukee Common Council will hold a hearing on Wednesday, November 2, 2011, commencing at 9:00 a.m., or as soon thereafter as this matter may be heard, in the Common Council chambers on the third floor of City Hall, 200 East Wells Street, Milwaukee, Wisconsin to consider whether to renew, renew with a suspension between 10 and 90 days, or not renew your Class "D" Bartender's license.

Attached you will find a copy of the Report of the Licenses Committee, which includes its Findings of Fact, Conclusions of Law and Recommendation, recommending nonrenewal of your license based upon your nonappearance. Report on the Renewal Application of the Class "D" Operator

license of Karrie A. Anderson

FINDINGS OF FACT

1. Karrie A. Anderson (hereinafter the "Licensee") is the holder of a Class "D" Operator license in the City and County of Milwaukee, Wisconsin.

2. An application to renew said license was untimely filed with the Office of the City Clerk on July 14, 2011.

3. Pursuant to Chapter 90 of the Milwaukee Code of Ordinances and Chapter 125 of the Wisconsin Statutes, the matter was referred to the Milwaukee Police Department for investigation. On July 15, 2011, the Milwaukee Police Department responded with a police report that could form a basis for non-renewal or suspension of said license.

4. On October 4, 2011, the City Clerk's Office provided timely notice to the licensee pursuant to Chapter 90 of the Milwaukee Code of Ordinances and Chapter 125 of the Wisconsin Statutes of the report of the Milwaukee Police Department and included therewith a copy of the Milwaukee Police Department report. The matter was scheduled for a hearing on the Police Department report on October 17, 2011, commencing at 1:30 p.m. in Room 301B of City Hall. At said date, time, and place, the licensee did not appear and she was not represented by counsel.

5. Based upon the sworn testimony heard and the evidence received at the hearing, the Committee finds the following:

A. A notice of the hearing as well as a copy of the police report was sent to Karrie A. Anderson at 2004 North 49th Street, Milwaukee, Wisconsin 53208 on October 4, 2011 by U.S. prepaid first-class mail in an envelope bearing the return address of the License Division. The address of 2004 North 49th Street, Milwaukee, Wisconsin 53208 is the address given by the

licensee on her application. The envelope was not returned to the License Division by the United States Postal Service. The licensee failed to appear at the hearing on October 17, 2011.

CONCLUSIONS OF LAW

- 1. The Committee has jurisdiction to hold hearings and provide Findings of Fact and Conclusions of Law and a Recommendation to the full Common Council pursuant to Chapter 125 of the Wisconsin Statutes and Chapter 90 of the Milwaukee Code of Ordinances.
- 2. Based on the above facts found, the Committee concludes that the licensee, Karrie A. Anderson, has not met the criteria of Chapter 125 of the Wisconsin Statutes or Chapter 90 of the Milwaukee Code of Ordinances to allow renewal of the Class "D" Operator license based upon nonappearance.
- 3. In order to protect the health, safety, and welfare of the citizens of the City of Milwaukee, it is the recommendation of the Licenses Committee that the full Common Council should exercise its discretion to not renew the Class "D" Operator license held by Karrie A. Anderson based upon nonappearance.

RECOMMENDATION

Based upon the Findings of Fact and Conclusions of Law stated above, the Committee, by a vote of four (4) ayes and zero (0) noes, recommends that the Class "D" Operator license not be renewed based upon nonappearance.

Re: Report of the Renewal Application of Barry T. Henley, agent for "Working Class, LLC" for a Class "B" Tavern license for the premises located at 1816 West Fond Du Lac Avenue in the City

and County of Milwaukee, Wisconsin ("Working Class").

FINDINGS OF FACT

1. Barry T. Henley (hereinafter the "Licensee"), agent for "Working Class, LLC," is the holder of a Class "B" Tavern license for the premises located at 1816 West Fond Du Lac Avenue in the City and County of Milwaukee, Wisconsin ("Working Class"). Said license expires at midnight, November 5, 2011.

2. An application to renew said license was filed with the Office of the City Clerk on September 7, 2011.

3. Pursuant to Chapter 90 of the Milwaukee Code of Ordinances and Chapter 125 of the Wisconsin Statutes, the matter was referred to the Milwaukee Police Department for investigation. The Milwaukee Police Department responded with a report that could form the basis of nonrenewal or suspension of this license on September 14, 2011.

4. On October 5, 2011, the City Clerk's Office provided notice to the licensee pursuant to Chapter 90 of the Milwaukee Code of Ordinances and Chapter 125 of the Wisconsin Statutes of the police report that could form the basis for nonrenewal or suspension and included a copy of the police report. The matter was scheduled for a hearing on the police report and neighborhood objections on October 17, 2011 at 9:45 a.m. in Room 301B of the third floor of City Hall. At said date, time, and place, the licensee did appear and was not represented by counsel

5. Based upon the sworn testimony heard and the evidence received at the hearing, the Committee finds the following:

A. On January 22, 2011, licensee received two citations for sidewalks to be kept clean and smoking in city building at 1618

West Fond Du Lac. The licensee was found guilty of sidewalks to be kept clean on March 24, 2011 and fined \$40.00. Licensee was found guilty smoking in city building on March 24, 2011 and fined \$100.00.

- B. On April 3, 2011 at 12:45 a.m., Milwaukee police conducted a license premise check at 1816 West Fond Du Lac Avenue. During the premise check it was determined the establishment had underage patrons, one of which was only 16 years of age. Police could also smell an odor of marijuana and observed several ashtrays scattered about the bar filled with ashes and some blunt wrappers. Police spoke with the licensee, Barry Henley, who stated that his lawyer told him that underage persons were allowed to be on the premise as long as they were not served any alcohol. When asked in regards to not checking the ID cards of the underage patrons, Henley stated, "They must have snuck in." A premise check was also conducted on April 17th at 12:30 a.m. with more underage patrons found inside the tavern. Henley was issued a citation for A&A presence of minor on premise and found guilty and fined \$175.00 on May 25, 2011. Licensee was issued a citation for smoking prohibited and found guilty and fined \$60.00 on May 25, 2011.
- C. On May 29, 2011 at 12:45 a.m., licensee received a citation for allow underage on premises at 1816 West Fond Du Lac Avenue. Licensee was issued a citation for allow underage on premises and found guilty on August 5, 2011 and fined \$220.00.
- D. On July 3, 2011, at 1:45 a.m., Milwaukee police were investigating a recklessly endangering safety complaint and conducted a follow up at North 18th Street and West Fond Du Lac to locate a scene. A bullet hole was observed through the window of the Working Class bar. Attempts were made to contact the licensee, Barry Henley, which met with negative results. Officers who were at the hospital with the shooting victim interviewed him. The victim stated that was he was inside the bar with family and friends when two groups of people were escorted out of the bar by security for fighting. The victim indicted that when the owner, Barry Henley, called last call, he ordered another beer. The victim further stated that both groups of people were still outside in front of the bar when he heard sounds of gunshots coming from the front of the tavern. The victim then stated he felt pain to his right leg. The victim was treated for a gunshot wound to his right inner thigh. On July 17, 2011, police conducted a follow up regarding the investigation and spoke with Barry Henley. Henley stated that at approximately 1:15 a.m. on July 3rd, he was outside in the back of the bar when he heard several gunshots. Henley stated he took cover for approximately 5 minutes before he walked back inside the bar and discovered that all patrons left. Henley further stated he was unaware that anyone had been shot. Henley stated he then

closed up the bar and left. The bar did not have video surveillance cameras.

CONCLUSIONS OF LAW

- 1. The Committee has jurisdiction to hold hearings and provided Findings of Fact and Conclusions of Law and a Recommendation to the full Common Council pursuant to Chapter 125 of the Wisconsin Statutes and Chapter 90 of the Milwaukee Code of Ordinances.
- 2. Based upon the above facts found, the Committee concludes that the licensee, Barry T. Henley, agent for "Working Class, LLC," who holds a Class "B" Tavern license for the premises located at 1816 West Fond Du Lac Avenue in the City and County of Milwaukee, Wisconsin ("Working Class") has not met the criteria of Chapter 90 of the Milwaukee Code of Ordinances together with the police report and neighborhood objections to allow renewal of his license without undergoing a ten (10) day suspension. The Committee finds the police report as stated above to be true.
- 3. In order to protect the health, safety, and welfare of the citizens of the City of Milwaukee, it is the recommendation of the Licenses Committee that the full Common Council of the City of Milwaukee should exercise its judgment to renew the Class "B" Tavern license of Barry T. Henley, agent for "Working Class, LLC," for the premises located at 1816 West Fond Du Lac Avenue in the City and County of Milwaukee, Wisconsin ("Working Class") with a ten (10) day suspension based upon the police report.

RECOMMENDATION

Based upon the Findings of Fact and Conclusions of Law stated above, the Committee, by a vote of three (3) ayes and two (2) noes, recommends that the Class "B" Tavern license held by Barry T. Henley, agent for "Working Class, LLC," for the premises located at 1816 West Fond Du Lac Avenue in the City and County of Milwaukee, Wisconsin ("Working Class") be renewed with a ten (10) day suspension based upon the police report.

Said suspension is to be in effect between 12:01 a.m. November 6, 2011 through midnight, November 15, 2011.
