Dear Ms. Robinson:


We have received your claim in the amount of \$7,243.76, relating to damage to your car on August 2, 2011 when you allege that the front left bumper was struck by a passing large yellow DPW truck while it was parked at 4881 North 18th Street.

Our investigation reveals that the Fleet Accident Report completed as a result of this alleged incident notes that the damage on your vehicle appears to be old. There was also no paint transfer on your vehicle. In addition, there were only two DPW trucks working in the area of North 18th Street on this day. There was no paint transfer on them. Finally, both drivers deny causing the damage. There is no evidence to support your belief that a large yellow DPW truck caused the damage. As such, the City cannot accept liability. Therefore, we are denying your claim.

If you wish to appeal this decision, you may do so by sending a letter within 21 days of the receipt of this letter to the Milwaukee City Clerk, 200 East Wells Street, Room 205, Milwaukee, Wisconsin 53202, requesting a hearing.
