SUBJECT: Additional Changes to 2012 Salary Ordinance Part I & II

Attached please find a list of recommended changes to the Salary Ordinance. The changes have been identified and recommended as a result of our ongoing review of the Ordinance. Many of these changes include the deletion of obsolete titles and footnotes and an explanation is included next to each item.

- 1. Change all Pay Range designations in Part I to 3 digits. A Pay Range ending in X will indicate that titles are exempt under the Fair Labor Standards Act (FLSA) and are not eligible to receive overtime. A Pay Range ending with an N indicates that a title is non-exempt under FLSA and is eligible to receive overtime.
- 2. Delete the title of Snow Driver in PR 8IN and in lieu of this create a task rate for Snow Driver in Part II, Sec 11. Supplemental Pay Practices.

Snow Driver Pay: An employee holding a title other than Operations Driver, when assigned to salting and plowing operations, will be paid the rate of \$21.91 per hour, if that employee's regular rate of pay is lower.

3. For the following Career Ladder titles in DNS, add the following footnote:

Titles:

- Residential Code Enforcement Inspector
- Commercial Code Enforcement Inspector
- Special Enforcement Inspector
- Environmental Risk Officer

Footnote:

An employee transferred or promoted into this title will be placed in the pay step that corresponds with demonstrated core competencies and certifications. If the employee's prior rate is higher than the appropriate step, the employee will retain their previous rate and will move to the next higher step when they have demonstrated the required core competencies and certifications.

- 4. PR 7CN correct footnote #2 for Building Maintenance Mechanic II this title does not receive the \$6.90 pay for completing supervisory duties during a shift.
- 5. PR 7BN- change title in Footnote 7 to Inventory Control Assistant III the title of Fire Stores Clerk is obsolete.
- 6. PR 4E-Pay Range 856 delete obsolete title of Paramedic Lieutenant remove title from footnote #1.
- 7. PR 4J-Pay Range 857 delete obsolete title of Administrative Captain-EMS from footnote #1
- 8. PR 3BN delete footnote #2 obsolete Engineering Technician I is not assigned to Road Life Work
- 9. PR 3FN delete footnote #2 obsolete Engineering Technician II is not assigned to Road Life Work
- 10. PR 6JN delete obsolete title of Fire Stores Clerk
- 11. PR 8LN Delete obsolete Library Delivery Services Specialist title and correct pay range rates
- 12. PR 7FN Delete obsolete Lead Bookbinder title
- 13. PR 7CN Delete obsolete Bookbinder title
- 14. PR 8HN Delete obsolete Sewer Examiner I title
- 15. PR 8FN Delete obsolete Auto Mechanic Helper title
- 16. For the following titles/footnotes add temporary appointments to the footnote language to so that employees given either an emergency or temporary appointment to a title be paid at the same footnoted rate. This is in lieu of receiving the regular promotional rate of 5%.
