Dear Council Members:

We return the enclosed document which has been filed with the City Clerk and ask that it be introduced and referred to the Committee on Judiciary & Legislation with the following recommendation.

Claimant, Transinternational Systems, Inc., alleges through North American Risk Services, by its representative Lori Grabias, P.O. Box 166002, Altamonte Springs, FL 32716-6002, as subrogee, that on May 10, 2012 they sustained damages when their insured's large truck hit a low hanging branch from a City tree at South 5th Street and West Howard Avenue. They claim damages in the amount of \$8,283.78.

Our investigation reveals that the Forestry Section records indicate that on May 10, 2012 they received a service request for a tree down blocking the road at 500 West Howard Avenue. The responding crew found that a large limb over the roadway had been ripped off the main trunk of the 24-inch diameter Norway maple tree located in the City right-of-way at 500 West Howard Avenue. The tree damage was caused by a semi-trailer impacting the tree limb at the curb/parking lane. The tree was healthy and had some internal decay that became visible after this impact. The damage to the tree was substantial and required the removal of the tree.

Forestry also reviewed their records for the last 6 years and found no notice of potential hazardous conditions or service requests for this tree. The trees in this area are on a regular pruning schedule and were last pruned in December, 2006. All City tree branches are pruned to a height of at least 14 feet, the Section guideline, where they enter over the roadway traffic lanes. This guideline is not subject to parking lanes. The operator of a vehicle has the ultimate responsibility of look out and management.
