

Re: Report on the Renewal Applications of John R. Shemitis, Agent for "Whiskey River Saloon –Milwaukee, LLC," for Class "B" Tavern and Public Entertainment Premises Licenses for the premises at 1023-27 North Old World Third Street in the City and County of Milwaukee, Wisconsin ("Irish Rec Room")

- 1. John R. Shemitis, Agent for "Whiskey River Saloon Milwaukee, LLC" (hereinafter the "licensee"), is the holder of a Class "B" Tavern and Public Entertainment Premises Licenses for the premises located at 1023-27 North Old World Third Street in the City and County of Milwaukee, Wisconsin.
- 2. Applications to renew said licenses were filed with the Office of the City Clerk on November 8, 2012.
- 3. Pursuant to Chapters 90 and 108 of the Milwaukee Code of Ordinances, the matter was referred to the Milwaukee Police Department for investigation. On November 9, 2012, the Milwaukee Police Department responded with a police report which could form the basis of non-renewal or suspension of said licenses.
- 4. On November 20, 2012, the City Clerk's Office provided notice to the licensee pursuant to Chapters 90 and 108 of the Milwaukee Code of Ordinances and Chapter 125 of the Wisconsin Statutes, of the police report and neighborhood objections and included a copy of the police report and neighborhood objections. The matter was scheduled for a hearing on December 3, 2012 at 10:00 a.m. in Room 301B of the third floor of City Hall. At said date, time, and place, the licensee appeared and admitted to service of the notice. He was not represented by counsel.
- 5. Based upon the sworn testimony heard and the evidence received at the hearings, the Committee finds the following:
 - A. On April 17, 2012, the applicant was issued a citation at 1023 North Old World Third Street for underage consumption of alcohol on Class "B" premises. He was found guilty on June 15, 2012 and fined \$100.00.



- B. On April 18, 2012, the applicant was issued a citation at 1023 North Old World Third Street for disorderly premises prohibited. He was found guilty on this citation on June 15, 2012 and fined \$200.00.
- C. Jacob Dehne, 6923 West Wisconsin Avenue, owner of neighboring establishment Buckhead Saloon, testified in opposition because the bar deviated from its original plan of operation and rents out its bar to promoters that host disorderly functions.
- D. Edward A. Stray, 1009 North Old World Third Street, testified that the premise is not a full scale restaurant, DJs bring in violent crowds, loitering occurs outside the business at the back alley, all you can drink events occur, there are drunk patrons, the owner does not open at 11:00 a.m. as the plan of operation indicates, and the bar only operates on Thursday, Friday and Saturday.
- E. Stacie Callies, 633 West Wisconsin Avenue, on behalf of the Westown Association, testified in opposition due to the bar's deviation from its plan of operation. Mr. Shemitis wrote that the business would be a country bar with live music, serving lunch, open every weekday, would refrain from utilizing event promoters, and have Mr. Shemitis managing the bar on a daily basis. The bar does not serve lunch, is now an Irish sports bar, does not have Mr. Shemitis as the daily manager, and has used event promoters. Ms. Callies has personally observed the bar not being open from Monday to Tuesday on two occasions but could not remember exactly when. The association has received complaints from neighboring businesses and the police department regarding the disorderly behavior, loitering, and fighting caused by patrons of the bar.
- F. Mr. Shemitis gave testimony. The business does not serve lunch as originally planned. He is not there everyday but is hands-on with many operations. There have been event bookings with and without his knowledge. Event planners and promotions have occurred but some were done without his knowledge by the previous management team. Mr. Vecitis was recently hired to head the management team. Staff and the kitchen are being changed so that food can be served going forward. The business is open six days a week.
- G. Mr. Vecitis testified that he has been the new manager for ten days, the business had been recently shut down for two weeks between Monday and Wednesday for renovation, erroneous social media promotions will be removed, and future booked events have or will be cancelled.
- H. Alderman Robert Bauman expressed concerns of deviation from the original business plan of a restaurant, which was to open at 11:00 a.m. and serve lunch during the daytime. Operating during the daytime by this premise was important to help daytime business activity. Alderman Bauman opposed the renewal of the license due to neighborhood testimony, deviation from the plan of operation, subleasing of the bar, nuisance behavior of patrons, and the police report.

CONCLUSIONS OF LAW

- 1. The Committee has jurisdiction to hold hearings and provide Findings of Fact, Conclusions of Law and a Recommendation to the full Common Council pursuant to Chapters 85, 90, and 108 of the Milwaukee Code of Ordinances.
- 2. Based upon the above facts found, the Committee concludes that the licensee, John R. Shemitis, Agent for "Whiskey River Saloon Milwaukee, LLC," has not met the criteria of Chapters 85, 90, or 108 of the Milwaukee Code of Ordinances to allow renewal of the Class "B" Tavern and Public Entertainment Premises Licenses. The Committee finds the police report, neighborhood objections, and deviation from the plan of operation, as stated above, to be true.
- 3. In order to protect the health, safety, and welfare of the citizens of the City of Milwaukee, it is the recommendation of the Licenses Committee that the full Common Council of the City of Milwaukee should exercise its discretion to not renew the Class "B" Tavern and Public Entertainment Premises Licenses held by John R. Shemitis, Agent for "Whiskey River Saloon Milwaukee, LLC," for the premises located at 1023-27 North Old World Third Street in the City and County of Milwaukee, Wisconsin based upon the police report, neighborhood objections, and deviation from the plan of operation.

RECOMMENDATION

Based upon the Findings of Fact and Conclusions of Law stated above, the Committee, by a vote of three (3) ayes, one (1) no, and one (1) abstention, recommends that the Class "B" Tavern and Public Entertainment Premises Licenses held by John R. Shemitis, Agent for "Whiskey River Saloon – Milwaukee, LLC," for the premises located at 1023-27 North Old World Third Street ("Irish Rec Room") not be renewed based on the police report, neighborhood testimony, and deviation from the plan of operation.



Re: Report of the Renewal Applications of Lyle A. McDowell for Class "B"

Tavern and Public Entertainment Premises Licenses for the premises located at 3478 North 2nd Street in the City and County of Milwaukee,

Wisconsin ("Club 2-C").

- Lyle A. McDowell (hereinafter the "licensee") is the holder of Class "B" Tavern and Public Entertainment Premises Licenses for the premises located at 3478
 North 2nd Street in the City and County of Milwaukee, Wisconsin ("Club 2-C").

 Said licenses expire at midnight, December 20, 2012.
- Applications to renew said licenses were timely filed with the Office of the City Clerk on November 28, 2012.
- 3. Pursuant to Chapter 90 of the Milwaukee Code of Ordinances and Chapter 125 of the Wisconsin Statutes, the matter was referred to the Milwaukee Police Department for investigation. The Milwaukee Police Department responded with a report that could form the basis of non-renewal or suspension of said licenses on November 28, 2012.
- 4. On November 27, 2012, the City Clerk's Office provided notice to the licensee, pursuant to Chapter 90 of the Milwaukee Code of Ordinances and Chapter 125 of the Wisconsin Statutes, of the police report and neighborhood objections and included a copy of the police report and neighborhood objections. The matter was scheduled for hearings on November 12, 2012 and subsequently on December 3, 2012 at 10:30 a.m. in Room 301B of the third floor of City Hall. At the hearings, the licensee did appear and was represented by counsel, Attorney Michael F. Torphy, 5321 North Port Washington Road, Glendale, WI 53217.
- 6. Based upon the sworn testimony heard and the evidence received at the hearing the Committee finds the following:
 - A. The licensee was found guilty of Presence of Minor/Underage at Licensed Premise on February 29, 2012 and fined \$200.00 of which he still owes \$150.00.



- B. On February 13, 2012 at 7:38 a.m. Milwaukee police were dispatched to an entry complaint at 3478 North 2nd Street. The investigation revealed an actor(s) entered the bar by unknown means and removed money, equipment and bottles of alcohol from the business. Officers spoke with the owner as well as the working bartender that night prior to the entry and obtained their statements. A report was filed.
- C. On June 1, 2012 at 1:32 a.m. Milwaukee police were dispatched to 3478 North 2nd Street for a fight complaint. Police spoke with Lyle McDowell who stated an argument began in the bar between two groups of females at the rear pool table area when it turned physical. McDowell stated he and the bartender escorted all parties outside and did not call police because he though he had the situation under control and because the police quickly arrived on scene. Officers did observe evidence of a disturbance in the pool table area and that everything else in the tavern appeared in order. Two patrons that were involved appeared highly intoxicated and were conveyed via ambulance to a nearby hospital for treatment.
- D. Adrian Spencer-Good, 3475 North 2nd Street, Milwaukee, testified to seeing several brawls in the street involving patrons, calling police to hearing shootings, shootings occurring after the operations of the bar, excessive noise, and underage patrons including her 20 year old daughter. She has called the police several times since September 2012 regarding the brawls and shootings in the area. She believes some of the shootings are spilled over from the activities of the bar. These nuisances have occurred late at night and into the morning near or beyond closing time.
- E. Diane O'Howard, 3460 North 1st Street, Milwaukee, testified that there is excessive noise in the area and that she opposes an increase in hours.
- F. Prudence Holland, 3454 North 3rd Street, Milwaukee, testified that the bar operations have caused parking and general rowdiness to overflow into her block between 2:00 and 3:00 a.m. She added that bar patrons have caused loud noise and speeding especially during the summer by motorcycles. She is against an extension of hours.
- G. Darryl Johnson, 133 West Randolph Street, Milwaukee, testified to overconcentration of alcohol beverage outlets in the area which is primarily residential. He also testified at the last Licenses Committee meeting of November 12, 2012 to bullets flying into his house from a recent homicide incident in the area.
- H. Roosevelt Jenkins and Steven Brown testified in support stating that the drug dealing and shots fired problems are issues of the neighborhood, not the bar.

CONCLUSIONS OF LAW

- The Committee has jurisdiction to hold hearings and provide Findings of Fact and Conclusions of Law and a Recommendation to the full Common Council pursuant to Chapter 125 of the Wisconsin Statutes and Chapter 90 of the Milwaukee Code of Ordinances.
- 2. Based upon the above facts found, the Committee concludes that the licensee, Lyle A. McDowell, who holds Class "B" Tavern and Public Entertainment Premises Licenses for the premises located at 3478 North 2nd Street in the City and County of Milwaukee, Wisconsin ("Club 2-C") has not met the criteria of Chapter 90 of the Milwaukee Code of Ordinances or Chapter 125 of the Wisconsin Statutes to allow renewal of said licenses without undergoing a ten (10) day suspension of said licenses based upon the police report and neighborhood objections.
- 3. In order to protect the health, safety, and welfare of the citizens of the City of Milwaukee, it is the recommendation of the Licenses Committee that the full Common Council of the City of Milwaukee should exercise its judgment to renew the Class "B" Tavern and Public Entertainment Premises Licenses of Lyle A. McDowell for the premises located at 3478 North 2nd Street in the City and County of Milwaukee, Wisconsin ("Club 2-C") with a ten (10) day suspension based upon the police report and neighborhood objections. The Committee finds the police report and neighborhood objections, as stated above, to be true.

RECOMMENDATION

Based upon the Findings of Fact and Conclusions of Law stated above, the Committee, by a vote of four (4) ayes and one (1) no, recommends that the Class "B" Tavern and Public Entertainment Premises Licenses held by Lyle A. McDowell for the premises located at 3478 North 2nd Street ("Club 2-C") be renewed with a ten (10) day suspension based upon the police report and neighborhood objections.

Said suspension is to be in effect between 12:01 a.m. December 21, 2012 through midnight, December 30, 2012.
