PERMANENT UNDERGROUND PIPE LINE EASEMENT AGREEMENT

On March 22, 2012 the parties Milwaukee Metropolitan Sewerage District (MMSD), a municipal corporation, and the City of Milwaukee, a municipal corporation, entered into a Permanent Underground Pipe Line Easement Agreement granting MMSD a permanent 15-foot wide easement over those portions of the Property located at 1600 E. College Avenue and described on Exhibit A (the "Easement Area") and depicted on Exhibit B of the Easement for the operation and maintenance of the underground pipe line already located there. Said easement was approved by the Common Council of the City of Milwaukee by passage of Resolution File No. 111423 adopted on February 28, 2012 and the Milwaukee Metropolitan Sewerage Commission, October 24, 2012, Resolution No. 11-14-2-10. Easement was recorded April4, 2012 with Register of Deeds Milwaukee County, Wisconsin, Doc. #10100955.

WHEREAS, the MMSD is requesting an additional 10-foot wide temporary area along the southerly 200-feet west of and adjacent to the original description to temporarily accommodate the MMSD's PVC pipe connection to the West Shore pipeline as shown on the attached Exhibit "A-1" (legal description) and Exhibit "B-1" (plat map).

The parties agree to the additional 10-foot wide use. All other terms and conditions of the original agreement (dated above) shall remain the same.

LEGAL DESCRIPTION
