We have received your claim for the damage you sustained to your garage door on November 21, 2012.

Our investigation reveals you and your tenant reported damage to the garage door of your property located at 1541 West Highland Avenue in Milwaukee, Wisconsin. You contacted our Fleet Services Department to report the damage and submitted your damage photos via e-mail. The Fleet Services Department inspected the property on November 29, 2012; and at that time the repairs to the garage door had been completed on November 26, 2012. The Fleet Services Department observed the trackless marks went no closer than two feet away from the garage. The damage you are reporting is not consistent with having been hit by a trackless tractor with a leaf rake attachment. Therefore, we are denying your claim.
