Dear Mr. Johnson:

We have received your claim and that of your son totaling \$5,000.00, relating to property damage and injuries allegedly sustained on January 8, 2013 when your vehicle was hit by a Milwaukee Police Department (MPD) vehicle near North 27th Street and West Burleigh Street.

Our investigation reveals that the Wisconsin Motor Vehicle Accident Report completed as a result of this incident notes that the MPD squad car was operating as an emergency vehicle with its lights and siren on. It was traveling eastbound in an alley and stopped when it came to North 27th Street. The officer started to edge out, checking to see if traffic was stopping. You were traveling southbound on North 27th Street, braked and then collided with the squad car. The liability for this accident is upon you. As such, the City cannot accept liability for the damage and injuries allegedly sustained by you and your son. Therefore we are denying your claims. If the City has damages to claim, it may, in some capacity, contact you regarding them.
