I was hit by a 4 foot by 2 inch solid wooden pole by my neighbor. AT the immediate time of the assault there was no mark or pain that I could detect right away to my arm. But further on during the day my arm started throbbing and I took off my coat and shirt and I noticed a pretty good size wound.

I didn't seek medical attention because I couldn't afford it.

My wife was a partial witness and another neighbor was also a partial witness. They didn't see the actual blow but they heard the cursing and banging from the one that struck me.

On Nov. 28th at approximately 11:30 Am., I went to my neighbors garbage can which was in the alley to retrieve a book that was thrown out.

Mr. Leiberman my neighbor came out with a club and tried to hit me in the head but I blocked it with my arm and he smashed my arm.

The police came and refused to investigate or do their duty properly.

I told them I was hit by the club but I wasn't hurting that bad at the moment. They asked me if I wanted medical treatment or an ambulance and I said no I couldn't afford the charges.

A couple of hours later it started to aggravate me and was causing me quite a lot of pain.

I went to the 2nd district police station a couple of hours later and requested that they take a picture of my wound and take the weapon away from my neighbor and to change the ticket that my neighbor received from disorderly conduct to a felony assault and battery on a senior citizen and even make an arrest.

They refused to do all of the above.

This is not the first time I was physically assaulted by this neighbor.

The other time I was sprayed in the face with mace and the officers took away his mace and gave him a state charge of assault and battery.
