
This letter is in response to your February 19, 2013 letter addressing my claim against the Milwaukee Police Department and DOC/DCC staff at the 7<sup>th</sup> district. On Jan. 2<sup>nd</sup> the DOC/DCC staff forced entry into my home for a warrant that was failed to produce and are still failing to produce. Your letter told me to call Daniel Issacson to obtain a copy. After several attempts to gain possession of the warrant I am entitled to write this letter without the proof I need to show you that the warrant was a apprehension warrant and not a search warrant for the police to force entry into my home.

I have made numeral attempts to resolve this issue with the MPD and the DOC/DCC staff. The DOC/DCC staff told me that they didn't need a warrant to enter my home because my son was on supervision at my house, but in the Division of Community Corrections (Operations Manual) it states in 08.03.09, that "**under no circumstances is Forced Entry by DCC staff permitted. If the offender or others are present but are refusing entry, agents should issue an Apprehension Request (DOC-58) and/or inform the occupant of possible prosecution under Wisconsin Statute 946.46. Offenders refusing entry should be detained when apprehended. Law Enforcement personnel have their own guidelines regarding forced entry that may not be altered by DCC direction.**"

The solo purpose for coming to my home in the first place was a VOP (Violation of Parole). No new criminal charges so the police only inquiry at my home was for DCC staff. There was no warrant signed by a judge to enter the home. They did not see him commit a crime and run in the house. The Emp Braclet put him outside of the residence before they arrived. So why would you Still force entry into a unoccupied home. This is a act of criminal prosecution, I on the other hand would just like for my property to be fixed by the parties responsible. I say criminal prosecution because when a gang of people use there position of power to break the law and enter a persons property illegally then it becomes a criminal matter.

I don't know what type of warrant they issued because they wouldn't give me a copy and right now they are covering themselves when they know they wasn't exposed to enter my home like they did. I feel that the City of Milwaukee and the State of Wisconsin do owe 1002.44 for my damaged property. Thank you for your time and consideration.

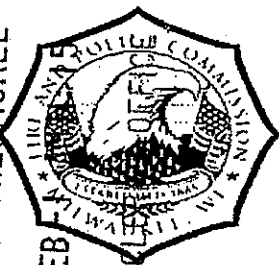

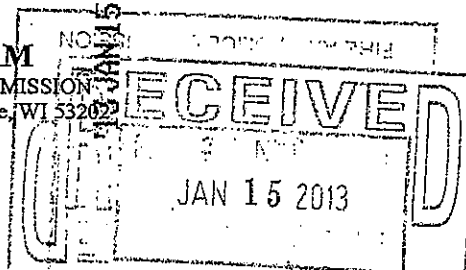

## STATEMENT/DESCRIPTION OF INCIDENT

Describe the incident in detail: The incident began when I received a phone call at 4:45pm from my neighbor (Debra Henry) informing me that the police were going in and out of my home. I work 2nd shift from 1:30-10:00pm at the post office (25yrs.), immediately after getting permission to leave. I arrived at my home too see all the police. (20/30) exiting my home.

Keep in my that my(adult) son Frank Arms was confined to "HOUSE ARREST w/ELECTRONIC BRACELET MONITORING" at my home from 1pm - 9am, therefore I could not be nor was I responsible for his accountability. When MPD Supv Rodney Washington approached me to explain their (maximum presence) that they were looking for my son who was not there as I too discovered.

I asked why they broke into my home. he responded that my son didn't answer the phone so they entered because of it. noone presented me with a "WARRANT" or any other reason why, within (5 mins.) of talking with this officer my son appeared exiting a car when they promptly arrested him and took him away.

At that time I entered my home and noticed right away

my front iron security door pried open then to my anger and disgust discovered (5) doors that all were locked (bedroom, washroom, closet & security-front/rear were kicked in multiple times. I needed some answers. It was then MPD Supv. Rodney Washington approached me again with a "DAMAGE NOTICE" specifying the damage done to my home, as well as the reason for committing these acts and having checked the box on the notice "EXECUTE A SEARCH WARRANT" which he never produced or commented on at all.
