
## Exh; bit A TRANSPORTATION PLAT


## **LEGAL DESCRIPTION**

Commencing at the Southeast corner of said Southeast 1/4, thence South 89°33′54″ West, 562.47 feet along the South line of said Southeast 1/4 to the East line of the Wisconsin Department of Transportation lands described in document 7876499 page 15; thence North 11°14′41′East along the East line of said lands, 89.12 feet to the intersection of the Wisconsin Department of Transportation lands described in document 5015826 in reel 1019 images 1243-1245; thence North 17°43′46″ East along said East line, 109.06 feet to the point of beginning; thence continuing North 17°43′46″ East along said East line, 47.39 feet; thence North 75°17′39″ East, 87.14 feet to the West right of way line of South Lincoln Memorial Drive; thence South 61°08′46″ East along said West right of way line, 58.05 feet; thence South 75°17′39″ West, 154.62 feet to the point of beginning.

This parcel contains **0.111 acres**, more or less.

The above temporary limited easement is to terminate upon the completion of this project or on the day the highway is open to the traveling public, whichever is later.



## LEGAL DESCRIPTION

A **Temporary Limited Easement** for the purpose of contractor access and structure repair being in the Southeast 1/4 of the Southeast 1/4 and the Northeast 1/4 of the Southeast 1/4 of the Southeast 1/4 of the Oity of Milwaukee, Milwaukee County, Wisconsin, described as follows;

Commencing at the Meander corner set on the North line of said Southeast 1/4, thence South 89°47'48" East along said North line, 37.87 feet; thence South 18°02'47" East, 784.09 feet to the beginning of a 2°00'01" degree curve with Easterly convexity having a radius of 2,864.38 feet and a tangent length of 207.32 feet; thence Southeasterly 413.92 feet along the arc of said curve; thence South 80°14'05" West, 148.75 feet to the West line of the Wisconsin Department of Transportation lands described in document 5015826 in reel 1019 image 1239 and the point of beginning; thence South 18°02'34" East along the West line of said lands, 110.52' to the intersection of the Wisconsin Department of Transportation Highway Easement described in said document in reel 1019 images 1257-1258 and the beginning of a 2°01'13" degree curve with Easterly convexity having a radius of 2,835.87 feet and a tangent length of 463.44 feet; thence Southerly 918.75 feet along the arc of said curve to the South line of said Highway Easement; thence South 81°27'03" West along the South line of said Highway Easement, 26.74 feet to the beginning of a 2°02'18" degree curve with Easterly convexity having a radius of 2,810.87 feet and a tangent length of 519.86 feet; thence Northerly 1,028.10 feet along the arc of said curve; thence North 80°14'05'East 4.85 feet to the point of beginning.
