Dear Ms. Gauthier:

We have received your claim in the amount of \$2,026.39, relating to your interest and that of your insured arising from a March 7, 2013 loss in which your insured's vehicle sustained damage when a City of Milwaukee garbage truck allegedly sideswiped it while it was parked at 1302 North 46th Street.

Our investigation reveals that the Fleet Accident Report completed as a result of this alleged incident notes that the damage on your insured's vehicle is not consistent with being hit by a garbage truck. In addition, there was no paint transfer on the vehicle. Finally, our driver denies causing the damage. There is no evidence to support your belief that a City garbage truck caused the damage. As such, the City cannot accept liability. Therefore, we are denying your claim.
