Dear Mr. Harrington,

We have received your claim for the amount of \$1,071.84 as a result of a tree branch falling onto your vehicle parked at 3238 North Richards Street.

The Forestry Department reports on February 27, 2013 the City of Milwaukee experienced windy conditions with peak wind gusts reaching 30 mph, and a snow depth accumulation of 5 inches. As a result of the windy conditions, the Forestry Department received numerous requests to remove broken branches and downed trees. The Forestry Department responded to 3238 North Richards Street and found a branch from a Honey Locust tree had broken off and fallen onto your vehicle. The crew removed the branch, photographed the damage and completed a property damage report.

Upon inspection of the tree, the fallen tree limb was found to be alive and did not have any signs of decay. The last cycle of pruning for this particular tree occurred in November 2009. The Forestry Department did not receive any complaints or service requests regarding any defects, potential hazards, or decay in this tree for the five years preceding this incident. Based on this information, the tree limb in question fell from a live tree during conditions of severe winds. Because these damages were caused through no fault or negligence of the City of Milwaukee, the city cannot be held liable. Accordingly, we are denying your claim.
