# Uptown Crossing Business Improvement District #16 August 2013

The property owners and merchants within Business Improvement District #16, Uptown Crossing, have been involved with the following activities in the area bounded by West North Avenue from Sherman Boulevard to North 60<sup>th</sup> Street and West Lisbon Avenue from 45<sup>th</sup> Street to North 52<sup>nd</sup> Street.

The procurement, promotion and encouragement of new businesses in the area, including activities specifically designed to create in the Business Area a clean, attractive, safe commercial environment contributing to individuals wanting to visit and patronize businesses in the District.

The continuing distribution of a quarterly newsletter, which was redesigned in the past year, informing member merchants of activities and events occurring within the District (copy accompanying).

The maintenance and upkeep of streetscape improvements including street and sidewalk maintenance, light pole banners, public art piece, tree grates, refuse containers, landscaping amenities, specially painted pedestrian crossings and holiday decorations, all intended to make the District a more attractive area within which to locate a business or to conduct business.

The BID's website was updated in 2012 (<a href="www.uptownCrossing.com">www.uptownCrossing.com</a>), allowing members and the general public easy and convenient access to information concerning property events and new businesses in the Uptown Crossing business community with the ability to easily add content.

On-going communication with City of Milwaukee Departments and Aldermen pertaining to the location and creation of new businesses entering the area. New businesses located in BID #16 include Myle Nails, North Avenue Coffee and Bedroom Secrets.

In 2012 the BID board continued working on the process of creating a development program to leverage BID Funds to assist in the purchase and renovation of several underutilized buildings in the district. The BID Board created two RFP's aimed at small real estate developers or investors and issued those RFP's in Spring 2011. The BID was seeking to form a partnership with one or more parties to acquire and redevelop two properties 5038-5040 W. North Avenue and 5507-5513 W. North Avenue. Both properties have been sold and are no longer being marketed with the RFP. The Board will continue to seek opportunities to assist developers or new businesses in remodeling/restoring buildings in the District.

In 2013 the BID board has provided matching funds to the City of Milwaukee's Façade Grant Program, reserving \$10,000 per year for façade grants. Hi-Mount Investments took advantage of this BID provided program.

In addition to the above specific activities, the BID continues to act as a solidifying influence for property owners within its boundaries, providing to them an organization that attempts to maintain the commercial viability of the area and to promote it as a desirable area within which to do business.

## CAMERAS WILL HELP ENHANCE PUBLIC SAFETY IN COMMERCIAL CORRIDORS

If businesses in any neighborhood are to be successful, there must be a sense of security and safety with that neighborhood.


Surveillance cameras utilized in commercial corridors have proven effective in helping to deter crime and also helping to solve crimes.

For example, mounted surveillance cameras helped quickly identify the perpetrators of the Boston Marathon terror bombing and bring them to justice.

This summer, commercial corridors in the City of Milwaukee will be able to take advantage of a new city public safety initiative that will provide mounted, police-monitored surveillance cameras.

I'm proud to say I'm the lead sponsor of this initiative, joined by Alderman Bob Donovan. Mayor Tom Barrett is also a key supporter.

The initiative will use a \$200,000 matching grant to help provide monitored surveillance cameras in commercial corridors where Business Improvement Districts (BIDs) exist to support and help fund improvements.

Details of the program will be announced soon, but the bottom line is that participating BIDs that provide matching funds will be able to access grant funding for the installation of cameras.

There are two sources of the funding for the \$200,000 matching grant. Half will come from Community Development Block Grant (CDBG) funds, and half will come from funds generated from the Milwaukee Police Department's asset forfeiture program, which is confiscated cash and property from criminal cases.

# CREAM CITY FURNITURE BRINGS VINTAGE PIECES INTO 21 ST CENTURY

As the weather warms up, shoppers in the Uptown Crossing neighborhood will notice a mix of colorful and unique furniture on display outside of Cream City Furniture. Located at 5209 West North Avenue, Cream City Furniture is a destination for anyone looking to add one-of-a-kind pieces to their home or office.

Erik Hall opened Cream City Furniture in Uptown Crossing last spring after hearing about the available storefront from a friend.

"The location is great," said Hall."By having other interior stores such as Samara

and Residence as neighbors, we can attract shoppers looking for a number of options on one block."

Cream City Furniture specializes in repurposed furniture. Many of the pieces in Hall's shop were either found at auction or donated by friends looking to save a piece of quality furniture from the landfill. Hall spends about four hours with each piece of furniture restoring or refinishing it before it is ready to be sold.

"I see the furniture as pieces of art, but you can use them," said Hall. "They're interesting and great to look at, but these pieces are also functional and have purpose whether it's hanging up your jacket or storing your clothes."

Among the many unique pieces at Cream City Furniture are an old card catalog repurposed into a coffee table, a vibrant purple dresser and a set of wall hooks made out of old faucets. Prices for smaller pieces begin

"I can go back and forth between the store and the shop when I need. My dad also looks after the store if I'm gone or working in the shop."



# BID #16 ACCEPTING FAÇADE GRANT APPLICATIONS

Last year, the Uptown Crossing Business Improvement District (BID) #16 established a façade grant application to assist commercial property owners and businesses in BID 16 with improvements to their façades that will help improve the aesthetics of the BID area.


BID 16 has reserved \$10,000 per year for façade grants. These funds will be available on a first-come basis per calendar year until all funds have been used. The grants from the BID will only be given to a project that has been awarded a grant from the City of Milwaukee's Citywide Façade Grant program.

Because the citywide program does not provide 100% funding for projects, the role of the BID façade grant application is to provide additional resources to encourage property owners to improve their façades and help with the remaining costs.

Grant awards will help pay up to 50% of a property owner's share up to \$2,500, and each address in BID 16 is only eligible to receive one grant per calendar year. In addition, only work begun after approval by the City of Milwaukee is eligible for a grant.

One award has already been given out to the property owner at 5033 West North Avenue to improve the façade of the building. The changes have made a huge impact to that stretch of the district, and the BID hopes that it will inspire others to apply for the remaining funding.



# LISBON STORM, SCREEN AND DOOR - AN UPTOWN CROSSING NEIGHBORHOOD BUSINESS SINCE 1945

When Lawrence Wilhelm first arrived in the Uptown Crossing neighborhood in 1945, his plan was to own and operate a small family grocery store on the corner of 52nd Street and W. Lisbon Avenue. However, when Lawrence started selling used doors and windows alongside his groceries, his plans quickly changed. As demand for his store's doors and windows took off, Lawrence closed the family grocery store and opened Lisbon Storm, Screen and Door in 1961.

Now located at 5006 W. Lisbon
Avenue after a one-block move in the 1980s, Lisbon Storm, Screen and Door is a third-generation family business currently owned and operated by Lawrence's twin grandsons,
David and Daniel Wilhelm. The company has evolved from selling used doors and windows in a small grocery store to becoming a leader in the industry while remaining a neighborhood fixture throughout the area's several transformations throughout the years.

"Our location is great because it puts us right between downtown and the Menomonee Valley, as well as from Mequon to Brookfield," says

Wilhelm.

"Our customers in the Milwaukee area have easy access to our store

right where we are."

Since taking over the business in 1997, David and Daniel Wilhelm have helped Lisbon Storm, Screen and Door rapidly grow and quadrupled its sales. With its wide and diverse national customer base, Lisbon Storm, Screen and Door can accommodate nearly any customer, from do-it-yourself homeowners to



government agencies and retailers such as the Milwaukee Housing Authority and

Urban Outfitters.

"While in Kansas City this summer, I stopped in an Urban Outfitters to find some of our doors and windows used in displays throughout the store," says Wilhelm.

Not only is Lisbon Storm, Screen and Door a destination for purchasing doors and windows, it is also the go-to company for door and window repairs in the state.

"If you know someone who has brought a door or window to their local hardware store in Wisconsin for repair, there's a good chance it has come through our doors," says Wilhelm.

To maintain its diverse customer base and services, Lisbon Storm, Screen and Door has 29 employees ranging from office and sales staff to warehouse employees, delivery drivers and glass cutters.

## HISTORIC UPTOWN CROSSING:

## A BUILDING FOCUSED ON SAVING

Part of the historic BID 16 series of articles bringing Uptown Crossing's history to life

Though it could not have served two more unrelated

industries, the Agape Love Deliverance building at 4716 W. Lisbon Avenue has been a fixture in the Uptown Crossing District since it was built in 1924.

The building, which was constructed at a cost of \$55,000, was first built for the Northwestern National Bank. Designed by the Milwaukee architectural firm of Dick and Bauer – the firm behind many of Milwaukee's theaters and numerous homes in the Washington Heights neighborhood – the bank served residents and businesses in the Uptown Crossing, Sherman Park and Washington Heights neighborhoods.

Northwestern National Bank received its federal charter the same year the building was constructed on the corner of Lisbon and North, but was not part of the growing Northwestern National Bank cooperative based in Minneapolis that would later become Wells-Fargo bank. Instead, within the decade, it was acquired by First Wisconsin Trust Company, the precursor to Milwaukee-based First Wisconsin/ FirstStar.


In the late 1920s, First Wisconsin Trust Company's directors formed a new entity, Wisconsin Bankshares Corporation, which legally allowed the bank to acquire numerous smaller banks. By the end of 1930, Wisconsin Bankshares Corporation acquired 23 additional Wisconsin financial institutions, giving it a total of 16 national banks, 27 state banks (including the one located in Uptown Crossing), three trust companies, and seven other companies.

Unlike many financial institutions, Wisconsin Bankshares Corporation initially weathered the Stock Market Crash of 1929, staying rather stable for the next few years. However, the Depression ultimately caught even this stable Milwaukee-based firm, and it took part in a number of mergers during the next this particular

bank remained open and under its control.

During the next few decades, federal and state regulations impacted the financial industry. Banking operations continued at many of the corporation's locations, though the Lisbon Avenue branch ultimately closed. This was likely due to not only the changing needs of the area, but also increased competition as more banks opened in the neighborhood over time. For many years, Wisconsin tightly regulated the growth of banks and their ability to open branch offices. The state legislature relaxed these regulations in the 1960s and 1970s, resulting in increased competition from other lending instututions throughout the city as new branch operations opened.

First Wisconsin Trust Company continued to own the building, and by the 1970s, the building had become

involved in a second chapter of "savings" — saving souls as a church and outreach ministry facility.

By 1975, the Child Evangelism Fellowship of Milwaukee opened a bookstore and office in the bank building.

This was followed by Highway and Hedges Outreach Ministries Training Center in the late 1990s, and a few years later, the Agape Love Deliverance Church was established on the site. While it still remains a church, the facility has expanded, becoming the Agape Love Bible College & ALBC School of Theology, with a mission to educate, inspire and promote Biblical and religious studies.
