Re: Report of the Renewal Application of Amit P. Singh for a Public Passenger Vehicle Driver License.

FINDINGS OF FACT

- 1. Amit P. Singh (hereinafter the "Licensee") is the holder of a Public Passenger Vehicle Driver license in the City and County of Milwaukee, Wisconsin. Said license expires at midnight, October 31, 2013.
- 2. An application to renew said license was filed with the Office of the City Clerk February 15, 2013.
- 3. Pursuant to Chapter 100 of the Milwaukee Code of Ordinances and § 349.24 of the Wisconsin Statutes, the matter was referred to the Milwaukee Police Department for investigation. The Milwaukee Police Department filed a police report dated July 16, 2013. That report could form the basis of non-renewal or suspension of this license.
- 4. On August 27, 2013, the City Clerk's Office provided timely notice to the Licensee, pursuant to Chapter 100 of the Milwaukee Code of Ordinances and § 349.24 of the Wisconsin Statutes of a police report that could form the basis for suspension or non-renewal of the license of the licensee and included therewith a copy of the Milwaukee Police Department report. The matter was scheduled for a hearing on the police report on September 12, 2013 at 9:00 a.m. in Room 301B of City Hall. At said date, time and place, the licensee did appear and was not represented by counsel.
- 5. Based upon the sworn testimony heard and the evidence received at the hearing, the Committee finds the following:
 - A. On November 12, 2011 12:46 a.m. an officer observed the applicant operating a taxicab with a fare on board in the 100 block North 6th Street. The vehicle appeared to be speeding and the officer using laser captured the speed of 46 mph in a 30 mph zone. The officer followed the applicant to Potawatomi Casino to drop off his passenger.



The applicant was unsure of his speed and estimated he was driving about 40 mph. The applicant was asked for his daily safety checklist and trip records. The applicant produced a safety checklist from April. The trip log last had an entry at 11:20 p.m. and the applicant stated he was behind in listing his last 3 or 4 fares. The applicant was cited for speeding and advised regarding the other violations.

The officer contacted the taxi dispatch company and was informed the driver was Amit Singh. The officer contacted the applicant at his residence. The applicant stated he was driving the vehicle involved and did strike the traffic signal pole because he was looking at his cell phone, He stated he fled because he was scared.

- D. On December 12, 2012 the applicant was convicted in Greenfield Municipal Court of Operating While Intoxicated-1st offense and the Wisconsin Department of Transportation revoked his driver's license for 6 months.
- E. The applicant's regular driver's license is revoked for item #4 and not eligible for reinstatement until May 16, 2013. The applicant reinstated his driver's license on June 26, 2013.
- F. The Wisconsin Department of Transportation revoked the applicant's driver's license for the following:

CONCLUSIONS OF LAW

- 1. The Committee has jurisdiction to hold hearings and provide Findings of Fact and Conclusions of Law and a Recommendation to the full Common Council pursuant to Chapter 100 of the Milwaukee Code of Ordinances and § 349.24, Wisconsin Statutes.
- 2. Based upon the above facts found, the Committee concludes that the licensee, Amit P. Singh, has not met the criteria of Chapter 100 of the Milwaukee Code of Ordinances or § 349.24 of the Wisconsin Statutes to allow renewal of his Public Passenger Vehicle Driver license without undergoing a fifteen (15) day suspension based upon the police report and driving record.
- 3. In order to protect the health, safety and welfare of the citizens of the City of Milwaukee, it is the recommendation of the Public Safety Committee that the full Common Council of the City of Milwaukee should exercise its judgment to renew with a fifteen (15) day suspension the Public Passenger Vehicle Driver license held by Amit P. Singh based upon the police report and driving record.

RECOMMENDATION

Based upon the Findings of Fact and Conclusions of Law stated above, the Committee recommends that the Public Passenger Vehicle Driver license of Amit P. Singh be renewed with a fifteen (15) day suspension based upon the police report and driving record.

Said suspension is to be in effect from November 1, 2013 through midnight November 15, 2013.

Report of the Renewal Application of Miloud Laasiri for a Public Passenger Vehicle Re:

Driver License.

FINDINGS OF FACT

1. Miloud Laasiri (hereinafter the "Licensee") is the holder of a Public Passenger Vehicle Driver license in the City and County of Milwaukee, Wisconsin. Said license expired at midnight, October 31, 2013.

- 2. An application to renew said license was filed with the Office of the City Clerk August 9, 2013.
- Pursuant to Chapter 100 of the Milwaukee Code of Ordinances and § 349.24 of the 3. Wisconsin Statutes, the matter was referred to the Milwaukee Police Department for investigation. The Milwaukee Police Department filed a police report dated August 20, 2013. That report could form the basis of non-renewal or suspension of this license.
- On August 27, 2013, the City Clerk's Office provided timely notice to the Licensee, 4. pursuant to Chapter 100 of the Milwaukee Code of Ordinances and § 349.24 of the Wisconsin Statutes of a police report that could form the basis for suspension or nonrenewal of the license of the licensee and included therewith a copy of the Milwaukee Police Department report. The matter was scheduled for a hearing on the police report on September 12, 2013 at 9:30 a.m. in Room 301B of City Hall. At said date, time and place, the licensee did not appear and was not represented by counsel.
- Based upon the sworn testimony heard and the evidence received at the hearing, the 5. Committee finds the following:
 - A. Notice was sent to Miloud Laasiri at 2721 East Whittaker Avenue, St. Francis, Wisconsin 53235, along with a copy of the police report on August 27, 2013 in an envelope which was sent by U.S. first-class prepaid mail in an envelope bearing the return address of the License Division, 200 East Wells Street, Room 105,



Milwaukee, WI 53202. The address of 2721 East Whittaker Avenue, St. Francis, Wisconsin 53235 was the address given by the applicant on his renewal application. The notice included a copy of the police report. The licensee failed to appear at the hearing and the envelope containing the notice and police report was not returned to the License Division by the U.S. Postal Service.

CONCLUSIONS OF LAW

- 1. The Committee has jurisdiction to hold hearings and provide Findings of Fact and Conclusions of Law and a Recommendation to the full Common Council pursuant to Chapter 100 of the Milwaukee Code of Ordinances and § 349.24, Wisconsin Statutes.
- 2. Based upon the above facts found, the Committee concludes that the licensee, Miloud Laasiri, has not met the criteria of Chapter 100 of the Milwaukee Code of Ordinances or § 349.24 of the Wisconsin Statutes to allow renewal of his Public Passenger Vehicle Driver license based upon nonappearance.
- In order to protect the health, safety and welfare of the citizens of the City of Milwaukee, it is the recommendation of the Public Safety Committee that the full Common Council of the City of Milwaukee should exercise its judgment to not renew the Public Passenger Vehicle Driver license held by Miloud Laasiri based upon nonappearance.

RECOMMENDATION

Based upon the Findings of Fact and Conclusions of Law stated above, the Committee recommends that the Public Passenger Vehicle Driver license of Miloud Laasiri be denied based upon nonappearance.
