Substitute resolution relating to the permanent historic designation of the Tiefenthaler House at 2425 W. McKinley Avenue, in the 4th Aldermanic District.

Body:

Whereas, The Milwaukee Historic Preservation Ordinance, s. 320-21 of the Code of Ordinances, provides that historic sites, structures and districts may be designated by the Common Council upon the recommendation of the Historic Preservation Commission; and

Whereas, The Historic Preservation Commission, at its August 5, 2013 meeting, by a vote of seven (7) ayes and zero (0) noes, recommended permanent designation of the Tiefenthaler House at 2425 W. McKinley Avenue as a historic site;

Whereas, This site possesses integrity of location, design, setting, materials, workmanship and association and fulfills the following criterion set forth in s. 320-21(3):

- e-3 Its identification with a person or persons who significantly contributed to the culture and development of the City of Milwaukee.
- e-5. Its embodiment of the distinguishing characteristics of an architectural type or specimen.

Resolved, By the Common Council of the City of Milwaukee, that the Tiefenthaler House at 2425 W. McKinley Avenue, and further described as follows:
