### 1. Description of Grant Program/Project (Include Target Locations and Populations):

The Consolidated Contract includes three (3) initiatives, each having a specific purpose and target population. The three initiatives are Maternal and Child Health, Childhood Lead Detection Grant, and the Immunization Action Plan Grant,

The objectives for the **Maternal and Child Health Grant** are to improve birth outcomes and childhood development through an intensive home visiting program (Nurse Family Partnership, and to operate a men's health center.

**The Lead Detection Grant** in combination with City and Centers for Disease Control funds support comprehensive and coordinated service delivery to lead-poisoned children and their families. This particular grant supports community outreach, nursing care management, and abatement technical services.

The primary focus of the **Immunization Action Plan** is to increase immunization rates of children served by the Milwaukee Health Department to 90% by the year 2020. In addition, the Immunization Program plans to continue to utilize the tracking and recall system through the Wisconsin Immunization Registry for children who are behind in their immunizations for their age and to assure that children served at the MHD will be assisted in locating their private providers name and location for follow-up medical services.

### 2. Relationship to Citywide Strategic Goals and Departmental Objectives:

All of the programs relate to the City-wide goal to enhance the health and well-being of Milwaukee residents by improving access to preventive health care; promote healthy behaviors; assure safe and healthy homes, businesses and neighborhoods; reduce racial and ethnic health disparities; and improve the quality of healthcare information and coordination of services.

### 3. Need for Grant Funds and Impact on Other Departmental Operations (Applies only to Programs):

The consolidated contract funds positions and services needed to sufficiently administer the programs. While some City funds are currently used to support some of these initiatives, they are considered as match funds for the grantor. These functions could not be achieved without the grant funding supplementing the City funds. Community-wide, these grants work to improve the health of Milwaukee's citizens.

### 4. Results Measurement/Progress Report (Applies only to Programs):

**MCH Grant:** NFP Outcome measures/Goals: 1) Achieving a client caseload of 140 2) Completing 1,500 home visits 3) 60 babies born with less than 8% premature or low birth weight 4) Completing 100 developmental and social-emotional screenings on infants and toddlers 5) Receiving 100 new referrals for potential clients 6) 60 families referred and/or visits completed by Mental Health Consultant.

The Men's Health goals are to collaboratively introduce men and father servicing agencies to the concepts of the Lifecourse Framework; to promote activities that strengthen systems of early childhood services; to expand the number of service providers who know the value of child development screening tools; and to provide fathers health services and appropriate referrals.

**The Immunization Action Grant** goals are to 1) By December 31, 2014, the Milwaukee Health Department (MHD) will work with MPS and Private schools in the city of Milwaukee to increase the City immunization compliance rate by 2% from 87% to 89%. And 2) By December 31, 2014, 58% children residing in City of Milwaukee jurisdiction who turn 24 months of age during the contract year will complete 4 DTaP, 3 Polio, 1 MMR, 3 Hib, 3 Hepatitis B, 1 Varicella and 4 Pneumococcal Conjugate (PCV) vaccination by their second birthday.

**Lead Detection Grant:** 1) By December 31, 2014, 150 environmental lead hazard investigations will be completed on the primary residences and pertinent secondary properties of children with venous blood lead levels greater than or equal to 15 micrograms per deciliter (µg/dL) who reside in the City of Milwaukee. 2) By December 31, 2014, all children with capillary or venous blood lead levels ≥10mcg/dL who reside in the City of Milwaukee will receive comprehensive follow-up nursing service according to the City of Milwaukee Health Department (MHD) Childhood Lead Poisoning Prevention Intervention Schedule.

**5. Grant Period, Timetable and Program Phase-out Plan:**

The grant period for the Consolidated Contract is January 1, 2014 through December 31, 2014.

If funding was not received, the positions paid by this contract would be eliminated and the ability of the Health Department to provide these services would be greatly diminished.
