
You are hereby notified that the Milwaukee Common Council will hold a hearing on Wednesday, January 22, 2014, commencing at 9:00 a.m., or as soon thereafter as this matter may be heard, in the Common Council chambers on the third floor of City Hall, 200 East Wells Street, Milwaukee, Wisconsin to consider whether to renew, renew with a suspension between 10 and 90 days, or not renew your Public Passenger Vehicle Driver's license.

Attached you will find a copy of the Report of the Public Works Committee, which includes its Findings of Fact, Conclusions of Law, and Recommendation, recommending renewal of your Public Passenger Vehicle Driver's license, with a ten (10) day suspension, based upon your police report. This recommendation is the result of a public hearing before the Committee held on Wednesday, January 8, 2014.

Please be advised that the Common Council will determine whether to renew, renew with a suspension between 10 and 90 days, or not renew your Public Passenger Vehicle Driver's license based upon the Findings of Fact contained within the Committee report.

You may file written objections to the report of the Committee. The written objections must be filed with the City Clerk by 4:45 p.m. on Thursday, January 16, 2014 in Room 205 of City Hall. If you file written objections, you or a legal representative may then also appear at the Common Council to make oral arguments supporting the written objections. You will be given approximately five minutes to present the oral argument.

Re: Report of the Renewal Application of Mohamed A. Salaad for a Public Passenger Vehicle Driver License.

### FINDINGS OF FACT

1. Mohamed A. Salaad (hereinafter the "Licensee") is the holder of a Public Passenger Vehicle Driver license in the City and County of Milwaukee, Wisconsin. Said license expired at midnight, October 31, 2013.
2. An application to renew said license was filed with the Office of the City Clerk on November 22, 2013.
3. Pursuant to Chapter 100 of the Milwaukee Code of Ordinances and § 349.24 of the Wisconsin Statutes, the matter was referred to the Milwaukee Police Department for investigation. The Milwaukee Police Department filed a police report dated November 25, 2013 which report could form the basis of non-renewal or suspension of this license.
4. On December 27, 2013, the City Clerk's Office provided timely notice to the Licensee, pursuant to Chapter 100 of the Milwaukee Code of Ordinances and § 349.24 of the Wisconsin Statutes of a police report that could form the basis for suspension or non-renewal of the license of the licensee and included therewith a copy of the Milwaukee Police Department report. The matter was scheduled for a hearing on the police report on January 8, 2013 at 9:45 a.m. in Room 301B of City Hall. At said date, time and place, the licensee did appear and was not represented by counsel.
5. Based upon the sworn testimony heard and the evidence received at the hearing, the Committee finds the following:
  - A. On January 8, 2012 an officer observed the applicant operating a taxicab in the 100 block of South 6<sup>th</sup> Street. Using a laser the officer captured the



applicant's speed at 47 mph in a 30 mph zone. After being stopped, while speaking to the officer, the applicant stated he knew the speed limit was 30 mph and estimated his speed at 30 mph. The applicant did not have a current trip record or daily safety checklist. The applicant gave conflicting statements when asked if he was in service, but stated he did not convey any fares. The officer contacted the dispatch company which confirmed the applicant had logged in four fares. When confronted with this information the applicant admitted being untruthful and stated he was in service. The applicant's Wisconsin driver's license had expired on January 1, 2012. The applicant was issued citations for (1) exceeding posted speed limit (fined \$114.00); (2) operating without valid driver's license (fined \$76.20); and (3) public passenger vehicle trip log required (fined \$50.00). He was found guilty of the above on February 23, 2012.

### CONCLUSIONS OF LAW

1. The Committee has jurisdiction to hold hearings and provide Findings of Fact and Conclusions of Law and a Recommendation to the full Common Council pursuant to Chapter 100 of the Milwaukee Code of Ordinances and § 349.24, Wisconsin Statutes.
2. Based upon the above facts found, the Committee concludes that the licensee, Mohamed A. Salaad, has not met the criteria of Chapter 100 of the Milwaukee Code of Ordinances or § 349.24 of the Wisconsin Statutes to allow renewal of his Public Passenger Vehicle Driver without a suspension of 10 days.
3. In order to protect the health, safety and welfare of the citizens of the City of Milwaukee, it is the recommendation of the Public Works Committee that the full Common Council of the City of Milwaukee should exercise its judgment to renew the Public Passenger Vehicle Driver license held by Mohamed A. Salaad with a suspension of 10 days.

### RECOMMENDATION

Based upon the Findings of Fact and Conclusions of Law stated above, the Committee by vote of four (4) ayes and zero (0) noes recommends that the Public Passenger Vehicle Driver license of Mohamed A. Salaad be renewed with a 10-day suspension based upon the police report.

Said suspension is to be in effect from the dated of the Common Council meeting on January 22, 2014 and for ten days thereafter.

Re: Report of the Renewal Application of Dimpale A. Sharma for a Public Passenger Vehicle Driver License.

**FINDINGS OF FACT**

1. Dimpale A. Sharma (hereinafter the "Licensee") is the holder of a Public Passenger Vehicle Driver license in the City and County of Milwaukee, Wisconsin. Said license expired at midnight, October 31, 2013.
2. An application to renew said license was filed with the Office of the City Clerk on August 14, 2013.
3. Pursuant to Chapter 100 of the Milwaukee Code of Ordinances and § 349.24 of the Wisconsin Statutes, the matter was referred to the Milwaukee Police Department for investigation. The Milwaukee Police Department filed a police report that could form the basis of non-renewal or suspension of this license.
4. On December 27, 2013, the City Clerk's Office provided timely notice to the Licensee, pursuant to Chapter 100 of the Milwaukee Code of Ordinances and § 349.24 of the Wisconsin Statutes of a police report that could form the basis for suspension or non-renewal of the license of the licensee and included therewith a copy of the Milwaukee Police Department report. The matter was scheduled for a hearing on the police report on January 8, 2014 at 9:45 a.m. in Room 301B of City Hall. At said date, time and place, the licensee did not appear and was not represented by counsel. This was the applicant's second non-appearance.
5. Based upon the sworn testimony heard and the evidence received at the hearing, the Committee finds the following:
  - A. Notice was sent to Dimpale A. Sharma at 3406 South 13<sup>th</sup> Street, Milwaukee, WI 53215, along with a copy of the police report on



December 27, 2013 in an envelope which was sent by U.S. first-class prepaid mail in an envelope bearing the return address of the License Division, 200 East Wells Street, Room 105, Milwaukee, WI 53202. The address of 3406 South 13<sup>th</sup> Street, Milwaukee, WI 53215 was the address given by the applicant on his renewal application. The notice included a copy of the police report. The licensee failed to appear at the hearing of January 8, 2014 and the envelope containing the notice and police report was not returned to the License Division by the U.S. Postal Service.

- B. On April 28, 2012 the applicant was arrested in the City of Milwaukee for operating while intoxicated (1<sup>st</sup> offense) and refusal to submit to chemical test. He was found guilty of both charges on December 4, 2012 and fined \$801.00 and had his license revoked.
- C. On November 5, 2013 the applicant was convicted of operating while intoxicated (1<sup>st</sup> offense) in West Allis Municipal Court and the Wisconsin Department of Transportation revoked his driver's license for two years.

#### CONCLUSIONS OF LAW

1. The Committee has jurisdiction to hold hearings and provide Findings of Fact and Conclusions of Law and a Recommendation to the full Common Council pursuant to Chapter 100 of the Milwaukee Code of Ordinances and § 349.24, Wisconsin Statutes.
2. Based upon the above facts found, the Committee concludes that the licensee, Dimpale A. Sharma, has not met the criteria of Chapter 100 of the Milwaukee Code of Ordinances or § 349.24 of the Wisconsin Statutes to allow renewal of his Public Passenger Vehicle Driver license based upon items 5-6 in the police report and his second nonappearance.
3. In order to protect the health, safety and welfare of the citizens of the City of Milwaukee, it is the recommendation of the Public Works Committee that the full Common Council of the City of Milwaukee should exercise its judgment to not renew the Public Passenger Vehicle Driver license held by Dimpale A. Sharma based upon the police report and second nonappearance.

#### RECOMMENDATION

Based upon the Findings of Fact and Conclusions of Law stated above, the Committee recommends that the Public Passenger Vehicle Driver license of Dimpale A. Sharma not be renewed based upon items 5 and 6 in the police report and second nonappearance.
