1st Aldermanic District

N. 35th St. – W. Cameron Ave. to W. Villard Ave. (ST211130121):

Concrete pavement reconstruction, replace all curb and gutter, replace sidewalk and driveway approaches where necessary, sodding (9 – 11-foot width of tree border area), and grading.

Alan H. Nelson – 5045 N. 35th St. – opposed

Approve, with late billing, with continued dialog with Mr. Nelson relating to the sidewalk and other items, by Ald. Puente. Prevailed. 3-0 (Ald. Wade and Ald. Donovan excused)

N. 38th St. – W. Florist Ave. to W. Douglas Ave. (ST211130124):

Asphalt pavement resurfacing, replace curb and gutter, sidewalk and driveway approaches where necessary, sodding (7-foot width of tree border area), and grading.

David Fenton – 6029 N. 38th St. – opposed to taking out sidewalk in good condition

W. Legion St. – S. 24th St. to S. Layton Blvd. (ST211120115):

Pavement reconstruction, replace all curb and gutter, replace sidewalk and driveway approaches where necessary, sodding (0-foot width of tree border area), and grading.

W. Tower Ave. – N. 87th St. to N. Faulkner Rd. (ST211130107):

Asphalt pavement resurfacing, replace curb and gutter, sidewalk and driveway approaches where necessary, sodding (11-foot width of tree border area), and grading.

S. 67th St. – W. Fremont Pl. to W. Cleveland Ave. (ST211110117):

Asphalt pavement resurfacing, replace curb and gutter, sidewalk and driveway approaches where necessary, sodding (9-foot width of tree border area), and grading.

Approve, with late billing, by Ald. Bohl. Prevailed 4-0

E. Anderson Ave. – A point 400 feet m/l east of S. 1st St. to S. 1st St. (ST211120106):

Concrete alley-type pavement reconstruction, replace some abutting walk or driveway approaches, grading, and storm drainage facilities where necessary.

S. 2nd St. – A point south of W. Norwich St. to W. Howard Ave. (ST211110111):

Pavement reconstruction, replace all curb and gutter, replace sidewalk and driveway approaches where necessary, sodding (8-foot width of tree border area), grading, and tree removal where necessary.

14th Aldermanic District

S. Griffin Ave. – E. Malvern Pl. to E. Euclid Ave. (ST21100136):

Pavement reconstruction, replace all curb and gutter, replace sidewalk and driveway approaches where necessary, sodding (8 – 9-foot width of tree border area), and grading.

Approve, with late billing until 2017, by Ald. Bohl. Prevailed. 4-0
