RE: Resolution relating to the permanent historic designation of the Germania Building located at 135 W. Wells Street, in the 4th Aldermanic District.

Dear Property Owner:

An application was recently submitted to the Historic Preservation Commission to designate the Germania Building located at 135 W. Wells Street as a historic site or structure.

A public hearing has been scheduled for Monday, February 10, 2014 at 3:00 p.m. in City Hall, 200 East Wells Street, Room 301-B to determine whether or not the proposed designation of the Germania Building located at 135 W. Wells Street satisfies the criteria for historic designation in accordance with Section 320-21 of the Milwaukee Code of Ordinances.

If the Commission determines the building meets at least one criterion, a favorable recommendation for nomination can be forwarded to the Milwaukee Common Council.
