Communication from MARSELINE MANN

Dear Ms. Mann:

We have received your claim in the amount of \$1,016.92, relating to damage to the front and rear driver side doors of your parked vehicle allegedly sustained on July 23, 2013 when the Milwaukee Police Department (MPD) was in the process of placing a subject under arrest at/near 2628 North 24th Place.

The MPD records indicate that on July 23, 2013 officers were dispatched to a violation of a restraining order at North 24th Place and West Center Street. In the process of placing the subject under arrest, there were scratches done to the front driver side door of your vehicle. The sergeant involved did not recall any scratches on the rear driver side door, but noted that it is possible. It could not be determined if the officers or the subject did the damages. The police action taken in this matter was necessary and appropriate. Since the police were not negligent, but rather were acting within the sphere of their responsibility, the City would not be liable. Therefore, we are denying your claim.

If you wish to appeal this decision, you may do so by sending a letter within 21 days of the receipt of this letter to the Milwaukee City Clerk, 200 East Wells Street, Room 205, Milwaukee, Wisconsin 53202, requesting a hearing.
