5. DESCRIPTION OF PROJECT:

1 - Hollow Metal Door - There is an existing hollow metal door and on the west facade that is damaged and is being proposed for replacement. The door will be replaced with a hollow metal door with a small square vision lite. Refer to A4 for proposed door elevation. The door will be painted to match the existing color.

2- Entry Doors - The existing entry doors for Henry's on E. Belleview Place are currently wood doors that are painted green to match the wood trim below the street storefront. These doors are being proposed for replacement. The proposed doors would be full glass solid wood doors that match the doors on Pizza Man. The glazing in the proposed doors would be clear tempered glass and the hardware would be a dark bronze to match the storefront framing color at Henry's. The proposed doors would painted to match the rest of the wood paneling color on Henry's entrance facade. Refer to A1 for the color of the existing wood paneling.
