5. DESCRIPTION OF PROJECT:

Our intention is to ultimately design and fabricate a new marquis sign for the historic Avalon movie theater -one that glorifies the existing architecture while paying homage to both the aesthetics and principals of the atmospheric type movie theaters of the 1920's. Our objective is to achieve this by combining elements of the existing design with the use of modern materials and technological components. Buy using similar decorative and architectural elements, such a sign would be truly beautiful while further resurrecting and conveying the impression of a fantastic and escapist environment.

The sign will occupy overall dimensions of 24 feet in length by 24 feet in height by 8 feet in depth. Sign construction will use all aluminum, painted in rich metallics: a dark architectural bronze for the face panels (bands) of both the canopy and for the two-sided projecting blade (which will be integrated with the roof of the canopy), and a frosted, antique-like gold for all of the trim. The 'AVALON' letters will use all aluminum channel letter construction, painted red with exposed single stroke red neon. The trim will use all aluminum channel construction as well, painted gold with exposed gold neon. Both ends of the rectangular canopy will feature a digitally-programmable and fully customizable full-color LED message center/display that is 6 feet long by 3 feet in height. Finally, it should be noted that the shape of the two-sided projecting sign blade 'echoes' the same profile of the minarets (tall, slender towers) which once adorned both sides of the ornamental masonry work while projecting into the beautiful skies of Bay View.
