It was brought to my attention that Mr. Jermaine Cannon has applied for a Public Passenger license from the City of Milwaukee. Mr. Jermaine Cannon is currently on an Extended Supervision term which is scheduled to discharge on 01/19/2016 for the offense of Felon in Possession of a Firearm.

This letter is to inform you that such a licensure would not be in in violation of his/her rules/conditions of supervision. If circumstances change, we will take whatever action we deem appropriate, including action which may affect such licensure. This decision was made based in part, on the following information:

- Residence Stability: offender has or has not maintained residence stability (yes or no)
- Reporting History: offender has or has not maintained required contacts with agent (yes -no)
- Police Contact while on supervision: offender has had police contact prompted by illegal behavior, rule violations, curfew violation, geographic are violation while on supervision (yes or no)
 - Overall level of cooperation while on supervision: (very cooperative, somewhat cooperative, unmotivated, uncooperative, resistant)
 - Offender has or has not complied with referrals and services designed to address treatment needs (yes or no)
 - DCC recommends license not be granted due the following: License/employment has a direct nexus to committing offense.
 - License/employment would have a negative impact on the offender based on specific treatment needs. (HIPPA prohibits the disclosure of specific treatment needs)
 - Sex offenses will be scrutinized at a higher level.
