

<p>PER OUR CONVERSATION AND CITY INSPECTOR'S INSPECTION REPORT WE SUBMIT THE FOLLOWING ESTIMATE FOR TUCKPOINTING AND BRICK REPLACEMENT ON EAST SIDE ARCH OPENING ON CHURCH. PER MY COUNT THERE ARE APPROXIMATELY 60 BRICK TO SAW OUT AND REPLACE WHICH ARE DETERIORATING. THESE OCCUR IN THE ARCH AREA AND SUPPORT COLUMN BASE OF DOOR OPENING AND ADJACENT WALL ALONG WITH TUCKPOINTING AND CAULKING OF CRACKS. WE WILL USE YOUR STORED BRICK, BUT THEY RUN 3/8" TO 1/2" SHORTER THAN EXISTING BRICK WHICH ARE NO LONGER MADE IN THAT SIZE. SO CROSS JOINTS AT REPLACED BRICK WILL BE WIDER.
