This ordinance clarifies the city's zoning regulations for agricultural and agriculturerelated land uses. Specifically, the ordinance:

1. Defines the terms "raising of livestock," "community garden" and "commercial farming establishment" and specifies the use classification (i.e., permitted use, special use, etc.) of these uses in the various zoning districts.

2. Requires the operator of a community garden to register the garden with the commissioner of city development or the commissioner's designee.

3. Permits an accessory building on a residentially-zoned lot not containing a principal building, provided the principal use of the lot is the raising of livestock, a community garden or a commercial farming enterprise. Presently, accessory buildings are prohibited on lots that do not contain principal buildings.

4. Provides that if the principal use of a residentially-zoned lot is the raising of livestock, a community garden or a commercial farming establishment, the maximum total lot coverage for all accessory structures shall be the maximum lot coverage for principal buildings in the zoning district in which the lot is located.

5. Defines 2 types of agricultural accessory structures – "large agricultural structures" and "hoop" houses and, together with a third types of agricultural accessory structure ("shed"), specifies the maximum number of agricultural accessory structures and maximum lot coverage by agricultural accessory structures for residentially-zones lots.

6. Establishes minimum setbacks and maximum heights for the 3 types of agricultural accessory structures.

..Body

The Mayor and Common Council of the City of Milwaukee do ordain as follows:

Part 1. Section 200-33-5-f of the code is renumbered 200-33-5-g.

Part 2. Section 200-33-5-f of the code is created to read:

200-33. Fees.

5. BUILDING PERMITS.

f. Hoop Houses. There shall be no building permit fee for a hoop house.

Part 3. Section 200-33-8.5-a-10 of the code is created to read:

8.5. CERTIFICATES OF OCCUPANCY.

a. Certificates of Occupancy.

a-10. The required fee for a certificate of occupancy for a commercial faming enterprise shall be \$25.

Part 4. Section 200-42-2-a of the code is amended to read:

200-42. Certificate of Occupancy.

2. WHEN REQUIRED.

a. It shall be unlawful to occupy or use, or offer too occupy or use any building, structure or premises now existing or hereafter erected unless or until a certificate of occupancy has been issued by the commissioner, except as provided in s. 200-43 and s. 295-303. A separate certificate of occupancy shall be obtained for each occupancy and use stated in ch. 295 >>, including a commercial farming enterprise, << or any other regulation of this code. A new certificate of occupancy shall be required each time there is a change in the operator or tenant of a non-residential premises.

Part 5. Section 275-81-5-b of the code is amended to read:

275-81. Sanitary Conditions.

5. MAINTENANCE OF PREMISES.

b. Every premises shall be maintained in an erosion-free and dust-free condition utilizing suitable landscaping, grass, trees, shrubs or other planted ground cover or, except in the case of a premises occupied by a single-, 2- or multi-family dwelling, other suitable means approved by the commissioner. >><u>Crops, vegetation or other planted material shall be reasonably maintained to prevent a public nuisance, as determined by the commissioner.</u>

Part 6. Section 295-201-106, 112, 282 and 312.5 of the code is created to read:

295-201. Definitions.

106. COMMERCIAL FARMING ENTERPRISE means a premises used to grow and harvest plants or compost for sale to the general public, retail businesses or wholesale establishments. This use does not include community gardens or outdoor storage facilities.

112. COMMUNITY GARDEN means any use of land or a premises for the growing of crops, plants or other vegetation by a group of individuals or by a public or non-profit

organization. This use includes composting and the raising of crops, native vegetation or fruit not otherwise in violation of this code. It also includes the sale of produce and ornamental crops grown on-site. This use does not include a commercial farming enterprise or outdoor storage facilities.

282. HOOP HOUSE means a temporary or permanent structure typically constructed with, but not limited to, piping or other material covered with translucent material for the purpose of growing food or ornamental crops, but nor for storage of inorganic materials. A hoop house is considered more temporary than a greenhouse.

312.5. LARGE AGRICULTURAL STRUCTURE means an accessory structure that does not fit the definition of a hoop house and that is greater than 150 square feet in area. This term includes a rain catchment system.

Part 7. Section 295-201-473 of the code is repealed and recreated to read:

473. RAISING OF LIVESTOCK means the use of land or buildings for aquaculture, or the keeping of bees, cows, cattle, horses, sheep, swine, goats, chickens, ducks, turkeys, geese or any other domesticated livestock if permitted by the health department under the provisions of ch. 78.

Part 8. Section 295-203-14-b of the code is repealed and recreated to read:

295-203. Use Definitions.

14. AGRICULTURAL USES.

b. "Raising of livestock" means the use of land or buildings for aquaculture, or the keeping of bees, cows, cattle, horses, sheep, swine, goats, chickens, ducks, turkeys, geese or any other domesticated livestock if permitted by the health department under the provisions of ch. 78.

Part 9. Section 295-203-14-c and d of the code is created to read:

c. "Community garden" means any use of land or a premises for the growing of crops, plants or other vegetation by a group of individuals or by a public or non-profit organization. This use includes composting and the raising of crops, native vegetation or fruit not otherwise in violation of this code. It also includes the sale of produce and ornamental crops grown on-site. This use does not include a commercial farming enterprise or outdoor storage facilities.

d. "Commercial farming enterprise" means a premises used to grow and harvest plants or compost for sale to the general public, retail businesses or wholesale establishments. This use does not include community gardens or outdoor storage facilities.

Part 11. Section 295-423 of the code is created to read:

295-423. Agricultural Uses. 1. REGISTRATION OF COMMUNITY GARDENS. No person may establish or maintain a community garden without first registering the garden with the commissioner of city development or the commissioner's designee on a form provided therefor by the commissioner or designee.

2. COMMUNITY OUTREACH. At the time of submitting an application for registration of a community garden, the applicant shall submit to the commissioner of city development or the commissioner's designee a description of the applicant's outreach to the surrounding neighborhood to develop public awareness of, and support for, the proposed community garden. Such outreach may include, but shall not be limited to, circulation of petitions of support or distribution of fliers in the surrounding neighborhood.

3. COUNCIL MEMBER NOTIFICATION. The commissioner of city development or the commissioner's designee shall provide a copy of the community garden registration application to the local common council member.

4. FEE. There shall be no fee for the registration of a community garden.

5. COMPLIANCE WITH OTHER REGULATIONS. Every community garden or commercial farming enterprise shall comply with the relevant provisions of chs. 68, 78, 79 and 275.

6. REVOCATION OF REGISTRATION. The commissioner of neighborhood services may revoke the registration of a community garden upon determining that the community garden is not in compliance with any provision of this chapter or ch. 68, 78, 79 or 275.

r. Raising of Livestock. The use is limited to the raising of chickens or bees, as permitted under ch. 78.

Part 15. Section 295-505-3-b of the code is amended to read:

295-505. Design Standards.

3. ACCESSORY STRUCTURE STANDARDS.

b. Principal Building Required. No accessory building shall be located on a lot not containing a principal building >>, unless the principal use of the lot is for the raising of livestock, a community garden or a commercial farming enterprise<< . If a principal building >>or use<< on a lot is removed, any accessory building on the lot shall also be removed within 60 days and the premises made compliant with this code.

Part 16. Section 295-505-3-p of the code is renumbered 295-505-3-q.

Part 17. Section 295-505-3-p of the code is created to read:

p. Accessory Structures for Agricultural Uses. p-1. Permitted Structures. The following accessory structures supporting the raising of livestock, a community garden or a commercial farming enterprise shall be permitted:

p-1-a. Sheds.

p-1-b. Large agricultural structures.

p-1-c. Hoop houses.

p-2. Maximum Number. Not more than one shed and one large agricultural structure may be located on a single lot. The number of hoop houses on a single lot is unlimited.

p-3. Lot Coverage. The total lot coverage of all sheds, large agricultural structures and hoop houses on a single lot shall not exceed 70% of lot area. The total lot coverage of sheds and large agricultural structures on a single lot shall not exceed 15% of lot area.

p-4. Setbacks. p-4-a. The minimum front setback, side street setback or rear street setback for a shed, large agricultural structure or hoop house shall be the average plus 5 feet.

p-4-b. The minimum side setback or rear setback for a shed, large agricultural structure or hoop house shall be 5 feet.

p-5. Maximum Height. p-5-a. The maximum height of the sidewall of an agricultural accessory structure shall be 8 feet for a shed, 10 feet for a large agricultural structure and 14 feet for a hoop house.

p-5-b. The maximum overall height of an agricultural accessory structure shall be 10 feet for a shed, 14 feet for a hoop house, 14 feet for a large agricultural structure on a vacant lot, and 24 feet or the height of the principal building for a large agricultural structure on a lot containing a principal building.
