## **Accomplishments and Activities in 2013**

**On January 15, 2013,** several members of the committee attended a meeting with the Consul General of Indonesia, Andriana Supandy, in the Common Council Chambers Anteroom of City Hall. Indonesian dignitaries, Common Council persons, staff and several guests met and discussed economic opportunities, common interests and goals, the City of Milwaukee's Sister Cities program, and collaboration possibilities. A framed photograph and resolution were presented to the Indonesian dignitaries in honor of their presence. Minutes of this meeting are attached to this report as **Exhibit A.** 

**On February 11 and March 4, 2013,** letters were sent to Irish Festivals, Inc. and the African American Chamber of Commerce to request 2013 annual reports regarding sister city relationship activities with Galway, Ireland and uMhlathuze, South Africa respectively. Copies of these letters are attached to this report as **Exhibit B.** 

**On May 1, 2013,** the sister city relationship with uMhlathuze, South Africa expired. No renewal application was received from the local sponsor, African American Chamber of Commerce. A renewal application was sent to the local sponsor on August 2, 2012. The application was due on November, 1, 2012, six months prior to the expiration date. Despite the expiration of the sister city relationship with uMhlathuze, South Africa, there is an ongoing relationship between the University of Wisconsin – Milwaukee and the University of Zululand.

No annual report was received regarding the sister city relationship with uMhlathuze, South Africa for the year 2013. The annual report was due on May 17, 2013.

**On July 29, 2013,** an informational letter regarding the City's sister city program was sent to the Kumba City Council in Cameroon, as it had sent a letter to the Mayor's Office on June 6, 2013, expressing an interest to cooperate and twin with the City of Milwaukee. These letters are attached to this report as **Exhibit C.** 

**On August 15, 2013,** the sister city relationship with Galway, Ireland expired. No renewal application was received from the local sponsor, Irish Festivals, Inc. A renewal application and cover letter were sent to the local sponsor on November 2, 2012 and a second time on July 29, 2013. The second cover letter is attached to this report as **Exhibit D.** The application was due on February 15, 2013, six months prior to the expiration date.

**On August 26, 2013,** the 2013 annual report was received regarding Galway, Ireland from Irish Festivals, Inc. The annual report was due on April 26, 2013, and it is attached to this report as **Exhibit E.** 

**On September 4, 2013,** a letter was sent to request the 2013 annual report for Carora, Venezuela from the local sponsor, The Peace Education Project of Peace Action

Wisconsin. The letter is attached to this report as **Exhibit F.** The 2013 annual report concerning Carora was not received and was due on November 8, 2013.

**On September 22, 2013,** the renewal application regarding the sister city relationship with Carora, Venezuela, was received from the local sponsor, The Peace Education Project of Peace Action Wisconsin. The relationship expires March 24, 2014. The renewal application is attached to this report as **Exhibit G.**

## Meeting with Consul General of Indonesia Andriana Supandy January 15, 2013 Common Council Chambers Anteroom

Meeting convened at 2:00 p.m.

## 2:00 p.m. Welcome

Indonesian dignitaries arrived and were greeted by City of Milwaukee Common Councilpersons, staff, and guests in attendance.

Ald. Joe Davis, Sr. and President Willie Hines, Jr., City of Milwaukee Common Council, gave opening remarks. President Hines thanked the Indonesian dignitaries of their visit and said that the visit is an opportunity for information and service exchanges between the City of Milwaukee and Indonesia. Ald. Michael Murphy and Ald. Nik Kovac, City of Milwaukee Common Council, were introduced.

## 2:05 p.m. Presentation of Global Appreciation

President Hines presented a resolution from the City of Milwaukee Common Council to the Consul General (Indonesian Consulate General) in honor of the dignitaries' presence, and Ald. Davis presented a framed photograph to the Consul General.

#### 2:20 p.m. Introduction of Indonesian Delegation

The Indonesian delegation was introduced. Present were:

#### 2:30 p.m. Official Remarks

Consul General (CG) Supandy thanked City officials, staff, and guests for a warm welcome and hospitality. CG Supandy gave remarks. Milwaukee is a neighbor of Chicago, where he is stationed. Today's visit is his first visit to Milwaukee and only one of many stops in the City. The purpose for today's visit is to know Milwaukee better and facilitate possibilities for economic growth for Indonesia and Milwaukee.

#### 2:50 p.m. Presentation of Economic Opportunities

Ms. Luber gave a brief description of the Milwaukee Economic Development Corporation (MEDC). MEDC works closely with the City of Milwaukee in the private sector and is a compliment to private bank financing. MEDC has a 55 million dollar portfolio and has been around for forty one years. MEDC provides low cost loans to fill the gap for businesses that cannot get enough bank financing. In the last five years, MEDC has funded 90 million dollars in new loans, leveraged about 300 million dollar private investments with 60 percent of those loans going towards minority or female owned businesses in highly distressed areas in the City of Milwaukee. Goals of MEDC are to fill in the gap, assist in projects with jobs, and aide in job retention. Ald. Davis, Hines, Murphy, and Kovac are on the executive board. MEDC is open to provide assistance and be a partner.

Mr. Kraft gave a brief description of FirstPath Partners, LLC (FPP). FFP works with MEDC and the City of Milwaukee to invest money in the southeast region of Wisconsin in a program called "EB5." FPP was founded five years ago and raised about 150 million dollars. This year,

200 million dollars from around the world are raised for projects for job creation in a specific economic development area. The program operates nationwide and is focused on southeastern Wisconsin. FPP can work with Indonesian companies that come into the region.

### 3:05 p.m. Presentation of City of Milwaukee's Sister Cities International Program

Ald. Davis said that he serves as an honorary consul to the Republic of South African and is the chair of the Sister Cities Committee in Milwaukee. He added that he is hopeful the Indonesian delegates will be given a good first impression regarding Milwaukee's friendliness and resources that it has to offer publicly and privately.

Ald. Davis proceeded to give an overview regarding opportunities and cultural ties in the City of Milwaukee. Milwaukee welcomes international investment. FirstPath Partners has attracted over 200 million dollars into the region in areas such as manufacturing, industrial, and hospitality. Milwaukee is home to the beautiful Quadracci Pavilion, Milwaukee Harley Davison Museum, and Potawatomi Bingo and Casino. The Midwest attracts research dollars due to great institutions such as those in Milwaukee like the University of Wisconsin - Milwaukee, Marquette University, Milwaukee School of Engineering, and Milwaukee Area Technical College. Milwaukee's location makes travel easy to other cities in neighboring states within a day. The driving distance between Chicago to Milwaukee is 90 miles, and there is a commuter train between these cities. General Mitchell International Airport in Milwaukee is a convenient and user friendly airport that international guests can use to make multiple stops with direct flights into Canada and Mexico and take flights to other major cities nationwide. The airport is less congested than other airports such as those in Chicago. Downtown Milwaukee has the 190,000 square feet Delta Airline Convention Center with exhibit and meeting spaces that delegates can use for conferences. The US Cellular Arena, Milwaukee Theater, first class hotels, and many restaurants and Ethnic dining options are also located in downtown Milwaukee. In all, Milwaukee has attractions, is user friendly, and has affordable accommodations compared to Chicago.

Ald. Davis further gave an overview of the Sister Cities Committee and relationships with the City of Milwaukee. Milwaukee has five relationships: Galway, Ireland; Carora, Venezuela; Morogoro, Tanzania; uMhlathuze, South Africa, and Ningbo, China. For a formal sister city relationship the process first beings when a local non-governmental organization (NGO) submits a letter of interest. A meeting is scheduled by the committee where the NGO makes a presentation on the intent, cultural, and economic goals of the relationship. The committee may approve and extend a formal application to the NGO. The NGO would have 90 days to file an application. Once an application is received, the committee would schedule for a final presentation to be made by the NGO. If the committee approves the application, an official signing ceremony will be scheduled. A successful relationship is for five years. Only NGOs from both cities are involved in a relationship because the NGOs should not be engaged in political activities.

## 3:20 p.m. Roundtable Discussion, Theme: "Common Interest – Common Goals"

Mr. Pardede gave an overview on the volume of trade between Indonesia and Midwest states in the United States. The Indonesian Consulate is headquartered in Chicago, Illinois and incorporates 13 Midwestern states. In 2011, the total trade value between all Midwestern states and Indonesia was 4.1 billion U.S. dollars. Illinois was number one in trade value followed by Ohio, Kentucky, and Wisconsin. There was a big gap between the export trade value to Wisconsin (381 million dollars) and import trade value from Wisconsin (74 million dollars). In 2012 for the first three quarters, the total trade value between Indonesia and Wisconsin was 430 million dollars and will likely eclipse 2011 trade values once fourth quarter values are known. Wisconsin moved from being fourth in 2011 to being third in 2012 in total trade value with Indonesia compared to other Midwestern states. There is a desire to identify opportunities for further export from Wisconsin to lessen the gap in the export and import trade value between Wisconsin and Indonesia. Also, both parties should go beyond traditional trade to expand to other avenues.

Mr. Pardede said that from 2008 to 2011, top export commodities from Indonesia to Wisconsin included apparel articles, accessories, wood, footwear, and furniture. Top import commodities to Indonesia from Wisconsin from 2008 to 2011 were mostly technological and included nuclear equipment, electric equipment and machinery, seed, fruit, plant, medical equipment, and food industries. Indonesia has very good resources for minerals and energy sectors. It is ranked number one in mineral wealth. Indonesia has a demand for hospital and health care growth, which Wisconsin can expand on its medical equipment that it has to offer. Indonesia lacks food processing sectors for its abundant natural resources such as coffee, cocoa beans, palm oil, and vanilla. Food processing trade can be a fast potential for business for Wisconsin.

Mr. Pardede said that Indonesia hosts a big annual international trade expo in October. A variety of businesses from mining, agriculture, to tourism sectors participate with about 6500 buyers and 2000 exhibitors. The expo can be a good opportunity for Wisconsin to be an investor and marketer. The president of the Republic of Indonesia opens the event, which also has high delegations from the world who attends the expo. During the 2012 expo, 38 exhibitors from other countries came to the expo to sell in the Pacific region. There was a company from Illinois that had a booth regarding railroad technologies and products.

Mr. Pardede proceeded to give an overview on the economy of Indonesia. The country has six big islands with a lot of potential and resources. From 2007 to 2012, the gross domestic product (GDP) of the country was stable at about 6.3 to 6.5 percent. For 2013, the projected GDP is 6.7 percent. Compared to other Asian countries, China leads all GDP while Japan's GDP is at a negative. Currently, Indonesia's GDP is about 855 billion U.S. dollars, and the economy is progressing. Indonesia is one of the biggest emerging economies. According to a BBC World Service survey, Indonesia is one of the best places for entrepreneurs to start a business. Based on the 2010 Census, Indonesia has 238 million people. The population has increased to 242 million people in 2012, and the middle class population is projected to increase to 170 million people by 2015. Indonesia is ranked 9<sup>th</sup> as a major destination for foreign direct investment (FDI). The cost of living is similar but costs more than Thailand.

Mr. Pardede said that Indonesia has a master plan for the acceleration and expansion of the country's economic development and that there are six economic corridors that possess investment opportunities. The six economic corridors are Java, Sumatera, Kalimantan, Bali-Nusa Tenggara, Sulawesi, and Kep Maluku-Papua. The Java corridor has food and beverage, transportation, and power plant possibilities. The Sumatera corridor has coal, power plant, iron and steel, airport, and railroad possibilities. The Kalimantan corridor has mining, energy, natural resources, and port possibilities. The Sulawesi corridor has agriculture, plantation, fishery, and nickel mining possibilities. The Bali-Nusa Tenggara corridor has tourism, food, and agriculture possibilities. The Kep Maluka-Papua corridor has food, fishery, energy, and mining possibilities.

### 3:50 p.m. Way Forward

Ald. Davis said that GE is one of the large Wisconsin companies that can work with Indonesia regarding medical equipment trade.

Mr. Savage said that he would be interested to see the number of Indonesian students and study abroad opportunities in Indonesia increase.

Ald. Davis said that he will reflect on the possibilities for growth between Indonesia and the City of Milwaukee. Ald. Davis added that the Consul General should think about what city fits with Milwaukee to create an active sister city relationship.

Ms. Luber said that MEDC can assist with facilitating introductory meetings with those companies under its portfolio that the Consul General would be interested with.

Consul General Supandy gave farewell remarks. Indonesia offers its expo, commodities, and sectors. He is headquartered close by in Chicago. Milwaukee has many things to offer, has made a good impression, and has extended a warm welcome. A sister city relationship will be one important thing to consider for the future, and he is hopeful that action will be taken.



Please note that a sister city relationship application progress requires a local nonprofit organization, that wishes to sponsor a sister city relationship, to submit a letter of intent to the Sister Cities Committee. The Committee shall invite the organization to make a presentation to the Committee regarding the proposed sister city relationship. Following the presentation, the Committee shall decide whether to invite the organization to submit a formal application to the City's Common Council.

If the Committee has invited the organization to submit a formal application, the Committee will schedule a formal hearing on the application and notify the organization to attend. If the Committee recommends approval of the application, it will be forwarded to the Common Council's Community and Economic Development Committee and then to the full Council.

We look forward to further exploring a possible sister city relationship with you. The City of Milwaukee is a member of Sister Cities International and adheres to its policies and procedures in reviewing possible relationships. We believe a limited number of such relationships are beneficial to cultural, economic and educational growth and development for all involved.



A formal renewal application was sent to you on November 2, 2012 requesting that you submit the renewal application by February 15, 2013. To date, our office has not received any renewal application from you. Another renewal application is enclosed for your completion.

Please note that in addition to some basic information, the renewal application requests detailed attachments regarding the sister city, your organization, and the organization in the sister city that will support this relationship. A thorough response to all questions will be most appreciated and will strengthen your renewal application.

The Sister Cities Committee will schedule a formal hearing on your renewal application, and you will be notified to attend. If the Committee recommends approval of the renewal application, it will be forwarded to the Common Council's Community and Economic Development Committee and then to the full Council.

We look forward to further exploring this sister city relationship with you. The City of Milwaukee is a member of Sister Cities International and adheres to its policies and procedures in reviewing possible relationships. We believe a limited number of such relationships are beneficial to cultural, economic, and educational growth and development for all involved.



Goals:

We support President Eisenhower's original Sister Cities mission through relationships based on cultural, educational, and informational exchanges through person-to-person "citizen diplomacy." We strive to connect the citizens of Milwaukee and Carora by facilitating opportunities to make meaningful connections and lasting relationships. We also strive to cultivate economic, educational, and cultural programs that are sustainable and mutually beneficial.

## Methods used to reach these goals:

The hosting of education events, the utilization of social media and online resources (Sister Cities website and Peace Action website), and the providing of opportunities to visit Venezuela are the primary methods we use to reach our goals, and we have hosted a number of gifted activists and speakers that focus on Venezuela and have facilitated people-to-people connections, some of which are listed below:

Charles Hardy, a former priest from Wyoming who spent eight years living in a cardboard shack in a dangerous, poverty-stricken "barrio" of Venezuela as part of his religious mission, came to Milwaukee to share his published memoir entitled *A Cowboy in Caracas*. The book is a unique blend of culture and history, as seen through the eyes of a man committed to working with some of the poorest and most marginalized people in the world. Mr. Hardy's perspective is humorous and optimistic, although many of his experiences were anything but so. His visit was greatly contributed to an understanding of Venezuelan culture for all in attendance.

Dr. Mark Weisbrot is an economist and co-director of the Center for Economic Policy and Research who has served (and continues to serve) as an economic advisor to a number of Latin America nations, including Venezuela. Mr. Weisbrot gave the audience an expert analysis of the history and reality of Venezuela's politics, economics, and culture, and also shed light on many questions about daily life for Venezuelans and their government's foreign policy (including prospects for improving relations with the United States).

Gregory Wilpert, together with Martin Sánchez, launched Venezuelanalysis.com in September 2003. Founding member of the Milwaukee-Carora Sister Cities Committee, a UW-Milwaukee Alumnus and current Georgetown law student who was also a legal observer for the April, 2013 Venezuelan election, was employed by Venezuelanalysis.com while living in Carora. We continue to circulate this website as an educational tool in understanding Venezuelan culture and politics.

Eva Golinger is an author and the editor of the *Correo Orinoco*, a leading Venezuelan bi-lingual publication. Her journalistic contributions have helped us understand Venezuelan history and politics, and catapulted her to stardom in Venezuelan television and print. A warm person and captivating speaker, Milwaukee residents benefitted greatly from her visit.

Jessica Luna is a Venezuelan student activist based in Caracas. She studies agrology and her main volunteer work is in urban gardening and the cooperative movements in low-income neighborhoods of Caracas. She visited with local faculty at UW-Milwaukee, as well as tours

with the Riverwest Coop and Growing Power. She also delivered a public presentation, free of charge, of her work in Venezuela (on August 23, 2013, at Brewing Grounds for Change).

Each year, we co-host a film fest entitled Documentaries Del Sur. This is a local, multi-night film series held at the University of Wisconsin Milwaukee in partnership with local and student organizations. This film fest offers a variety of films, many of which are focused directly on Venezuela and its culture, politics, etc. Attendance throughout the fest usually reaches about 350 people, who leave with a greater grasp of the reality of life in our Sister city. We have also included special guests at this fest, including Emmy Award-winning director, Saul Landau.

Erik Sperling, current law student at Georgetown University and Co-Founder of the Sister Cities relationship, was invited to monitor the April, 2013 elections in Caracas, Venezuela. He was also able to visit Carora while on that trip and meet and discuss with folks we have been working with there since 2007. MCSCC also hosted a Venezuelan election party in April of 2013, complete with traditional Venezuelan food, Venezuelan television via the internet, and skype video calls with Venezuelan friends in our Sister City. This was very enjoyable, and we look forward to doing more.

We have also had a chance to cultivate people-to-people connections between Carora and Milwaukee. On more than one occasion, Mike Helbick, President of the Milwaukee-Carora Sister Cities Committee, collaborated musically with local Caroran musicians, including a band named Fusioncayado. A blend of traditional Venezuelan styles and modern rock, this band includes a seasoned artist who has played concerts in the United States as well promising, young musicians. In Fusioncayado's recording studio, Mike was able to perform with the band and record an original song with traditional Venezuelan influence. We look forward expanding the opportunity to mix our artistic styles and talents across continents.

In 2007, we launched our pilot Sister Cities delegation. Delegates learned about Carora's renowned "participatory democracy" and witnessed innovative social programs and progress in urban gardening, education, healthcare, housing, and more. The delegates also found themselves immersed in Venezuelan culture and enjoyed traditional dance, art, and poetry. Most importantly, they made meaningful connections to the people of Venezuela in Milwaukee's Sister City, Carora. We look forward to our upcoming delegation in January, 2014 and are sure it will be even more exciting and successful than the first!

## Current activities:

The Milwaukee-Carora Sister Cities Committee is partnering with Peace Action Wisconsin, Edward Mercado of Waya Tour, and the Venezuelan Consulate of Chicago to facilitate a Sister Cities trip to Venezuela in January, 2014.

This delegation, comprised of delegates from the cities of Milwaukee and Madison, will visit Milwaukee's Sister City of Carora and Madison's Sister City of Sanare. The goal of this delegation is not only to facilitate, in the tradition of Sister Cities International, a people-to-people connection across cultures, but also to facilitate lasting relations and partnerships between these four cities.

Throughout this trip, delegates will experience and learn about the rich traditional culture of Lara State, including music, poetry, and crafts. Delegates will also learn about new advancements in education, health care, and nonprofit initiatives in Carora and Sanare. Further, this delegation will seek to economically connect these four cities for mutually beneficial future exchanges of goods and services. We believe that this trip will benefit not only all individuals involved, both Estadounidense and Venezuelan, but will also benefit these participating cities at large. A highlight of this trip will be meeting with our counterparts in our Sister Cities that are charged with maintaining the Sister Cities relationship on their end. We look forward to sitting down with them and discussing more projects, moving forward. The Venezuelans are excited to host us!
