1. Description of Grant Project/Program (Include Target Locations and Populations):

DCD has received grant funds from the Mortgage Guaranty Insurance Corporation to plan, coordinate, promote and conduct local Global Youth Service Day ("GYSD") 2014 activities on April 11-13, 2014. Grant funds will be used to increase the scale, visibility and impact of GYSD 2014 by convening a planning coalition of at least 10 partner organizations that will engage 2,200 youth volunteers in 55 service projects, engage local media and elected officials, and plan a high-profile signature event and celebration of service. In 2013, DCD served as Milwaukee's Lead Agency and helped provide community service and service-learning activities for nearly 1,600 students from 29 schools and community-based organizations.
