 jurisdictions and citizens the opportunity to shape the various housing and community
 development programs into effective, coordinated neighborhood and community development
 strategies.
- 2) Funding Allocation Plan with proposed funding categories for Funding Year 2015.

 The Funding Allocation Plan incorporates strategic direction for the following grants:

 Community Development Block Grant funding, HOME Investment Partnerships,

 Emergency Solutions Grants (ESG) and Housing Opportunities for Persons with AIDS (HOPWA).

The City of Milwaukee Community and Economic Development Committee will hold two public hearings to obtain citizen comments on both the proposed Consolidated Plan and the proposed 2015 Funding Allocation Plan.
