SCHEDULE C - GENERAL MATTERS

MOTION:

"Hereby moved that beginning September 17, 2014, the position of Management Trainee is exempt from the approval procedure provided for under s. 18-10-6 c-3 of the City Charter."

Rationale: The City Charter establishes a review and approval procedure for the filling of vacant positions. The position of Management Trainee has been created to serve as an alternate recruitment path for City employment. Trainee assignments are explicitly limited in duration, usually to 12 months, and Trainees may be assigned to any City department. Therefore, the value of approving the filling of these vacancies is limited. In addition, departments who wish to assign a management trainee to a regular City position will continue to be required to seek approval to fill such a vacancy.
