



Dear Elizabeth,

I am writing to follow up on our phone conversation.

My wife and I called a Yellow Cab to return home from the clinic across the street from the Orthopedic Hospital in Glendale (575 W. River Woods Parkway) at approximately 11:20am, and were picked up by Taxi #243 around 11:30. I did not get the driver's name, but his phone number is (414) 628-2656.

The behavior of this driver was completely outrageous:

1. My wife has a broken ankle and is using a small scooter to get around. After assisting her getting into the cab, and placing the scooter in the back of the van, the driver attempted to leave without me. I had to bang on the window to get him to stop.

- 2. The driver had his window open. My wife was feeling cold and politely asked him to close the window. She had to ask three times before he did it, and it clearly upset him.
- 3. When we arrived, as she was getting out of the cab (which she has to do slowly and carefully) the driver closed the automatic door and it hit her bad leg. He was looking back at her before doing so and I can only assume he did it on purpose.
- 4. We both yelled at him to stop closing the door. After we were both out, he yelled "I will pray to God that you break your other leg!"

This man should not be driving a cab, or doing anything else where he interacts with customers. While I realize the cab drivers are independent contractors, I don't think you want someone like this representing your company. I hope that the actions of this driver will be reviewed and appropriate action taken.

As you suggested, I will also be calling the Taxi Licensing Department once you have confirmed receipt of this message and identified the driver involved.
