<u>Purpose of Amendment</u>: This is a Vendor Service Contract for hardware upgrades and annual maintenance for the Legistar Suite and ConTrack systems powered by GovQA.

Justification for Waiver:

Granicus, Inc. is the single software developer and distributor of the Legistar and ConTrack systems that were originally purchased in 2008 for public web access to over 50,000 Common Council files and attachments. Legistar 5 is the City's legislative tracking software that is accessed by the other departments and the general public via the internet. ConTrack is utilized by the Mayor's office and aldermen to track constituent requests. The Legistar and ConTrack software products are proprietary and require regular database maintenance by Granicus. Granicus purchased the original contractor, Daystar Computer Systems, Inc. in 2011.
