Capital Improvement Projects

- Concentrated Blight Elimination
 - □ \$1,319,000 for demolition
 - Code Compliance Loan Program
 - \$500,000 for loans to improve housing conditions and preserve owner-occupancy
 - Anderson Tower Remodel
 - 2 year project: \$650,000
 - Garage converted to office space in 2015: \$425,000
 - Reconfigure 2nd floor in 2016: \$225,000

- Condemnation & Demolition
 - Part of Strong Neighborhoods Plan
 - Two additional positions funded
 - Condemnation Program Coordinator (\$59,688)
 - Program Assistant II (\$42,118)
 - Needed to manage large volume of vacant, foreclosed and abandoned properties
 - Coordinate demolition activity, monitor and inspect properties, oversee condemnation activity

- BOZA Compliance Inspection Program
 - □ Two Special Enforcement Inspector added (\$126,000)
 - Periodic inspection program to monitor property
 - Confirm activity and use of property complies with zoning code and any permitted use, variance, special use, limited use or plan of operation approved by BOZA
 - Inspection intervals based on nature of business and potential impacts on neighborhood
 - Improve compliance and reduce problems with business and other establishments
 - Proactively prevent problems

- Code Compliance Loan Program
 - Part of Strong Neighborhoods Plan
 - Expand program
 - \$500,000 in capital account
 - DNS inspectors refer residential properties for repairs needed to correct code violations
 - 0% interest Deferred Payment Loan
 - Allows owner to retain property and avoid tax foreclosure
 - Limited to low-income persons that are not tax delinquent and properly insured

- Residential Rental Inspection Program
 - Program sunset to end Jan. 1, 2015
 - Mayor Barrett's proposal:
 - Continue program in Lindsay Heights & UWM neighborhoods
 - Expand program to St. Josaphat Basilica neighborhood
 - Add two additional Residential Code Enforcement Inspectors
 - □ \$109,000 in additional costs
 - \$106,000 in anticipated revenue recognition

- Demolition funding shifted to capital
 - Part of Strong Neighborhoods Plan
 - \$1,319,000 in Special Fund moved to new Capital account for demolition
 - Concentrated blight elimination capital funds can be used for demolition and deconstruction
 - Estimated 144 demolitions and 18 deconstructions to occur in 2015

Departmental Milestones

- Residential Rental Inspection has improved rental housing conditions and reduced complaints of a serious nature by 60%
- Special Enforcement will impact over 3,000 nuisance properties this year
- Over 1,800 active cases are in the monthly reinspection program
- An estimated 600 properties will be placarded as unsafe or unfit

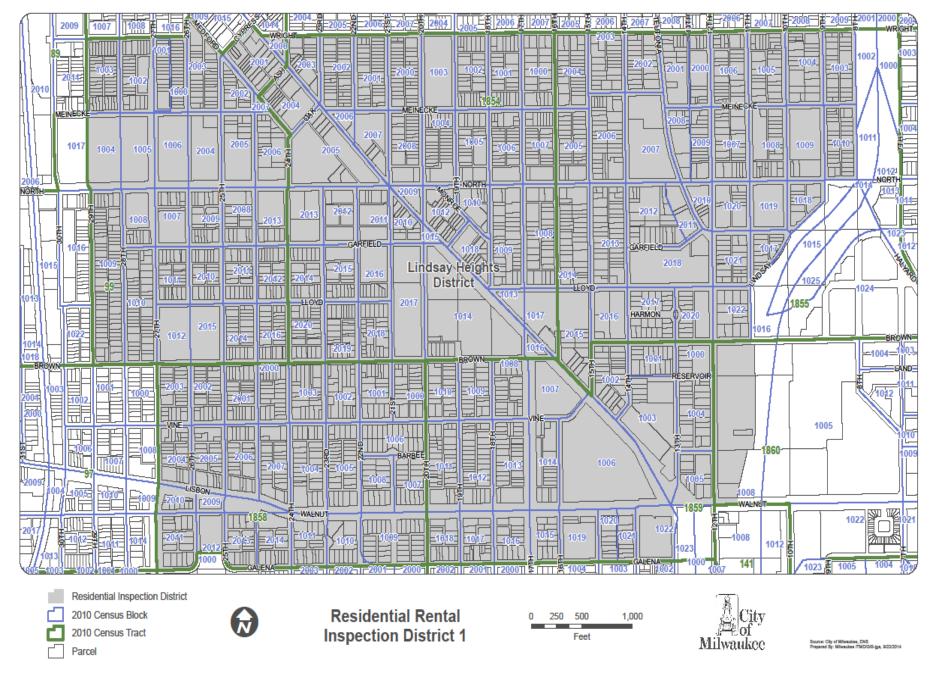
Departmental Milestones

- Over 850 buildings will be boarded up this year
- Over 72,000 inspections of vacant and foreclosed properties this year
- Expect 162 demolitions to occur in 2015

Departmental Milestones

- DNS is meeting established development plan review timelines 92% of the time compared to 85% in 2013 while submissions increased 8%
- Land Management System on track to be stood up in March of 2015

Proposed RRI Districts

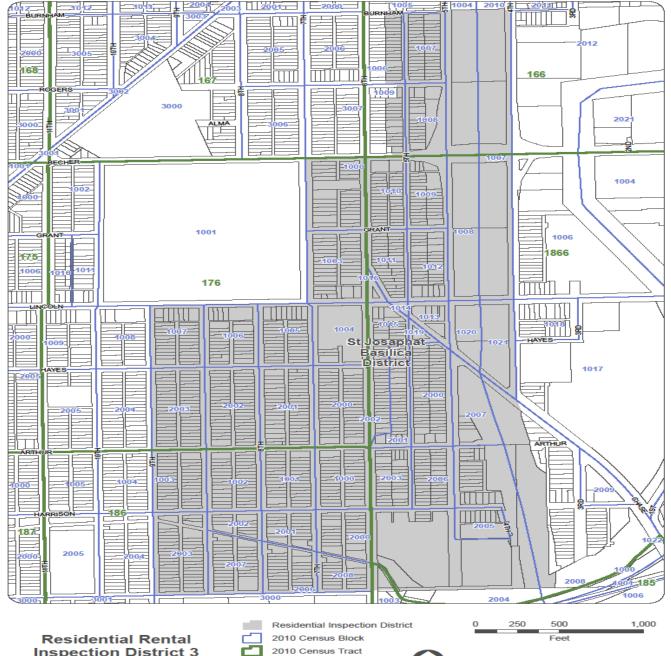




Residential Rental Inspection District 2
