Enclosed please find a proposed resolution. We ask that it be introduced and referred to the Committee on Judiciary & Legislation, with the following recommendation.

Claimant, 342 North Water, LLC, alleges through Pieper Properties, by its representative Ann Pieper Eisenbrown, 234 West Florida Street, Milwaukee, WI 53204 that on April 8, 2014 they sustained damages when a City crew drilled through the wall of their property located at 342 North Water Street. They claim damages in the amount of \$8,766.10.

Infrastructure Services Division records indicate that on April 8, 2014 a DPW Street Maintenance crew was working in the 300 block of North Water Street. They damaged a hollow walk/building wall at 342 North Water Street.
