Mr. Brothers,

Your name and e-mail address was listed as the manager which oversees alarm sales conducted by door-to-door sales representatives for the Vision Security Company located in Orem, UT.

The below complaint regarding Vision Sales Rep Bradley Collins was reported to me today by Mrs. Willie Bowen on behalf of Ms. Lucy Bowen.

Mrs. Willie Bowen advised me that Bradley Collins, while conducting door-to-door sales for Vision Security engaged her mother-in-law, Lucy Bowen at Ms. Bowen's residence, 2934 N. 26th St., Milwaukee, WI, on Saturday, August 11, 2012 in an effort to sell Ms. Bowen an alarm system. Ms. Bowen is 96 years old, suffers from alzheimers disease, and also experiences "tremors", shaking of her hands.

Bradley Collins proceeded to convince Ms. Bowen to purchase a Vision Security alarm system. According to Mrs. Willie Bowen, Bradley Collins forged Ms. Bowen's signature on the alarm system contract because Ms. Bowen is unable to sign due to her tremors. Ms. Bowen lives with her adult son caretaker who was not home at the time. Bradley Collins then proceeded to dismantle the current ADT system that Ms. Bowen has been using for the past 15 years and installed the Vision Security equipment.

Mrs. Willie Bowen feels that her mother-in-law was taken advantage of by Bradley Collins and is currently in contact with the Vision Security Customer Service Department, "Sean" and "Craig" in an effort to cancel the installation and contract. Mrs. Bowen contacted ADT to re-install the equipment that was dismantled by Bradley Collins. Mrs. Willie Bowen stated that ADT will charge her a fee for re-installing equipment that never should have been removed.

Back in May of this year I was notified by Milwaukee Police Department District Liaison Officer Shellee Lubus that she has received complaints of unethical sales practices regarding door-to-door sales reps claiming to be from "GE Vision." Officer Lubus stated that the complaints involve incidents of the reps being overly aggressive with the citizen who answers the door, asking personal questions, and using scare tactics in an effort to sell their system. Further investigation is being conducted to confirm whether the GE Vision sales reps are one and the same as the Vision Security reps.

The incident involving Ms. Lucy Bowen will be recorded and forwarded to the Milwaukee Police Department License Investigation Unit for possible Alarm Sales License revocation for the Vision Security Company.

Please remind the Vision Security sales reps that are currently selling alarm systems in Milwaukee the importance of proper and ethical sales practices.
