Report on the renewal applications of Habib Manjee, Agent for Lady Bug Club, LLC, for Class "B" Tavern and Public Entertainment Premises licenses for the premises located at 622 North Water Street in the City and County of Milwaukee, Wisconsin ("Ladybug Club/618

Live On Water").

- Habib Manjee ("Licensee") is the holder of Class "B" Tavern and Public Entertainment Premises 1. licenses for the premises located at 622 North Water Street in the City and County of Milwaukee, Wisconsin ("Ladybug Club/618 Live On Water"). Said licenses expire at midnight, December 20, 2014.
- An application to renew said licenses was filed with the Office of the City Clerk on September 29, 2. 2014.
- Pursuant to Chapters 90 and 108 of the Milwaukee Code of Ordinances and Chapter 125 of the 3. Wisconsin Statutes, the matter was referred to the Milwaukee Police Department for investigation. On September 30, 2014, the Milwaukee Police Department responded with a police report that could form a basis for non-renewal or suspension of said license.
- On November 21, 2014, the City Clerk's Office provided timely notice to the Licensee pursuant to 4. Chapters 90 and 108 of the Milwaukee Code of Ordinances and Chapter 125 of the Wisconsin Statutes and included therewith a copy of the Milwaukee Police Department report. The matter was scheduled for a hearing on December 1, 2014, commencing at 1:30 p.m. in Room 301B of City Hall, 200 East Wells Street, Milwaukee, Wisconsin 53202. At said date, time and place, the Licensee appeared and was represented by Attorney Frederick Gordon.
- 5. Based upon the sworn testimony heard and the evidence received at the hearing, the Committee finds the following:
 - A. On March 14, 2014 Milwaukee police observed a subject, while waiting in line to enter the tavern 618 Live, throw U.S. currency into the air. This caused people to run into the street, blocking traffic. There were approximately 100 people in line waiting to enter the business.



- B. On April 20, 2014 at approximately 1:30 a.m. Milwaukee police responded to the 600 block of North Water Street to assist with bar close. Officers observed two subjects fighting in the street in front of 628 North Water Street (Ultra Lounge). While investigating the fight, a third subject approached officers and asked for the status of one of the subjects involved in the fight. This subject left, but returned a short time later again asking officers about the status of one of the subjects involved in the fight. The subject again left, but returned a short time later armed with a semi-automatic pistol. This subject was arrested for disorderly conduct while armed and told officers he had been at Ultra Lounge prior to the incident. The two subjects originally detained were cited for disorderly conduct and told officers they had come from 618 Live (622 North Water Street). An incident report was filed.
- C. On May 24, 2014 Milwaukee police observed a fight in front of 618 Live (622 North Water Street). The investigation revealed that a group of approximately ten females were involved in a fight which stemmed from an incident which occurred inside the business. Four females were cited for disorderly conduct, two of which were under the legal drinking age of 21 and had used fraudulent identification to enter the business.
- D. On May 31, 2014 Milwaukee police were monitoring the closing of the tavern Club 618 (622 North Water Street). Security guards from the business informed officers that there was an altercation occurring in the Chase Bank parking garage (525 North Water Street). Officers observed a large group of individuals in the lower level of the parking garage. Some of these individuals left the parking structure, once alerted to the presence of police. Officers continued on to investigate and observed two subjects sifting in the front seat of a vehicle parked inside the garage. Closer inspection revealed several unfired cartridges lying on the ground next to auto. The subject sitting in the driver's seat fled on foot, but was apprehended by police after attempting to throw a loaded 9mm semiautomatic handgun into the Milwaukee River. The subject sitting in the passenger seat also fled on foot but was apprehended by security guards from Club 618. Following an altercation with police, this subject was also arrested. On May 31, 2014 at 10:00 p.m. a Milwaukee police sergeant was able to view photos taken at Club 618, which showed the suspects had been in the establishment before the incident occurred. A Milwaukee incident report was filed.
- E. On June 15, 2014 Milwaukee police observed four patrons fighting near the front door of 618 Live (622 North Water Street). One subject was cited for disorderly conduct, another subject was cited for disorderly conduct, misrepresent age, and presence of minor. Officers recovered a fake identification from the suspect and confirmed this was the identification used to enter the club from the club's printout.

- F. On August 2, 2014 Milwaukee police observed approximately 200 people waiting in line to enter 618 Live, officers observed two people involved in an altercation at the south end of the line. Both of these subjects were cited for disorderly conduct. The Milwaukee police mounted patrol unit was requested to assist in maintaining order.
- G. On August 3, 2014 Milwaukee police observed a subject being ejected from 618 Live (622 North Water Street). This subject was arrested and cited for disorderly conduct when he refused to leave the area and was observed by officers shouting profanity at security.
- H. On October 3, 2014 a Milwaukee police officer observed a stolen car being driven in the area of Old World Third Street and West Highland Avenue, The officer was later informed by other officers that the stolen auto was parked around the corner from 618 Live and that three occupants had exited the auto and were walking toward the club. It was believed that all three suspects entered the club prior to the arrival of police. After being informed of the situation by police, the applicant had club security trail the suspects which led to two of the suspects being apprehended. The apprehending officer writes "Without the clubs immediate assistance I would not have been able to get the information critical to the stolen auto complaint".
- I. On October 4, 2014 at 1:46 a.m. a Milwaukee police officer went over the air with a "huge fight" in front of 618 Live. Subsequently, the Milwaukee police mounted patrol and 15 additional police squads responded and discovered numerous separate fights in the area involving 20-40 people each. While investigating these fights, officers were told by staff from the bar that there were still approximately 150 people inside the tavern The officer who originally called for assistance regarding the "huge fight" indicates that he had been assigned to monitor the release of The Ultra Lounge and 618 Live, This officer observed a subject screaming, pounding and pulling on the front door of 618 Live after being ejected from the business. The applicant told police that this subject had been ejected for fighting inside the business and that the other combatant had been kicked out of the back door of the tayern. The two combatants located each other again after being ejected from the club and again began fighting. This incident led to other fights and other patrons gathering to view the commotion. Security staff from 618 Live was observed assisting officers break up the fights. 618 Live staff also provided police with video footage of the incident. Five subjects were cited as a result of the fights, officers were unable to detain additional subjects because of the number of fights occurring in close proximity to each other. At one point an officer used Oleoresin Capsicum "pepper spray" to stop the actions of one of the combatants. One of the suspects citied admitted to coming from the Ultra Lounge.

- J. On October 8, 2014 the applicant and representatives of The Ultra Lounge met with representatives of the Milwaukee police department and the Milwaukee City Attorney's office to discuss areas of concern including fights that occur on a regular basis at the end of the night. Several suggestions were made to help alleviate these issues. Some of the suggestions recommended for implementation by The Ultra Lounge, such as using an ID scanner, are already in place at 618 Live. Some suggestions, such as a patron being banned from one business also being banned from the other, are applicable to both businesses. Suggestions that would apply only to 618 Live were to change their minimum age to 23 and decrease capacity from the current 480 to 350. On October 9, 2014 it was agreed that capacity would be lowered to 400 and the minimum age would be changed to 23. The applicant was advised to contact the license division to update paperwork in order to reflect these changes.
- K. Alderman Bauman stated that it appears the items on the police report began soon after the previous license suspension ended.
- L. Attorney Gordon addressed each item on the police report:

Police Report Item #64 (March 14, 2014) - The individual who threw money in the air started the incident. The individual was not allowed access to the establishment. Mr. Manjee states he has facial recognition of the individual, but was not given a name from the police department.

Police Report Item #65 (April 20, 2014) - The applicant has the names and identification of the individuals involved. The incident was squelched by security personnel. Some individuals were cited with disorderly contact with the help of Mr. Manjee and Mr. Murado.

Police Report Item #66 (May 24, 2014) - The women involved have been identified. They will not be allowed back to the establishment.

Police Report Item #67 (May 31, 2014) - Security personnel have been vigilant. Fake IDs have been confiscated by staff so individuals can no longer gain access to any establishments illegally The altercation was taken care of by security and they have identified those individuals involved.

Police Report Item #68 (June 15, 2014) - The applicant provided video and photos to the police department. The individuals involved have been identified and banned.

Police Report Item #69 (August 2, 2014) - A concert was in the city that evening and word spread that the after party was at the establishment. However, the applicant maintained that there was no after party The individuals involved have been banned.

Police Report Item #70 (August 3, 2014) - The individual involved was not allowed entry. He has been identified so he cannot obtain entry in the future.

Police Report Item #71 (October 3, 2014) - The individuals involved were identified and not allowed entry.

Police Report Item #72 (October 4, 2014) - Security assisted the police department in apprehending the individuals involved.

Police Report Item #73 (October 8, 2014) - A meeting was set up with the police department The applicant agreed to reduce the establishment capacity and add an age restriction. They are working with cooperating with the police department.

M. Attorney Gordon states the business has won an award from the *Shepard Express* newspaper for the best night club in City of Milwaukee. They encountered problems in the past, but the issues have been overcome. The applicant and manager have cooperated with the police department. He pointed out that there are no neighborhood objectors this year compared to having several in past years.

Individuals appearing in support:

- N. Sami Ramone, 624 North Water Street, owns a nearby cafe and has not witnessed any problems. He states the applicant is a good neighbor.
- O. John Burke, owner of the 622 North Water Street building stated the applicant has worked hard to prevent problems. He states most problems on the street emanate from the Ultra Lounge.
- P. Homer Blow, Director of Blow Radio stated the applicant and his security have gone above and beyond the call at times. He stated they have worked for a solution instead of denying responsibility.
- Q. Tory Law, 2807 North 49th stated that in the last year he has seen Mr. Manjee and Mr. Murado contributing more to the community.

CONCLUSIONS OF LAW

1. The Committee has jurisdiction to hold hearings and provide Findings of Fact, Conclusions of Law and a Recommendation to the full Common Council pursuant to Chapter 125 of the Wisconsin Statutes and Chapters 90 and 108 of the Milwaukee Code of Ordinances.

- 2. Based upon the above facts found, the Committee finds that the Licensee, Habib Manjee has not met the criteria of Chapter 125, Wis. Stats. or Chapters 90 and 108 of the Milwaukee Code of Ordinances to allow renewal of the Class "B" Tavern and Public Entertainment Premises licenses for the premises located at 622 North Water Street in the City and County of Milwaukee, Wisconsin ("Ladybug Club/618 Live On Water") without undergoing a ten (10) day suspension of said licenses. The Committee finds the police report and testimony, as stated above, to be true.
- 3. The Committee recommends that the full Common Council of the City of Milwaukee exercise its judgment to renew the Class "B" Tavern and Public Entertainment Premises licenses for the licensed premises at 622 North Water Street in the City and County of Milwaukee, Wisconsin ("Ladybug Club/618 Live On Water") with a ten (10) day suspension of said licenses based upon items #64-73 of the police report.

RECOMMENDATION

Based upon the Findings of Fact and Conclusions of Law stated above, the Committee, by a vote of four (4) ayes and one (1) abstention, recommends that the Class "B" Tavern and Public Entertainment Premises Licenses of Habib Manjee, as agent for Lady Bug Club, LLC, for the premises located at 622 North Water Street in the City and County of Milwaukee, Wisconsin ("Ladybug Club/618 Live On Water") be renewed with a ten (10) day suspension.

Said suspension is to be in effect between 12:01 a.m., December 21, 2014 to 11:59 p.m., December 30, 2014.

Re: Report of the renewal application of Jalal Alqadi, agent for Alqadi Enterprises, LLC for a Secondhand Dealer license for the premises at 1951 West Capitol Drive ("Universal Wireless Plus").

- 1. Jalal Alqadi holds a Secondhand Dealer license for the premises at 1950 West Capitol Drive in the City and County of Milwaukee, Wisconsin ("Universal Wireless Plus"). Said license expires at midnight, December 31, 2014.
- 2. An application to renew said license was filed with the Office of the City Clerk on November 3, 2014.
- 3. Pursuant to Chapter 92 of the Milwaukee Code of Ordinances the matter was referred to the Milwaukee Police Department for investigation. The Milwaukee Police Department responded with a report dated November 5, 2014 which could form the basis for denial or suspension of this license.
- 4. On November 20, 2014 the City Clerk's Office provided notice to the Licensee, pursuant to Chapter 92 of the Milwaukee Code of Ordinances of the police report that could be the basis of non-renewal or suspension of this license as well as of the neighborhood objections that could form the basis for suspension or non-renewal of the license of the Licensee. The Licensee was provided a copy of the police report with the notice of hearing. The matter was scheduled for a hearing on the neighborhood objections on December 1, 2014 at 9:15 a.m. The licensee appeared and was not represented by counsel.
- 5. Based upon the sworn testimony heard and the evidence received at the hearing, the Committee finds the following:
 - A. On October 9, 2013 a black Apple I phone was taken during a strong-arm robbery at Rufus King High School. This phone was later recovered from Boost Mobile at 1951 West Capitol Drive. Several other used items were observed for sale inside the store. The applicant was cited for secondhand dealer license required and found guilty on this citation on February 21, 2014 and fined \$200.00.



- B. On May 15, 2014, a Milwaukee police officer met with the applicant at 1951 West Capitol Drive to discuss requirements pertaining to the applicant's secondhand dealer license at his location. It was discovered that the applicant was not reporting purchases of cell phones and computers to NEWPRS, was not holding items for 10 days, did not record the address of the seller, and that he purchased items from minors. The officer advised the applicant that these were violations of the ordinance. The officer then set up a NEWPRS account for the applicant and provided him with a copy of Milwaukee City Ordinance section 92, a NEWPRS manual and a NEWPRS sign as well as a business card. No citations were issued.
- C. Alderwoman Coggs stated that the last time he appeared before the committee they discussed the NEWPRS requirement and the matters previously considered on the police report as items 1 and 2. The applicant agreed to learn about NEWPRS regulations at the meeting.
- E. The applicant stated that prior to the latest police incident, he was not following all regulations. Since the May 15th police incident, he has been taking photos of IDs, holding items for 10 days, and meeting reporting requirements per NEWPRS regulations.

- 1. The Committee has jurisdiction to hold hearings and provided Findings of Fact and Conclusions of Law and a Recommendation to the full Common Council pursuant to Chapter 92 of the Milwaukee Code of Ordinances.
- 2. Based upon the above facts found, the Committee concludes that the Licensee, Jalal Alqadi has not met the criteria of Chapter 92 of the Milwaukee Code of Ordinances to allow renewal of the Secondhand Dealer license for the premises located at 1951 West Capitol Drive ("Universal Wireless Plus") without undergoing a ten (10) day suspension based on the police report and licensee testimony.
- 3. In order to protect the health, safety and welfare of the citizens of the City of Milwaukee, it is the recommendation of the Licenses Committee that the full Common Council of the City of Milwaukee should exercise its judgment to renew with a ten (10) day suspension the Secondhand Dealer license of Jalal Alqadi for the premises located at 1951 West Capitol Drive ("Universal Wireless Plus") in the City and County of Milwaukee, Wisconsin based on the police report and licensee testimony.

RECOMMENDATION

Based upon the Findings of Fact and Conclusions of Law stated above, the Committee by a vote of five (5) ayes and zero (0) noes recommends that the Secondhand Dealer license of Jalal Alqadi for the premises located at 1951 West Capitol Drive ("Universal Wireless Plus") in the City and County of Milwaukee, Wisconsin be renewed with a ten (10) day suspension based upon the police report and licensee testimony.

Said suspension is to be in effect from January 1, 2015 and for ten (10) days thereafter.

The matter was scheduled for a hearing on the police department report on December 1, 2014 at 1:00 p.m. in Room 301B of City Hall. At said date, time and place, the Licensee did not appear.

A notice of the hearing as well as a copy of the police report was sent to David Fre, 4221 South 6th Street #Lot EA, Milwaukee, WI 53221 on November 19, 2014 by U.S. prepaid first-class mail in an envelope bearing the return address of the License Division. The address of 4221 South 6th Street #Lot EA, Milwaukee, WI 53221 is the address given by the Licensee on his application. The envelope was not returned to the License Division by the United States Postal Service. The Licensee failed to appear at the hearing on December 1, 2014.



- 1. The Committee has jurisdiction to hold hearings and provide Findings of Fact, Conclusions of Law and a Recommendation to the full Common Council pursuant to Chapter 125 of the Wisconsin Statutes and Chapter 90 of the Milwaukee Code of Ordinances.
- 2. Based on the above facts found, the Committee concludes that the Licensee, David Fre has not met the criteria of Chapter 125 of the Wisconsin Statutes or Chapter 90 of the Milwaukee Code of Ordinances to allow renewal of the Class "D" Operator's license based upon nonappearance.


